A BILL FOR AN ACT

101 **CONCERNING FIFTH-DAY SCHOOL WEEK SUPPLEMENTAL ENRICHMENT**
102 **PROGRAMS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates the fifth-day academic enrichment and support grant program (program) to award grants on a 3-year cycle to one or more eligible community-based nonprofit organizations (organizations) to provide supplemental educational programs to full-day kindergarten through high school-aged children on the fifth day of the week for children in schools that have a 4-day school week.

To be eligible for a grant, organizations must, in part, have experience providing before- and after-school programs, serve a majority of children from low-income families, and have a relationship or partnership with a local school district that serves children in the program.

The state board of education (state board) awards program grants in a 3-year grant cycle, with an initial grant and automatic renewal of the grant for 2 years as set forth in the bill. The amount of the initial and renewal grants is determined by the state board based on the number of children served in the program and other criteria specified in the bill.

Grants must be used for one or more of the purposes specified in the bill, including to provide supplemental educational programming to support students' academic development on the fifth day of a 4-day school week, to provide meals for students attending the program, and to acquire educational materials and necessary technology to provide supplemental educational programming.

The state board shall promulgate rules to establish the program, including the application process and deadlines.

Grantees are required to report annually to the department of education (department) on the use of the grant money, with the department reporting to certain committees of the general assembly.

The bill creates a fund from which to pay program grants, consisting of money appropriated or transferred to the fund by the general assembly.

6 **22-104-101. Short title.** THE SHORT TITLE OF THIS ARTICLE 104 IS
7 THE "FIFTH-DAY ACADEMIC ENRICHMENT AND SUPPORT GRANT
8 PROGRAM ACT".

9 **22-104-102. Legislative declaration.** (1) THE GENERAL
10 ASSEMBLY FINDS THAT:

11 (a) COLORADO HAS MORE SCHOOLS ON A FOUR-DAY SCHOOL WEEK
12 THAN ANY OTHER STATE IN THE COUNTRY;

1 (b) ONE HUNDRED ELEVEN OF COLORADO'S ONE HUNDRED
2 SEVENTY-EIGHT SCHOOL DISTRICTS ARE ON A FOUR-DAY SCHOOL WEEK,
3 REPRESENTING MORE THAN EIGHTY THOUSAND CHILDREN;

4 (c) MANY SCHOOL DISTRICTS MADE THE DECISION TO MOVE TO A
5 FOUR-DAY SCHOOL WEEK TO ADDRESS BUDGET CONCERNS AND RECOGNIZE
6 THE NEED FOR ADDITIONAL STATE SUPPORT AND INVESTMENT IN
7 KINDERGARTEN-THROUGH-TWELFTH-GRADE FUNDING IN ORDER TO MOVE
8 TOWARD A RETURN TO A FIVE-DAY SCHOOL WEEK;

9 (d) HOWEVER, THERE IS LITTLE RESEARCH ON THE BENEFITS OR
10 COSTS OF A FOUR-DAY SCHOOL WEEK TO CHILDREN AND LEARNING;

11 (e) FREQUENTLY, WITHOUT SUPPLEMENTAL ENRICHMENT
12 PROGRAMMING AND WHILE AT HOME WITHOUT PARENTS OFTEN FOR MORE
13 THAN TEN HOURS AT A TIME, MANY CHILDREN ARE TASKED WITH TAKING
14 CARE OF SIBLINGS AND MANY GO WITHOUT WELL-BALANCED MEALS OR
15 SNACKS DURING THAT TIME; ■

16 (f) FURTHER, LOW-INCOME PARENTS AND PARENTS WHO DO NOT
17 HAVE A FLEXIBLE WORK SCHEDULE OR TIME OFF FROM WORK SPEND TIME
18 IN THE WORKDAY WORRYING ABOUT CHILDREN AT HOME, WITH LITTLE
19 ABILITY TO PROVIDE OR PAY FOR SUPERVISION WHEN CHILDREN ARE NOT
20 IN SCHOOL DURING THE WORKWEEK; AND

21 (g) WHILE SCHOOL DISTRICTS ARE OPERATING ON A FOUR-DAY
22 SCHOOL WEEK, SUPPLEMENTAL ENRICHMENT PROGRAMMING AND RELATED
23 ENRICHMENT ACTIVITIES CAN HELP PROVIDE STUDENTS WITH THE
24 SUPPORTS THEY NEED.

25 (2) THEREFORE, THE GENERAL ASSEMBLY DECLARES THAT
26 SUPPORTING COMMUNITY-BASED NONPROFIT ORGANIZATIONS AND
27 ELIGIBLE RURAL SCHOOL DISTRICTS IN PROVIDING SUPPLEMENTAL

1 ENRICHMENT PROGRAMMING THROUGH FIFTH-DAY ACADEMIC
2 ENRICHMENT AND SUPPORT PROGRAMS WILL HELP ENSURE THAT
3 DECLINES IN LEARNING ARE MINIMIZED AND THAT CHILDREN ARE IN A
4 SAFE, SUPPORTIVE, AND ACADEMICALLY ENRICHING ENVIRONMENT WHEN
5 NOT AT SCHOOL ON THE FIFTH DAY OF A FOUR-DAY SCHOOL WEEK.

3 **22-104-104. Fifth-day academic enrichment and support grant**
4 **program - created - use of grants - rules.** (1) THERE IS CREATED IN THE
5 DEPARTMENT THE FIFTH-DAY ACADEMIC ENRICHMENT AND SUPPORT
6 GRANT PROGRAM TO PROVIDE GRANTS TO ELIGIBLE COMMUNITY-BASED
7 NONPROFIT ORGANIZATIONS AND ELIGIBLE RURAL SCHOOL DISTRICTS TO
8 PROVIDE SUPPLEMENTAL ENRICHMENT PROGRAMMING AND RELATED
9 ENRICHMENT ACTIVITIES AND SERVICES TO CHILDREN IN PRESCHOOL

10 (3) THE DEPARTMENT SHALL IMPLEMENT AND ADMINISTER THE
11 GRANT PROGRAM; EXCEPT THAT THE DEPARTMENT SHALL NOT IMPLEMENT
12 OR ADMINISTER THE GRANT PROGRAM UNLESS THE GENERAL ASSEMBLY
13 APPROPRIATES SUFFICIENT MONEY TO THE FUND FOR SUCH PURPOSES.

14 SUBJECT TO AVAILABLE APPROPRIATIONS, █ THE STATE BOARD SHALL

21 THREE-YEAR GRANT CYCLE IN THE ORDER QUALIFYING APPLICATIONS
22 ARE RECEIVED. THE STATE BOARD SHALL DETERMINE THE AMOUNT OF THE
23 GRANTS. THE AMOUNT OF THE INITIAL AND RENEWAL GRANTS IS BASED ON
24 THE NUMBER OF CHILDREN SERVED IN THE FIFTH-DAY ACADEMIC
25 ENRICHMENT AND SUPPORT PROGRAM; EXCEPT THAT THE GRANT AWARD

22 **22-104-106. Reporting requirements.** (1) ON OR BEFORE
23 FEBRUARY 15 IN EACH FISCAL YEAR IN WHICH A GRANT IS AWARDED OR
24 RENEWED, EACH ELIGIBLE COMMUNITY-BASED ORGANIZATION AND
25 ELIGIBLE RURAL SCHOOL DISTRICT THAT RECEIVES A GRANT THROUGH THE
26 GRANT PROGRAM SHALL SUBMIT A REPORT TO THE DEPARTMENT. AT A
27 MINIMUM, THE REPORT MUST INCLUDE THE FOLLOWING INFORMATION, IF

1 **APPLICABLE:**

2 (a) THE NUMBER OF CHILDREN SERVED IN THE FIFTH-DAY
3 ACADEMIC ENRICHMENT AND SUPPORT PROGRAM DURING THE YEAR AND

7 ORGANIZATION'S RELATIONSHIP OR PARTNERSHIP WITH A LOCAL SCHOOL
8 DISTRICT THAT OPERATES ON A FOUR-DAY SCHOOL WEEK AND THAT IS THE
9 SCHOOL DISTRICT OF CHILDREN PARTICIPATING IN THE ACADEMIC
10 ENRICHMENT AND SUPPORT PROGRAM;

11 (c) A DESCRIPTION OF THE FIFTH-DAY ACADEMIC ENRICHMENT AND

18 **PROVIDED TO THE DEPARTMENT BY GRANT RECIPIENTS TO THE EDUCATION**
19 **COMMITTEES OF THE SENATE AND THE HOUSE OF REPRESENTATIVES, OR**

1 **program fund.** (1) THERE IS CREATED IN THE STATE TREASURY THE
2 FIFTH-DAY ACADEMIC ENRICHMENT AND SUPPORT GRANT PROGRAM FUND.
3 THE FUND CONSISTS OF MONEY THAT THE GENERAL ASSEMBLY MAY
4 APPROPRIATE OR TRANSFER TO THE FUND.

5 (2) THE STATE TREASURER SHALL CREDIT ALL INTEREST AND
6 INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE
7 FUND TO THE FUND.

8 (3) THE GENERAL ASSEMBLY SHALL ANNUALLY APPROPRIATE
9 MONEY FROM THE FIFTH-DAY ACADEMIC ENRICHMENT AND SUPPORT
10 GRANT PROGRAM FUND TO THE DEPARTMENT TO IMPLEMENT THE GRANT
11 PROGRAM. SUBJECT TO AVAILABLE APPROPRIATIONS, THE DEPARTMENT
12 SHALL EXPEND MONEY FROM THE FUND FOR THE AWARD OR RENEWAL OF
13 GRANTS PURSUANT TO THIS ARTICLE 104. THE DEPARTMENT MAY USE UP
14 TO FIVE PERCENT OF THE MONEY ANNUALLY APPROPRIATED FOR THE
15 PROGRAM TO PAY THE REASONABLE AND NECESSARY DIRECT AND
16 INDIRECT COSTS THE DEPARTMENT INCURS TO ADMINISTER THE GRANT
17 PROGRAM.

18 **SECTION 2. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, or safety.
