**A BILL FOR AN ACT**

101 **CONCERNING THE POSSESSION OF CERTAIN PERSONAL INFORMATION**  
102 **BY GOVERNMENTAL ENTITIES.**

**Bill Summary**

The bill requires a governmental entity that maintains, owns, or licenses computerized data that includes certain personal information about any Colorado residents, or a governmental entity that uses a third-party service provider to maintain computerized data that includes certain personal information, to give notice to those Colorado residents every 90 days.

The notice must give Colorado residents the option to either assent to the governmental entity possessing the Colorado resident's personal information or request that the governmental entity dispose of any paper or electronic documents containing the Colorado resident's personal identifying information.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 24-37.5-118 as  
3 follows:

4 **24-37.5-118. Study of personally identifiable information -**  
5 **authority of chief information officer - report to joint technology**  
6 **committee - definitions - repeal.** (1) THE CHIEF INFORMATION OFFICER  
7 SHALL CONVENE AN ADVISORY GROUP      TO STUDY WHERE PERSONALLY  
8 IDENTIFIABLE INFORMATION IS STORED BY STATE AGENCIES THROUGHOUT  
9 COLORADO, TO STUDY ENTITIES THAT HAVE ACCESS TO PERSONALLY  
10 IDENTIFIABLE INFORMATION STORED BY STATE AGENCIES, AND TO  
11 DETERMINE THE COSTS AND PROCESSES NECESSARY TO CENTRALIZE THE  
12 STORAGE AND PROTECTION OF PERSONALLY IDENTIFIABLE INFORMATION.

13 (2) THE ADVISORY GROUP CONSISTS OF:

14 (a) THE MEMBERS OF THE GOVERNMENT DATA ADVISORY BOARD  
15 CREATED IN SECTION 24-37.5-703;

16 (b) ONE MEMBER WHO REPRESENTS THE ATTORNEY GENERAL'S  
17 OFFICE, APPOINTED BY THE ATTORNEY GENERAL; AND

18 (c) ANY NUMBER OF MEMBERS WHO ARE PERSONALLY  
19 IDENTIFIABLE INFORMATION EXPERTS SELECTED AND APPOINTED BY THE  
20 CHIEF INFORMATION OFFICER.

21 (3) ON OR BEFORE JANUARY 1, 2023, THE ADVISORY GROUP SHALL  
22 COMPLETE ITS WORK AND PRESENT TO THE JOINT TECHNOLOGY  
23 COMMITTEE A SUMMARY OF THE ADVISORY GROUP'S FINDINGS, INCLUDING,

1 IF APPROPRIATE, PROPOSALS FOR LEGISLATION.

2 (4) AS USED IN THIS SECTION:

3 (a) "PERSONALLY IDENTIFIABLE INFORMATION" MEANS  
4 INFORMATION THAT MAY BE USED, ALONG OR IN CONJUNCTION WITH ANY  
5 OTHER INFORMATION, TO IDENTIFY A SPECIFIC INDIVIDUAL, INCLUDING BUT  
6 NOT LIMITED TO A NAME; A DATE OF BIRTH; A PLACE OF BIRTH; A SOCIAL  
7 SECURITY NUMBER OR TAX IDENTIFICATION NUMBER; A PASSWORD OR  
8 PASS CODE; AN OFFICIAL GOVERNMENT-ISSUED DRIVER'S LICENSE OR  
9 IDENTIFICATION CARD NUMBER; INFORMATION CONTAINED IN AN  
10 EMPLOYMENT AUTHORIZATION DOCUMENT; INFORMATION CONTAINED IN  
11 A PERMANENT RESIDENT CARD; VEHICLE REGISTRATION INFORMATION; A  
12 LICENSE PLATE NUMBER; A PHOTOGRAPH, ELECTRONICALLY STORED  
13 PHOTOGRAPH, OR DIGITIZED IMAGE; A FINGERPRINT; A RECORD OF A  
14 PHYSICAL FEATURE, A PHYSICAL CHARACTERISTIC, A BEHAVIORAL  
15 CHARACTERISTIC, OR HANDWRITING; A GOVERNMENT PASSPORT NUMBER;  
16 A HEALTH INSURANCE IDENTIFICATION NUMBER; AN EMPLOYER, STUDENT,  
17 OR MILITARY IDENTIFICATION NUMBER; A FINANCIAL TRANSACTION  
18 DEVICE; A SCHOOL OR EDUCATIONAL INSTITUTION ATTENDED; A SOURCE  
19 OF INCOME; MEDICAL INFORMATION; BIOMETRIC DATA; FINANCIAL AND  
20 TAX RECORDS; HOME OR WORK ADDRESSES OR OTHER CONTACT  
21 INFORMATION; FAMILY OR EMERGENCY CONTACT INFORMATION; STATUS  
22 AS A RECIPIENT OF PUBLIC ASSISTANCE OR AS A CRIME VICTIM; RACE;  
23 ETHNICITY; NATIONAL ORIGIN; IMMIGRATION OR CITIZENSHIP STATUS;  
24 SEXUAL ORIENTATION; GENDER IDENTITY; PHYSICAL DISABILITY;  
25 INTELLECTUAL AND DEVELOPMENTAL DISABILITY; OR RELIGION.

26 (b) "STATE AGENCY" MEANS ANY DEPARTMENT, COMMISSION,  
27 COUNCIL, BOARD, BUREAU, COMMITTEE, INSTITUTION OF HIGHER

1 EDUCATION, AGENCY, OR OTHER GOVERNMENTAL UNIT OF THE EXECUTIVE,  
2 JUDICIAL, OR LEGISLATIVE BRANCH OF STATE GOVERNMENT.

3 (5) THIS SECTION IS REPEALED, EFFECTIVE JANUARY 1, 2024.

4 **SECTION 2. Act subject to petition - effective date.** This act  
5 takes effect at 12:01 a.m. on the day following the expiration of the  
6 ninety-day period after final adjournment of the general assembly; except  
7 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
8 of the state constitution against this act or an item, section, or part of this  
9 act within such period, then the act, item, section, or part will not take  
10 effect unless approved by the people at the general election to be held in  
11 November 2022 and, in such case, will take effect on the date of the  
12 official declaration of the vote thereon by the governor.
