Bill Summary

Capital Development Committee. The bill requires the state treasurer to transfer to the capital construction fund any excess proceeds



from the issuance of a lease-purchase agreement under Senate Bill 20-219 that are initially credited to the emergency controlled maintenance account.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 SECTION 1. In Colorado Revised Statutes, 24-75-302, amend 3 (3.2) as follows: 4 24-75-302. Capital construction fund - capital assessment fees 5 - calculation - information technology capital account. (3.2) (a) There 6 is hereby created a special account within the capital construction fund 7 established pursuant to subsection (1) of this section to be known as the 8 emergency controlled maintenance account. The account consists of any 9 moneys MONEY appropriated to the account by the general assembly OR 10 TRANSFERRED OR CREDITED TO THE ACCOUNT. The moneys MONEY in the 11 account are IS subject to annual appropriation and may be used only to 12 fund any unplanned and immediate controlled maintenance needs 13 pursuant to section 24-30-1303.9 (5). All moneys MONEY unexpended or 14 unencumbered in any fiscal year must remain in the account. 15 (b) ON THE EFFECTIVE DATE OF THIS SUBSECTION (3.2)(b), THE 16 STATE TREASURER SHALL TRANSFER TO THE CAPITAL CONSTRUCTION FUND 17 CREATED IN SUBSECTION (1)(a) OF THIS SECTION ANY EXCESS PROCEEDS 18 FROM THE ISSUANCE OF A LEASE-PURCHASE AGREEMENT UNDER SENATE 19 BILL 20-219 THAT ARE INITIALLY CREDITED TO THE EMERGENCY 20 CONTROLLED MAINTENANCE ACCOUNT. THE TRANSFERRED MONEY IS

21 SUBSEQUENTLY AVAILABLE FOR APPROPRIATION FOR CAPITAL
22 CONSTRUCTION, CAPITAL RENEWAL, OR CONTROLLED MAINTENANCE
23 PROJECTS, BUT MUST BE SPENT NO LATER THAN MARCH 1, 2024.
24 UNEXPENDED APPROPRIATIONS DO NOT REVERT TO THE GENERAL FUND

AND MUST BE SPENT FOR CAPITAL CONSTRUCTION, CAPITAL RENEWAL, OR
 CONTROLLED MAINTENANCE PROJECTS NO LATER THAN MARCH 1, 2024.
 SECTION 2. Safety clause. The general assembly hereby finds,
 determines, and declares that this act is necessary for the immediate
 preservation of the public peace, health, or safety.
