# An Act

CONCERNING ALCOHOL BEVERAGES PURCHASED FOR THE PURPOSE OF A SPECIAL EVENT HELD AT A CLUB LICENSED TO SELL ALCOHOL BEVERAGES BY THE DRINK TO CLUB MEMBERS FOR CONSUMPTION ON THE CLUB PREMISES.

*Be it enacted by the General Assembly of the State of Colorado:*

**SECTION 1.** In Colorado Revised Statutes, **add** 44-5-109 as follows:

**44-5-109. Alcohol beverages obtained for a special event - authority of club licensee to commingle with inventory.** IF A PERSON LICENSED UNDER SECTION 44-3-418 PURCHASES ALCOHOL BEVERAGES FROM A WHOLESALER FOR PURPOSES OF A SPECIAL EVENT HELD ON THE LICENSEE'S

PREMISES, THE LICENSEE IS NOT REQUIRED TO STORE THE ALCOHOL BEVERAGES PURCHASED FOR THE SPECIAL EVENT SEPARATELY FROM THE LICENSEE'S INVENTORY.

**SECTION 2. Act subject to petition - effective date - applicability.** (1) This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly; except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in November 2022 and, in such case, will take effect on the date of the official declaration of the vote thereon by the governor.

(2) This act applies to special event permits issued on or after the applicable effective date of this act.
