A BILL FOR AN ACT

101 **CONCERNING THE CREATION OF AN OPTIONAL DISCOUNTED PARKS AND**
102 **PUBLIC LANDS ACCESS PASS THAT IS PURCHASED AT THE TIME A**
103 **MOTOR VEHICLE IS REGISTERED, AND, IN CONNECTION**
104 **THEREWITH, USING THE PASS FEES TO FINANCE A NUMBER OF**
105 **GOALS OF THE DIVISION OF PARKS AND WILDLIFE RELATED TO**
106 **INCREASED CONSERVATION OF, SAFETY AT, AND ACCESS TO**
107 **STATE PARKS AND PUBLIC LANDS; AND MAKING AN**
108 **APPROPRIATION.**

Bill Summary

Section 1 of the bill creates the keep Colorado wild pass (wild pass) for entry into state parks and other participating public lands. Commencing no earlier than January 1, 2023, but no later than January 1, 2024, each resident with one of the following motor vehicles that is not a commercial vehicle is assessed a fee for the wild pass (wild pass fee) when registering the motor vehicle:

- A passenger motor vehicle;
- A light-weight truck with an empty vehicle weight of less than or equal to 16,000 pounds;
- A motorcycle; or
- A recreational vehicle.

A resident may decline to pay the wild pass fee when registering the resident's motor vehicle, and nonpayment of the wild pass fee does not affect the resident's ability to register the motor vehicle.

The parks and wildlife commission in the department of natural resources (commission) is required to adopt rules to set the wild pass fee and, for income-eligible households, a reduced wild pass fee and may establish a process for applying existing discounts or free entry to persons eligible for the discount or free entry to the wild pass. The commission may also adopt rules establishing a separate fee for a pass, including a separate fee for passes for nonresidents, residents who decline to pay the wild pass fee when registering the resident's motor vehicle, and residents who do not possess one of the motor vehicles listed above.

For each state fiscal year, the division of parks and wildlife in the department of natural resources (division) will use the wild pass fees collected to achieve stated goals such as providing affordable access to state parks and public lands; managing state parks; supporting search and rescue and avalanche safety efforts; conserving vulnerable species and habitats; funding equity, diversity, and inclusion programs; and financing regional outdoor partnerships for community-driven planning and projects.

The division is required to:

- Develop language to notify motor vehicle registrants of their option to decline to pay the wild pass fee, which notice must be conspicuously placed on registration documents and on the division's and the division of motor vehicle's websites; and
- Implement a public outreach campaign to educate the public about the availability of the wild pass through the motor vehicle registration process and about access to state parks and public lands that the wild pass will provide.

Section 2 requires, on or before March 1, 2025, and on or before March 1, 2030, the division to make a presentation regarding its most

recent annual written report on the number of wild passes sold in the previous 12 months, an accounting of the expenditures made with the increased revenue generated from sales of the wild pass, and a summary of the effect that those increased expenditures have had on the achievement of the stated goals to a joint session of the legislative committees with jurisdiction over agriculture matters. The division is required to send the annual reports to the legislative committees with jurisdiction over natural resources and to make the reports available to the public.

Section 3 repeals limitations on the amount that the commission may increase fees for daily and annual park passes purchased by individuals who do not purchase the discounted wild pass.

Section 4 authorizes the division to enter into cooperative agreements with other land management agencies and requires the division to develop a program for seeking, accepting, and expending gifts, grants, or donations.

Section 5 establishes that a person's decision to decline to pay for the wild pass fee does not affect the person's ability to register a motor vehicle.

Sections 6 through 8 make technical changes.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, **add** 33-12-108 as follows:

33-12-108. Keep Colorado wild pass - assess with vehicle registration - option to decline to pay - rules - short title - legislative declaration - definitions. (1) **Short title.** THE SHORT TITLE OF THIS SECTION IS THE "KEEP COLORADO WILD PASS ACT".

(2) **Legislative declaration.** THE GENERAL ASSEMBLY:

(a) FINDS AND DETERMINES THAT:

(I) COLORADO'S GREAT OUTDOORS AND WILDLIFE ARE AMONG THE STATE'S MOST TREASURED RESOURCES, ENHANCING COLORADANS' QUALITY OF LIFE, BRINGING PROSPERITY TO THE STATE AND ITS RESIDENTS, AND REPRESENTING THE FABRIC OF THE STATE;

(II) RAPID GROWTH IN DEMAND FOR, AND EFFECTS OF, OUTDOOR

1 RECREATION IS CHALLENGING THE DIVISION'S CAPACITY TO DELIVER ON ITS
2 MISSION TO ENSURE THAT THE BENEFITS OF COLORADO'S OUTDOORS AND
3 WILDLIFE ARE SUSTAINED FOR FUTURE GENERATIONS, WHILE
4 RECREATIONISTS HAVE FEW OPPORTUNITIES TO FINANCIALLY SUPPORT
5 WILDLIFE CONSERVATION AND THE TRAILS AND OTHER OUTDOOR
6 RECREATIONAL INFRASTRUCTURE THAT ARE IN HIGH DEMAND IN
7 COLORADO;

8 (III) DESPITE GROWTH IN OUTDOOR RECREATION, MANY
9 COLORADO FAMILIES LACK ACCESS TO THE EXPERIENCE, EQUIPMENT, AND
10 RESOURCES NECESSARY TO VISIT OUR STATE PARKS AND PUBLIC LANDS
11 AND NEW STRATEGIES ARE NEEDED TO REDUCE BARRIERS FOR THOSE
12 FAMILIES WITH LIMITED RESOURCES TO ACCESS THE OUTDOORS;

13 (IV) THE DIVISION AND THE COMMISSION HAVE IDENTIFIED GOALS
14 AND OBJECTIVES TO ACHIEVE THEIR MISSION, INCLUDING THE FOLLOWING
15 GOALS AND OBJECTIVES:

16 (A) PROVIDING A SIMPLE AND AFFORDABLE STATE PARKS AND
17 PUBLIC LANDS ACCESS PASS TO ENSURE THAT COLORADO'S OUTDOORS ARE
18 WELCOMING AND ACCESSIBLE TO ALL AND THAT ALL USERS CONTRIBUTE
19 TO KEEPING COLORADO WILD;

20 (B) ENSURING SUFFICIENT STAFFING AND RESOURCES TO MANAGE
21 AND PROTECT COLORADO'S FORTY-TWO EXISTING STATE PARKS;

22 (C) SUPPORTING THE THOUSANDS OF SEARCH AND RESCUE
23 VOLUNTEERS IN COLORADO THAT RISK THEIR LIVES RESPONDING TO
24 BACKCOUNTRY EMERGENCIES AND DEVELOPING EDUCATIONAL PROGRAMS
25 AND CAMPAIGNS TO PROMOTE BACKCOUNTRY SAFETY;

26 (D) PROTECTING WINTER RECREATIONISTS BY SUPPORTING
27 BACKCOUNTRY AVALANCHE SAFETY AND AWARENESS;

1 (E) BUILDING AND MAINTAINING NEW STATE PARKS ON A REGULAR
2 BASIS IN PARTNERSHIP WITH LOCAL GOVERNMENTS, CONSERVATIONISTS,
3 RECREATIONISTS, AND OTHER LAND MANAGEMENT AGENCIES;

4 (F) GROWING THE DIVISION'S CAPACITY TO ADDRESS OUTDOOR
5 RECREATION BEYOND STATE PARKS, INCLUDING ON FEDERAL LANDS;

6 (G) INCREASING STATE TRAILS PROGRAM FUNDS FOR TRAIL
7 STEWARDSHIP, NEW TRAILS, AND RIVER RECREATION PROJECTS;

8 (H) DEDICATING RESOURCES FOR THE DIVISION'S STATE WILDLIFE
9 ACTION PLAN TO CONSERVE VULNERABLE SPECIES AND HABITATS;

10 (I) SUPPORTING THE DIVISION'S INITIATIVES THAT ARE FOCUSED ON
11 EQUITY, DIVERSITY, AND INCLUSION IN THE OUTDOORS; AND

12 (J) FUNDING COLORADO REGIONAL OUTDOOR PARTNERSHIPS TO
13 SUPPORT COMMUNITY-DRIVEN CONSERVATION AND RECREATION
14 PLANNING AND PROJECTS; AND

15 (V) THE GOALS AND OBJECTIVES IDENTIFIED IN SUBSECTION
16 (2)(a)(IV) OF THIS SECTION CAN ONLY BE ACCOMPLISHED THROUGH
17 IMPLEMENTATION OF A FEE STRUCTURE THAT INCREASES PARTICIPATION;
18 PROVIDES CONSISTENT, RELIABLE FINANCIAL CONTRIBUTIONS; AND IS
19 OFFERED AT A DISCOUNTED PRICE FROM THE PRICE OF AN EXISTING
20 ANNUAL STATE PARK PASS; AND

21 (b) DECLARES THAT:

22 (I) THE PASS FEE IS NOT INTENDED AS A REGISTRATION FEE OR
23 OTHER CHARGE WITH RESPECT TO THE OPERATION OF ANY MOTOR VEHICLE
24 UPON ANY PUBLIC HIGHWAY IN THE STATE;

25 (II) THE COLLECTION OF THE PASS FEE WITH AN ANNUAL MOTOR
26 VEHICLE REGISTRATION IS INTENDED TO CREATE AN ADMINISTRATIVE
27 CONVENIENCE; AND

1 (III) AN INDIVIDUAL'S CHOICE NOT TO PAY THE PASS FEE IS NOT
2 INTENDED TO AFFECT THE INDIVIDUAL'S ABILITY TO REGISTER THE
3 INDIVIDUAL'S MOTOR VEHICLE.

4 (3) **Definitions.** AS USED IN THIS SECTION, UNLESS THE CONTEXT
5 OTHERWISE REQUIRES:

6 (a) "AUTHORIZED AGENT" HAS THE MEANING SET FORTH IN
7 SECTION 42-1-102 (5).

8 (b) "COMMERCIAL VEHICLE" HAS THE MEANING SET FORTH IN
9 SECTION 42-1-102 (17.5).

10 (c) "DIVISION OF MOTOR VEHICLES" MEANS THE DIVISION OF
11 MOTOR VEHICLES IN THE DEPARTMENT OF REVENUE.

12 (d) "KEEP COLORADO WILD PASS" OR "PASS" MEANS THE KEEP
13 COLORADO WILD PASS CREATED IN SUBSECTION (4)(a) OF THIS SECTION.

14 (e) "LIGHT-WEIGHT TRUCK" MEANS A TRUCK WITH A DECLARED
15 EMPTY VEHICLE WEIGHT OF LESS THAN OR EQUAL TO SIXTEEN THOUSAND
16 POUNDS.

17 (f) "MOTORCYCLE" HAS THE MEANING SET FORTH IN SECTION
18 42-1-102 (55).

19 (g) "MOTOR VEHICLE" HAS THE MEANING SET FORTH IN SECTION
20 42-1-102 (58).

21 (h) "PARKS AND OUTDOOR RECREATION CASH FUND" MEANS THE
22 PARKS AND OUTDOOR RECREATION CASH FUND CREATED IN SECTION
23 33-10-111 (1).

24 (i) (I) "PASS FEE" MEANS THE ANNUAL PASS FEE OR FEES THAT THE
25 COMMISSION, BY RULE, SETS PURSUANT TO SUBSECTION (5)(a)(I)(A) OF
26 THIS SECTION.

27 (II) "PASS FEE" INCLUDES THE REDUCED PASS FEE OR FEES THAT

1 THE COMMISSION, BY RULE, SETS PURSUANT TO SUBSECTION (5)(a)(I)(B)
2 OF THIS SECTION.

3 (j) "RECREATIONAL VEHICLE" HAS THE SAME MEANING AS
4 "NONCOMMERCIAL OR RECREATIONAL VEHICLE" AS SET FORTH IN SECTION
5 42-1-102 (61).

6 (k) "REGISTRATION" REFERS TO THE REGISTRATION OF A VEHICLE
7 WITH THE DEPARTMENT OF REVENUE, AS REQUIRED BY SECTION 42-3-103.

8 (l) "TRUCK" HAS THE MEANING SET FORTH IN SECTION 42-1-102
9 (108).

10 (m) "WILDLIFE CASH FUND" MEANS THE WILDLIFE CASH FUND
11 CREATED IN SECTION 33-1-112 (1)(a).

12 (4) (a) THE DIVISION SHALL DEVELOP A KEEP COLORADO WILD
13 PASS AS AN ANNUAL STATE PARKS AND PUBLIC LANDS PASS FOR A MOTOR
14 VEHICLE AND THAT PROVIDES ACCESS TO ANY COLORADO STATE PARK OR
15 OTHER PARTICIPATING PUBLIC LANDS.

16 (b) COMMENCING NO EARLIER THAN JANUARY 1, 2023, BUT NO
17 LATER THAN JANUARY 1, 2024, A KEEP COLORADO WILD PASS FEE SHALL
18 BE ASSESSED AT THE TIME OF REGISTERING A MOTOR VEHICLE THAT:

19 (I) IS NOT A COMMERCIAL VEHICLE; AND

20 (II) IS A PASSENGER MOTOR VEHICLE, LIGHT-WEIGHT TRUCK,
21 MOTORCYCLE, OR RECREATIONAL VEHICLE.

22 (c) (I) A PERSON REGISTERING A TYPE OF MOTOR VEHICLE LISTED
23 IN SUBSECTION (4)(b)(II) OF THIS SECTION WHO HAS BEEN ASSESSED THE
24 PASS FEE MAY DECLINE TO PURCHASE THE PASS AND NOT PAY THE FEE
25 WHEN MAKING PAYMENT DURING THE MOTOR VEHICLE REGISTRATION
26 PROCESS. NONPAYMENT OF THE PASS FEE DOES NOT AFFECT A PERSON'S
27 ABILITY TO REGISTER THE MOTOR VEHICLE.

1 (II) IF A PERSON DECLINES TO PAY THE PASS FEE OR OTHERWISE
2 FAILS TO PAY THE PASS FEE, THE PERSON MAY OBTAIN A STATE PARKS PASS
3 FROM THE DIVISION OR, PURSUANT TO SECTION 33-12-104, FROM A PASS
4 AND REGISTRATION AGENT TO ENTER A STATE PARK.

5 (d) (I) THE PASS FEE SHALL BE ASSESSED WHEN ONE OF THE MOTOR
6 VEHICLES LISTED IN SUBSECTION (4)(b)(II) OF THIS SECTION IS REGISTERED
7 AS REQUIRED BY ARTICLE 3 OF TITLE 42. EACH AUTHORIZED AGENT SHALL
8 REMIT TO THE DEPARTMENT OF REVENUE NO LESS FREQUENTLY THAN
9 ONCE A MONTH ALL PASS FEES COLLECTED BY THE AUTHORIZED AGENT.
10 THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF REVENUE SHALL
11 TRANSMIT ALL PASS FEES REMITTED BY AUTHORIZED AGENTS PLUS ANY
12 PASS FEES COLLECTED DIRECTLY BY THE DEPARTMENT OF REVENUE, MINUS
13 THE DIRECT AND INDIRECT COSTS FOR THE COLLECTION AND
14 TRANSMISSION OF THE PASS FEE AS INCURRED BY THE DEPARTMENT OF
15 REVENUE AND ITS AUTHORIZED AGENTS AND AS ANNUALLY APPROPRIATED
16 BY THE GENERAL ASSEMBLY, TO THE STATE TREASURER NO LESS
17 FREQUENTLY THAN ONCE A MONTH, AND THE STATE TREASURER SHALL
18 CREDIT THE FEES TO THE SPECIFIED FUNDS IN ACCORDANCE WITH
19 SUBSECTION (4)(e) OF THIS SECTION.

20 (II) ANY MONEY THAT THE DEPARTMENT OF REVENUE RECEIVES
21 AND TRANSMITS TO THE STATE TREASURER PURSUANT TO SUBSECTION
22 (4)(d)(I) OF THIS SECTION AND THE STATE TREASURER CREDITS TO THE
23 PARKS AND OUTDOOR RECREATION CASH FUND, THE WILDLIFE CASH FUND,
24 OR THE SEARCH AND RESCUE FUND PURSUANT TO SUBSECTIONS
25 (4)(e)(I)(A), (4)(e)(II), AND (4)(e)(I)(B) OF THIS SECTION:

26 (A) IS COLLECTED FOR THE DIVISION, WHICH IS AN ENTERPRISE
27 PURSUANT TO SECTION 33-9-105;

1 (B) IS CUSTODIAL MONEY INTENDED FOR THE DIVISION AND HELD

11 PURSUANT TO SUBSECTION (4)(d) OF THIS SECTION IN EACH STATE FISCAL
12 YEAR AS FOLLOWS:

13 (I) THE FIRST THIRTY-SIX MILLION DOLLARS SHALL BE ALLOCATED
14 AS FOLLOWS:

15 (A) THIRTY-TWO MILLION FIVE HUNDRED THOUSAND DOLLARS TO
16 THE PARKS AND OUTDOOR RECREATION CASH FUND FOR STATE PARKS
17 MAINTENANCE IN FURTHERANCE OF THE GOALS SET FORTH IN SUBSECTIONS
18 (2)(a)(IV)(A) AND (2)(a)(IV)(B) OF THIS SECTION;

19 (B) TWO MILLION FIVE HUNDRED THOUSAND DOLLARS TO THE
20 SEARCH AND RESCUE FUND CREATED IN SECTION 33-1-112.5 (1) IN
21 FURTHERANCE OF THE GOAL SET FORTH IN SUBSECTION (2)(a)(IV)(C) OF
22 THIS SECTION; AND

23 (C) ONE MILLION DOLLARS TO THE COLORADO AVALANCHE
24 INFORMATION CENTER FUND CREATED IN SECTION 24-33-116 (2)(c) IN
25 FURTHERANCE OF THE GOAL SET FORTH IN SUBSECTION (2)(a)(IV)(D) OF
26 THIS SECTION; AND

27 (II) AFTER MAKING THE ALLOCATIONS UNDER SUBSECTION

1 (4)(e)(I) OF THIS SECTION, THE STATE TREASURER SHALL CREDIT ONE-HALF
2 OF ANY REMAINING MONEY TO THE WILDLIFE CASH FUND AND ONE-HALF
3 OF ANY REMAINING MONEY TO THE PARKS AND OUTDOOR RECREATION
4 CASH FUND IN FURTHERANCE OF THE GOALS SET FORTH IN SUBSECTIONS
5 (2)(a)(IV)(E) TO (2)(a)(IV)(J) OF THIS SECTION.

6 (f) ON AN ANNUAL BASIS AFTER THE FIRST YEAR IN WHICH THE
7 PASS IS OFFERED, THE COMMISSION SHALL DETERMINE AND INFORM THE
8 STATE TREASURER OF AN INCREASED ALLOCATION OF THE MONEY
9 COLLECTED FROM THE PASS FEE TO BE CREDITED PURSUANT TO
10 SUBSECTION (4)(e) OF THIS SECTION TO THE FOLLOWING FUNDS TO
11 REFLECT AN ADJUSTMENT BASED ON A CHANGE TO THE UNITED STATES

14 CONSUMERS, OR ITS SUCCESSOR INDEX:

2 (B) ESTABLISHING A REDUCED PASS FEE FOR INCOME-ELIGIBLE
3 HOUSEHOLDS IN CONSULTATION WITH ORGANIZATIONS THAT REPRESENT
4 HOUSEHOLDS AND COMMUNITIES WITH LIMITED RESOURCES AND
5 DEVELOPING A PROCESS FOR DEMONSTRATING INCOME ELIGIBILITY TO THE
6 DIVISION; AND

7 (C) ESTABLISHING A PROCESS TO ALLOW A PERSON WHO ENTERS
8 A STATE PARK OR OTHER PARTICIPATING PUBLIC LAND BY MEANS OTHER
9 THAN BY A MOTOR VEHICLE TO DEMONSTRATE THAT THE PERSON IS A PASS
10 HOLDER.

11 (II) THE PASS FEE AND REDUCED PASS FEE AND INSTRUCTIONS ON

11 **SECTION 9. Appropriation.** (1) For the 2021-22 state fiscal
12 year, \$502,646 is appropriated to the department of natural resources for
13 use by the division of parks and wildlife. This appropriation is from the
14 parks and outdoor recreation cash fund created in section 33-10-111 (1),
15 C.R.S. To implement this act, the division may use this appropriation for
16 state park operations, which amount is based on an assumption that the
17 division will require an additional 2.4 FTE.

18 (2) For the 2021-22 state fiscal year, \$106,200 is appropriated to
19 the department of revenue for use by the division of motor vehicles. This
20 appropriation is from reappropriated funds received from the department
21 of natural resources under subsection (1) of this section. To implement
22 this act, the division may use this appropriation for DRIVES maintenance
23 and support.

24 **SECTION 10.** **Act subject to petition - effective date -**
25 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
26 the expiration of the ninety-day period after final adjournment of the
27 general assembly; except that, if a referendum petition is filed pursuant

1 to section 1 (3) of article V of the state constitution against this act or an
2 item, section, or part of this act within the ninety-day period after final
3 adjournment of the general assembly, then the act, item, section, or part
4 will not take effect unless approved by the people at the general election
5 to be held in November 2022 and, in such case, will take effect on the
6 date of the official declaration of the vote thereon by the governor.
