Current Appropriations Clause in Bill

The bill includes an appropriation clause that provides \$8,266,779 General Fund and 0.9 FTE to the Office of Early Childhood in the Department of Human Services for FY 2021-22. Of this appropriation, \$6,888,983 is reappropriated to the Department of Education for the proportion of Part C Early Intervention activities conducted by Administrative Units.

Points to Consider

General Fund Impact

The Joint Budget Committee (JBC) has proposed a budget package for FY 2021-22 based on the March 2021 Legislative Council Staff revenue forecast. The JBC has included as part of its FY 2021-22 budget package \$8,266,779 General Fund to be appropriated for implementation of this bill.
