**A BILL FOR AN ACT**

101      **CONCERNING THE INCREASE OF AVAILABLE FUNDS FOR LAW**  
102                    **ENFORCEMENT AGENCY PEACE OFFICER SUPPORTIVE SERVICES,**  
103                    **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

The bill requires the department of law (department) to implement a pilot grant program (grant program) to support a law enforcement agency to retain and recruit qualified and trained P.O.S.T.-certified peace officers. The department may award grants to help fund retention programs, recruitment purposes, and to provide financial resources for

law enforcement academy training, academy trainees, and continuing education opportunities. For the 2022-23 state fiscal year, \$5 million is appropriated from the general fund to the P.O.S.T. board cash fund to be spent in accordance with the purpose of the grant program and requires that no more than 2% of the appropriated funds be used for administrative purposes.

The bill establishes a P.O.S.T. board committee to review grant applications and advise the department on the grant program. The bill grants the attorney general the power to administer the requirements of the grant program. The grant program is repealed effective July 1, 2024.

Under current law, there is a peace officer behavioral health support and community partnership grant program (program). The program specifies the purposes that grants can be used for. The bill adds to the program purposes services that support peace officers involved in job-related traumatic situations. Additionally, for state fiscal year 2022-23, the bill appropriates \$5 million from the general fund to the peace officers behavioral health support and community partnership fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 finds and declares that:

4 (a) According to the centers for disease control and prevention,  
5 peace officers are fifty-four percent more likely to commit suicide, with  
6 suicide being the second leading cause of death among peace officers  
7 following COVID-19;

8 (b) The Invisible Wounds Project found that one in four peace  
9 officers suffers from post-traumatic stress disorder;

10 (c) Good mental and psychological health is essential for peace  
11 officers to effectively keep Colorado and local communities safe from  
12 crime and violence;

13 (d) Improving mental health resiliency can also help peace  
14 officers prepare for, recover from, and adapt to stress and adversity;

15 (e) The experiences of peace officers and public safety mental  
16 health professionals, along with scientific research, show that providing

1 peace officers with mental health support services following traumatic  
2 incidents promotes positive outcomes;

3 (f) Allowing law enforcement agencies to hire full-time  
4 behavioral health professionals can aid in addressing confidentiality  
5 concerns, improve cultural competencies, and help law enforcement  
6 agencies systematically identify and refer peace officers to mental health  
7 services;

8 (g) Increased availability to behavioral health services will  
9 increase peace officers' empathy toward those experiencing mental health  
10 crises and provide the tools and awareness peace officers need to improve  
11 how they handle difficult situations;

12 (h) Improved access to behavioral health support services through  
13 peer support programs and other programs reduces barriers peace officers  
14 may have toward behavioral health support services and will increase  
15 their cultural competency in behavioral health support practices;

16 (i) Cross-training peace officers in behavioral health and  
17 providing student loan repayment options for current and former certified  
18 peace officers to receive this training can increase empathy; and

19 (j) While behavioral health training is essential for peace officers,  
20 there is no training or experience that can fully prepare them for the types  
21 of calls and situational challenges they face on a daily basis. Investing in  
22 tools and programs to help peace officers manage the stressors that  
23 accompany their work can have a positive impact on peace officers'  
24 mental health, as well as on community outcomes.

25 (2) Therefore, the general assembly declares that investing in  
26 additional mental and behavioral health funding and training for peace  
27 officers will improve interactions between peace officers and members

1 of the community, have positive public safety outcomes, and help peace  
2 officers recover from on-the-job trauma in order to handle the daily  
3 stressors of their job.

5           **SECTION 2.** In Colorado Revised Statutes, 24-32-3501, **amend**  
6 (2)(e), (2)(f), (4), and (7)(a); and add (2)(g) and (9) as follows:

7           **24-32-3501. Peace officers behavioral health support and**  
8 **community partnerships grant program - created - report - rules -**  
9 **fund - definitions - repeal.** (2) Grant recipients may use money received  
10 through the grant program for the following purposes:

11           (e) Training and education programs that teach peace officers and  
12 their immediate family members the symptoms of job-related mental  
13 trauma and how to prevent and treat such trauma; **and**

14           (f) Peer support programs for peace officers; **AND**

15           (g) **HIRING, CONTRACTING, OR DEVELOPING A REMOTE NETWORK**  
16 **TO PROVIDE BEHAVIORAL HEALTH COUNSELING, THERAPY, OR OTHER**  
17 **RELATED SUPPORT SERVICES TO PEACE OFFICERS INVOLVED IN**  
18 **JOB-RELATED TRAUMATIC SITUATIONS.**

19           (4) The department shall administer the grant program and,  
20 subject to available appropriations, shall award grants as provided in this  
21 section from the fund created in subsection (7) of this section. THE  
22 DEPARTMENT SHALL TRANSFER THE AWARDED GRANT MONEY TO A GRANT  
23 RECIPIENT AS SOON AS PRACTICABLE AFTER THE GRANT RECIPIENT'S  
24 GRANT APPLICATION IS APPROVED.

25           (7) (a) The peace officers behavioral health support and  
26 community partnership fund, referred to in this section as the "fund", is  
27 created in the state treasury. The fund consists of gifts, grants, and

1 donations credited to the fund pursuant to subsection (7)(b) of this section  
2 and any other money that the general assembly may appropriate or  
3 transfer to the fund. Subject to annual appropriation by the general  
4 assembly, the department may expend money from the fund for the  
5 purposes of this section. ANY UNEXPENDED AND UNENCUMBERED MONEY  
6 FROM AN APPROPRIATION MADE FOR THE PURPOSES OF THIS SECTION  
7 REMAINS AVAILABLE FOR EXPENDITURE BY THE DEPARTMENT FOR THE  
8 NEXT TWO FISCAL YEARS WITHOUT FURTHER APPROPRIATION. The  
9 department may use up to five SEVEN percent of the money annually  
10 appropriated to the fund to pay the direct and indirect costs that the  
11 department incurs in administering the grant program.

12 (9) IN ADDITION TO ANY OTHER MONEY APPROPRIATED OR  
13 TRANSFERRED TO THE FUND, FOR STATE FISCAL YEAR 2022-23, THE  
14 GENERAL ASSEMBLY SHALL APPROPRIATE THREE MILLION DOLLARS FROM  
15 THE GENERAL FUND TO THE FUND. THE MONEY APPROPRIATED PURSUANT  
16 TO THIS SECTION MUST BE USED FOR PURPOSES DESCRIBED IN SUBSECTIONS  
17 (2)(c) TO (2)(g) OF THIS SECTION. THIS SUBSECTION (9) IS REPEALED,  
18 EFFECTIVE JULY 1, 2026.

19 **SECTION 3. Appropriation.** (1) For the 2022-23 state fiscal  
20 year, \$3,000,000 is appropriated to the peace officers behavioral health  
21 support and community partnership fund created in section 24-32-3501  
22 (7)(a), C.R.S. This appropriation is from the general fund. The  
23 department of local affairs is responsible for the accounting related to this  
24 appropriation.

25 (2) For the 2022-23 fiscal year, \$3,000,000 is appropriated to the  
26 department of local affairs. This appropriation is from reappropriated  
27 funds in the peace officers behavioral health and community partnership

1 fund pursuant to subsection (1) of this section and is based on the  
2 assumption that the department will require an additional 2.5 FTE. To  
3 implement this act, the department may use the appropriation for the  
4 peace officers mental health support grant program.

5 **SECTION 4. Safety clause.** The general assembly hereby finds,  
6 determines, and declares that this act is necessary for the immediate  
7 preservation of the public peace, health, or safety.
