Bill Summary

The bill adds to the board of directors of the urban drainage and flood control district one director from Douglas county to be appointed by the governor as with existing director appointments representing various counties.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 32-11-204, **amend**  
3 (5)(a) as follows:

4           **32-11-204. Regular appointments.** (5) (a) A director shall be  
5 appointed to the board by the governor from each of the counties of  
6 Arapahoe, DOUGLAS, and Jefferson after the second Tuesday in January  
7 in each odd-numbered year and by the twentieth day of January in such  
8 year. A director shall be appointed to the board by the governor from each  
9 of the counties of Adams and Boulder during such part of January in each  
10 even-numbered year.

11           **SECTION 2. Act subject to petition - effective date.** This act  
12 takes effect at 12:01 a.m. on the day following the expiration of the  
13 ninety-day period after final adjournment of the general assembly; except  
14 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
15 of the state constitution against this act or an item, section, or part of this  
16 act within such period, then the act, item, section, or part will not take  
17 effect unless approved by the people at the general election to be held in  
18 November 2022 and, in such case, will take effect on the date of the  
19 official declaration of the vote thereon by the governor.
