A BILL FOR AN ACT

101 **CONCERNING MEDICAID REIMBURSEMENT FOR THERAPY USING EQUINE**
102 **MOVEMENT.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Subject to federal authorization and federal financial participation, on or after January 1, 2023, medicaid reimbursement is available for therapy using equine movement when provided by a physical therapist, an occupational therapist, or a speech-language pathologist.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds that:

4 (a) Therapy using equine movement, often referred to as
5 hippotherapy, is regarded as standard practice for occupational therapists,
6 physical therapists, and speech-language pathologists and is used to
7 engage sensory, neuromotor, and cognitive systems to promote functional
8 treatment outcomes. Therapy practitioners use equine movement as a tool
9 integrated with the use of other standard therapy tools, equipment, and
10 activities during a treatment session.

11 (b) Since the 1980s, the American Occupational Therapy
12 Association, the American Physical Therapy Association, and the
13 American Speech-Language-Hearing Association have recognized that
14 the use of equine movement is included in each respective scope of
15 practice and is an effective therapy tool that can be utilized in patient
16 treatment plans;

17 (c) Currently, there are 102 peer review journal articles, 12 peer
18 review case studies, and 13 meta-analyses that support the value of using
19 equine movement as a treatment tool to improve function within a therapy
20 plan of care for patients with cerebral palsy, multiple sclerosis, Down
21 syndrome, postural instability, spinal cord injury, traumatic brain injury,
22 language-learning disability, and stroke; and

23 (d) Across the United States, there are at least 37 states that
24 provide medicaid reimbursement for the use of equine movement as a
25 treatment tool. These states recognize that it is within the role of the
26 treating professional to select the appropriate treatment tools and
27 activities to meet each client's needs.

1 (2) Therefore, the general assembly declares that occupational
2 therapists, physical therapists, and speech-language pathologists should
3 not be penalized and denied medicaid reimbursement for therapy services
4 using equine movement as part of their respective practices.

5 **SECTION 2.** In Colorado Revised Statutes, **add** 25.5-5-332 as
6 follows:

7 **25.5-5-332. Therapy using equine movement - federal**
8 **authorization - definition.** (1) SUBJECT TO FEDERAL AUTHORIZATION
9 AND FEDERAL FINANCIAL PARTICIPATION, ON OR AFTER **JULY 1, 2024,**
10 THERAPY USING EQUINE MOVEMENT MAY BE PROVIDED BY A PHYSICAL
11 THERAPIST LICENSED PURSUANT TO ARTICLE 285 OF TITLE 12, AN
12 OCCUPATIONAL THERAPIST LICENSED PURSUANT TO ARTICLE 270 OF TITLE
13 12, OR A SPEECH-LANGUAGE PATHOLOGIST CERTIFIED PURSUANT TO
14 ARTICLE 305 OF TITLE 12.

15 (2) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
16 REQUIRES, "THERAPY USING EQUINE MOVEMENT" MEANS THERAPEUTIC
17 ACTIVITIES THAT LEVERAGE HORSE-HUMAN INTERACTIONS TO FACILITATE
18 PROGRESSION TOWARD MEETING THERAPEUTIC GOALS.

19 **SECTION 3. Safety clause.** The general assembly hereby finds,
20 determines, and declares that this act is necessary for the immediate
21 preservation of the public peace, health, or safety.
