A BILL FOR AN ACT

101 CONCERNING THE CREATION OF A PIKES PEAK INTERNATIONAL HILL
102 CLIMB SPECIAL LICENSE PLATE.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)

The bill creates the Pikes Peak international hill climb special license plate. In addition to the standard motor vehicle fees, the plate requires 2 one-time fees of \$25. One of the fees is credited to the highway users tax fund and the other to the licensing services cash fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 42-3-261 as
3 follows:

4 **42-3-261. Special plates - Pikes Peak international hill climb.**

5 (1) BEGINNING ON THE EARLIER OF JANUARY 1, 2023, OR WHEN THE
6 DEPARTMENT IS ABLE TO ISSUE THE PLATES, THE DEPARTMENT SHALL
7 ISSUE SPECIAL LICENSE PLATES TO QUALIFIED APPLICANTS IN ACCORDANCE
8 WITH THIS SECTION FOR MOTORCYCLES, PASSENGER CARS, TRUCKS, OR
9 NONCOMMERCIAL OR RECREATIONAL MOTOR VEHICLES THAT DO NOT
10 EXCEED SIXTEEN THOUSAND POUNDS EMPTY WEIGHT.

11 (2) (a) THERE IS HEREBY ESTABLISHED THE PIKES PEAK
12 INTERNATIONAL HILL CLIMB LICENSE PLATE.

13 (b) PIKES PEAK INTERNATIONAL HILL CLIMB, REGISTERED AS A
14 NONPROFIT ORGANIZATION UNDER 26 U.S.C. SEC. 501 (c)(3), MAY DESIGN
15 THE SPECIAL LICENSE PLATE, BUT THE DESIGN MUST CONFORM TO
16 STANDARDS ESTABLISHED BY THE DEPARTMENT AND BE APPROVED BY THE
17 DEPARTMENT.

18 (3) A PERSON MAY APPLY FOR A PIKES PEAK INTERNATIONAL HILL
19 CLIMB SPECIAL LICENSE PLATE IF THE PERSON PAYS THE TAXES AND FEES
20 REQUIRED BY THIS SECTION.

21 (4) THE AMOUNT OF THE TAXES AND FEES FOR SPECIAL LICENSE
22 PLATES UNDER THIS SECTION IS THE SAME AS THE AMOUNT OF THE TAXES
23 AND FEES FOR REGULAR MOTOR VEHICLE LICENSE PLATES; EXCEPT THAT
24 THE DEPARTMENT SHALL COLLECT AN ADDITIONAL ONE-TIME FEE OF
25 TWENTY-FIVE DOLLARS FOR ISSUANCE OR REPLACEMENT OF THE LICENSE
26 PLATE. THE DEPARTMENT SHALL TRANSMIT THE ADDITIONAL ONE-TIME
27 FEE TO THE STATE TREASURER, WHO SHALL CREDIT THE FEE TO THE

1 HIGHWAY USERS TAX FUND CREATED IN SECTION 43-4-201.

2 (5) AN APPLICANT MAY APPLY FOR PERSONALIZED PIKES PEAK
3 INTERNATIONAL HILL CLIMB LICENSE PLATES. UPON PAYMENT OF THE
4 ADDITIONAL FEE REQUIRED BY SECTION 42-3-211 (6)(a) FOR
5 PERSONALIZED LICENSE PLATES, THE DEPARTMENT MAY ISSUE THE PLATES
6 IF THE APPLICANT COMPLIES WITH SECTION 42-3-211. IF AN APPLICANT
7 HAS EXISTING PERSONALIZED LICENSE PLATES FOR A MOTOR VEHICLE, THE
8 APPLICANT MAY TRANSFER THE COMBINATION OF LETTERS OR NUMBERS
9 TO A NEW SET OF PIKES PEAK INTERNATIONAL HILL CLIMB LICENSE PLATES
10 FOR THE VEHICLE UPON PAYING THE FEE REQUIRED BY SECTION 42-3-211
11 (6)(a) AND UPON TURNING IN THE EXISTING PLATES TO THE DEPARTMENT.
12 A PERSON WHO HAS OBTAINED PERSONALIZED LICENSE PLATES UNDER
13 THIS SUBSECTION (5) MUST PAY THE ANNUAL FEE IMPOSED BY SECTION
14 42-3-211 (6)(b) TO RENEW THE PERSONALIZED PLATES. THE FEES UNDER
15 THIS SUBSECTION (5) ARE IN ADDITION TO ALL OTHER APPLICABLE TAXES
16 AND FEES.

17 **SECTION 2.** In Colorado Revised Statutes, **amend** 42-3-312 as
18 follows:

19 **42-3-312. Special license plate surcharge.** In addition to any
20 other fee imposed by this article 3, an applicant for a special license plate
21 created by rule in accordance with section 42-3-207, as the section existed
22 when the plate was created, or special license plates issued pursuant to
23 sections 42-3-211 to 42-3-214, sections 42-3-217 to 42-3-218, sections
24 42-3-221 to 42-3-234, sections 42-3-237 to 42-3-258, and ~~section~~
25 ~~42-3-260~~ SECTIONS 42-3-260 AND 42-3-261 shall pay an issuance fee of
26 twenty-five dollars; except that the fee is not imposed on special license
27 plates exempted from additional fees for the issuance of a military special

1 license plate by section 42-3-213 (1)(b)(II). The department shall transfer
2 the fee to the state treasurer, who shall credit it to the licensing services
3 cash fund created in section 42-2-114.5.

4 **SECTION 3. Safety clause.** The general assembly hereby finds,
5 determines, and declares that this act is necessary for the immediate
6 preservation of the public peace, health, or safety.
