**Human Services Committee.** The bill implements the recommendation of the department of regulatory agencies' sunset review and report concerning the strategic action planning group on aging by repealing the planning group.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-32-3407, **amend**  
3 **(2)** as follows:

4 **24-32-3407. Strategic action plan on aging cash fund.** (2) The  
5 state treasurer may invest any moneys MONEY in the fund not expended  
6 for the purpose of this part 34 as provided by law. The state treasurer  
7 shall credit all interest and income derived from the investment and  
8 deposit of moneys MONEY in the fund to the fund. Any unexpended and  
9 unencumbered moneys MONEY remaining in the fund at the end of a fiscal  
10 year remain in the fund and shall not be credited or transferred to the  
11 general fund or another fund AS OF JUNE 30, 2022, SHALL BE  
12 TRANSFERRED TO THE OLDER COLORADANS CASH FUND, CREATED IN  
13 SECTION 26-11-205.5 (5). MONEY TRANSFERRED TO THE OLDER  
14 COLORADANS CASH FUND PURSUANT TO THIS SUBSECTION (2) MAY BE  
15 USED BY THE DEPARTMENT OF HUMAN SERVICES FOR THE COLORADO  
16 COMMISSION ON AGING TO IMPLEMENT THE RECOMMENDATIONS MADE BY  
17 THE STRATEGIC ACTION PLANNING GROUP ON AGING, AS THAT GROUP  
18 EXISTED PRIOR TO JULY 1, 2022.

19 **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
20 **(13)(a)(II)** as follows:

21 **2-3-1203. Sunset review of advisory committees - legislative**  
22 **declaration - definition - repeal.** (13) (a) The following statutory  
23 authorizations for the designated advisory committees are scheduled for

1 repeal on September 1, 2022:

2 (II) The strategic action planning group on aging created in  
3 section 24-32-3404, C.R.S.:

4 SECTION 3. In Colorado Revised Statutes, 26-11-101, amend  
5 as amended by House Bill 22-1035 (1)(a) introductory portion as  
6 follows:

7 26-11-101. Commission on aging - created - definition.

8 (1) (a) There is created in the state department the Colorado commission  
9 on aging, referred to in this article 11 as the "commission", for the  
10 purpose of coordinating and guiding the implementation of the strategic  
11 action plan on aging, developed pursuant to section 24-32-3406, AS THAT  
12 SECTION EXISTED PRIOR TO JUNE 30, 2022, and other strategies the  
13 commission may identify that support older Coloradans. The commission  
14 shall consist of nineteen members who must be appointed as follows:

15 SECTION 4. In Colorado Revised Statutes, 26-11-102, amend  
16 as amended by House Bill 22-1035 (2)(a) introductory portion as  
17 follows:

18 26-11-102. Organization of commission. (2) (a) The

19 commission may establish standing subcommittees to support the  
20 implementation of the strategic action plan on aging, developed pursuant  
21 to section 24-32-3406, AS THAT SECTION EXISTED PRIOR TO JUNE 30, 2022,  
22 and work related to the lifelong Colorado initiative established in part 3  
23 of this article 11. The subcommittee topics may include, but are not  
24 limited to:

25 SECTION 5. In Colorado Revised Statutes, 26-11-105, amend  
26 as amended by House Bill 22-1035 (1)(b) and (1)(g) as follows:

27 26-11-105. Duties of commission - report. (1) The commission,

1 through its executive committee described in section 26-11-102 (1); in  
2 coordination with the state department liaison to the commission,  
3 appointed pursuant to section 26-11-104; and in coordination with  
4 independent staff, contracted pursuant to section 26-11-104, shall carry  
5 out the following duties:

6 (b) Coordinate and implement the strategic action plan on aging  
7 recommendations, developed pursuant to section 24-32-3406, AS THAT  
8 SECTION EXISTED PRIOR TO JUNE 30, 2022, and additional  
9 recommendations the commission makes;

10 (g) Review existing policies and programs across state agencies,  
11 and on or before September 1, 2023, and on or before September 1 each  
12 year thereafter, draft an annual report of issues and recommendations  
13 developed by the commission that support the implementation of  
14 strategies in alignment with the strategic action plan on aging developed  
15 pursuant to section 24-32-3406, AS THAT SECTION EXISTED PRIOR TO JUNE  
16 30, 2022, the lifelong Colorado initiative created pursuant to section  
17 26-11-302, and other recommendations that the commission makes. The  
18 commission shall submit the annual report to the governor, executive  
19 directors of impacted agencies, and the general assembly.

20 **SECTION 6.** In Colorado Revised Statutes, 26-11-203, amend  
21 as amended by House Bill 22-1035 (1)(k) and (1)(l) as follows:

22 **26-11-203. Duties of the state office.** (1) In addition to such  
23 other duties and functions as the executive director may allocate to the  
24 state office, the state office shall have the following duties and functions:

25 (k) To convene and coordinate a technical advisory committee  
26 comprised of key state department representatives, including but not  
27 limited to the department of human services, department of labor and

1 employment, department of higher education, department of health care  
2 policy and financing, department of transportation, department of public  
3 health and environment, and department of local affairs, to direct the  
4 implementation of recommendations and strategies provided in the  
5 strategic action plan on aging developed pursuant to section 24-32-3406,  
6 AS THAT SECTION EXISTED PRIOR TO JUNE 30, 2022, and recommendations  
7 the commission makes as set forth in section 26-11-105; and

8 (1) To coordinate with the technical advisory committee and  
9 commission to develop, maintain, and make publicly available on the  
10 state department's website a collection of available data sets; metrics  
11 specific to the implementation of strategies in alignment with the strategic  
12 action plan on aging developed pursuant to section 24-32-3406, AS THAT  
13 SECTION EXISTED PRIOR TO JUNE 30, 2022, and the lifelong Colorado  
14 initiative created pursuant to section 26-11-302; and other  
15 recommendations that the commission makes as set forth in section  
16 26-11-105.

17 **SECTION 7.** In Colorado Revised Statutes, 26-11-301, **amend**  
18 **as added by House Bill 22-1035** (4) as follows:

19 **26-11-301. Definitions.** As used in this part 3, unless the context  
20 otherwise requires:

21 (4) "Strategic action plan on aging" means the strategic action  
22 plan on aging developed pursuant to section 24-32-3406, AS THAT  
23 SECTION EXISTED PRIOR TO JUNE 30, 2022.

24 **SECTION 8. Effective date.** (1) Except as other otherwise  
25 provided in subsection (2) of this section, this act takes effect upon  
26 passage.

27 (2) Sections (2), (3), (4), (5), (6), and (7) of this act take effect

1 only if House Bill 22-1035 becomes law, in which case sections (2), (3),  
2 (4), (5), (6), and (7) take effect upon the effective date of this act or the  
3 effective date of House Bill 22-1035, whichever is later.

4 **SECTION 9. Safety clause.** The general assembly hereby finds,  
5 determines, and declares that this act is necessary for the immediate  
6 preservation of the public peace, health, or safety.
