A BILL FOR AN ACT

101 **CONCERNING A STATEWIDE COMMUNICATION SYSTEM FOR REFERRAL**
102 **TO ESSENTIAL SERVICES, AND, IN CONNECTION THEREWITH,**
103 **REQUIRING GENERAL FUND APPROPRIATIONS TO BE MADE TO**
104 **THE DEPARTMENT OF HUMAN SERVICES FOR THE ISSUANCE OF**
105 **ANNUAL GRANTS TO HELP FUND THE SYSTEM AND MAKING AN**
106 **APPROPRIATION.**

requires the general assembly to annually appropriate \$2 million from the general fund to the department of human services (department) for the issuance of annual grants to the Colorado 2-1-1 collaborative. For the 2021-22 fiscal year, the bill requires the general assembly to appropriate \$3 million from the general fund to the department for the issuance of a grant to the Colorado 2-1-1 collaborative for technological upgrades.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 hereby finds and declares that:

4 (a) The Colorado 2-1-1 collaborative is a safe and trusted service
5 that receives more than one hundred thousand requests for help each year
6 and connects individuals to over seven thousand essential resources and
7 services in their own communities;

8 (b) 2-1-1 is an easy to remember number that allows trained
9 professionals to provide confidential, multilingual support by guiding
10 people to services and solutions available by phone, text, live chat, e-mail,
11 or in-person in some communities;

12 (c) The Colorado 2-1-1 collaborative has the largest, most
13 up-to-date, centralized database of health and human services resources
14 in the rocky mountain region, including child care, access to food, legal
15 services, medical services, rental assistance, and utility support;

16 (d) When the Marshall fire affected communities at the close of
17 2021, Colorado 2-1-1 collaborative staff mobilized quickly to add
18 fire-specific resources to the Colorado 2-1-1 collaborative database and
19 have been supporting individuals and families with immediate needs,
20 including housing options, long-term housing planning, transportation,
21 mental health counseling, and food access; and

22 (e) With additional funding, the Colorado 2-1-1 collaborative can

1 expand its hours of operation, offer statewide chat and text services, allow
2 onsite or walk-in navigation at multiple locations, and promote the
3 Colorado 2-1-1 collaborative through a public awareness campaign.

4 **SECTION 2.** In Colorado Revised Statutes, 29-11-203, **add** (4),
5 (5), and (6) as follows:

6 **29-11-203. Human services referral service - immunity - grant**
7 **- report - repeal.** (4) (a) FOR THE 2021-22 FISCAL YEAR AND EACH
8 FISCAL YEAR THEREAFTER, THE GENERAL ASSEMBLY SHALL ANNUALLY
9 APPROPRIATE **ONE** MILLION DOLLARS FROM THE GENERAL FUND TO THE
10 DEPARTMENT FOR THE ISSUANCE OF ANNUAL GRANTS TO THE COLORADO
11 2-1-1 COLLABORATIVE FOR OPERATIONAL EXPENSES INCLUDING, BUT NOT
12 LIMITED TO:

13 (I) IMPLEMENTING A QUALITY CONTROL PROGRAM TO ENSURE A
14 HIGH LEVEL OF CALLER SATISFACTION;

15 (II) IMPLEMENTING DATA COLLECTION QUALITY CONTROL TO
16 ENSURE A HIGH LEVEL OF ACCURACY IN COLLECTING CALLER
17 INFORMATION AND IDENTIFYING CALLER NEEDS;

18 (III) PROVIDING SERVICES IN OVER THREE HUNDRED LANGUAGES;

19 (IV) RESEARCHING AND CURATING THE COLORADO 2-1-1
20 COLLABORATIVE DATABASE OF COMMUNITY-BASED ORGANIZATION
21 RESOURCES; AND

22 (V) DISPATCHING AND SCHEDULING RIDE SHARE RIDES FOR
23 CALLERS IN NEED OF TRANSPORTATION.

25 (b) ANY MONEY APPROPRIATED TO THE DEPARTMENT FOR A FISCAL
26 YEAR PURSUANT TO THIS SUBSECTION (4) THAT IS NOT EXPENDED BEFORE
27 THE FISCAL YEAR ENDS IS FURTHER APPROPRIATED TO THE DEPARTMENT

1 FOR THE SUBSEQUENT FISCAL YEAR FOR THE SAME PURPOSE.

2 (5) TO QUALIFY FOR THE GRANTS AWARDED BY THE DEPARTMENT
3 PURSUANT TO SUBSECTION (4) OF THIS SECTION, THE COLORADO 2-1-1
4 COLLABORATIVE MUST SERVE AS A STATEWIDE COMMUNICATION SYSTEM,
5 HOST MULTIPLE CALL CENTERS ACROSS THE STATE, AND PROVIDE
6 REFERRALS TO ONE OR MORE OF THE FOLLOWING:

- 7 (a) HOUSING, INCLUDING SHELTERS AND TRANSITIONAL SERVICES;
- 8 (b) RENT AND UTILITY ASSISTANCE SERVICES;
- 9 (c) INCOME SUPPORT AND ASSISTANCE SERVICES;
- 10 (d) CHILDCARE SERVICES;
- 11 (e) FOOD SERVICES;
- 12 (f) INDIVIDUAL, FAMILY, AND COMMUNITY SUPPORT SERVICES;
- 13 (g) TRANSPORTATION SERVICES;
- 14 (h) CLOTHING, PERSONAL, AND HOUSEHOLD NEEDS SERVICES;
- 15 (i) HEALTH-CARE SERVICES;
- 16 (j) MENTAL HEALTH AND SUBSTANCE USE DISORDERS SERVICES;
- 17 (k) EMPLOYMENT SERVICES;
- 18 (l) EDUCATION SERVICES;
- 19 (m) MEDICAL CLINICS SERVICES;
- 20 (n) DENTAL CLINICS SERVICES;
- 21 (o) OTHER GOVERNMENT AND ECONOMIC SERVICES; AND
- 22 (p) DISASTER SERVICES.

23 (6) ON OR BEFORE DECEMBER 31, 2022, AND ON OR BEFORE
24 DECEMBER 31 OF EACH YEAR THEREAFTER, AND NOTWITHSTANDING THE
25 REQUIREMENT IN SECTION 24-1-136 (11)(a)(I), FOR AS LONG AS ANNUAL
26 GRANTS ARE MADE PURSUANT TO SUBSECTION (4)(a) OF THIS SECTION, THE
27 DEPARTMENT SHALL SUBMIT A SUMMARIZED REPORT TO THE HEALTH AND

1 HUMAN SERVICES COMMITTEE OF THE SENATE AND THE PUBLIC AND
2 BEHAVIORAL HEALTH AND HUMAN SERVICES COMMITTEE OF THE HOUSE OF
3 REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES, ON THE GRANTS
4 ISSUED PURSUANT TO THIS SECTION.

5 **SECTION 3. Appropriation.** For the 2021-22 state fiscal year,
6 \$1,000,000 is appropriated to the department of human services for use
7 by administration and finance. This appropriation is from the general
8 fund. To implement this act, administration and finance may use this
9 appropriation for grants for operational expenses related to the Colorado
10 2-1-1 collaborative. Any money appropriated in this section not expended
11 prior to July 1, 2022, is further appropriated to administration and finance
12 for the 2022-23 state fiscal year for the same purpose.

13 **SECTION 4. Appropriation.** (1) For the 2022-23 state fiscal
14 year, \$1,055,645 is appropriated to the department of human services for
15 use by administration and finance. This appropriation is from the general
16 fund. Any money appropriated in this section not expended prior to July
17 1, 2023, is further appropriated to administration and finance for the
18 2023-24 state fiscal year for the same purpose. To implement this act,
19 administration and finance may use this appropriation as follows:

20 (a) \$55,645 for the Colorado 2-1-1 collaborative, which amount
21 is based on an assumption that the department will require an additional
22 0.9 FTE; and

23 (b) \$1,000,000 for grants for operational expenses related to the
24 Colorado 2-1-1 collaborative.

25 **SECTION 5. Safety clause.** The general assembly hereby finds,
26 determines, and declares that this act is necessary for the immediate
27 preservation of the public peace, health, or safety.
