A BILL FOR AN ACT

101 **CONCERNING MEASURES TO INCREASE PROTECTIONS FROM**
102 **PERFLUOROALKYL AND POLYFLUOROALKYL CHEMICALS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Section 1 of the bill enacts the "Perfluoroalkyl and Polyfluoroalkyl Chemicals Consumer Protection Act" to establish a regulatory scheme that collects information from product manufacturers regarding the use of perfluoroalkyl and polyfluoroalkyl chemicals (PFAS chemicals) in their products and phases out the sale or distribution of products that contain intentionally added PFAS chemicals. **Section 1** requires

manufacturers of products that are sold or distributed in the state and that contain intentionally added PFAS chemicals to provide written notification (notification) to the executive director (executive director) of the Colorado department of public health and environment (department) that provides:

- The trade name of the product;
- A description of the purpose that PFAS chemicals serve in the product;
- Contact information for the manufacturer; and
- Any additional information required by the executive director.

For manufacturers that were already selling or distributing a product containing intentionally added PFAS chemicals in the state before January 1, 2025, the notification must be made no later than 30 days before January 1, 2025. For manufacturers that begin to sell or distribute a product containing intentionally added PFAS chemicals in the state on or after January 1, 2025, the notification must be made at least 30 days after the manufacturer begins selling or distributing the product in the state.

No later than 30 days after the executive director receives a notification, the executive director shall publish the trade name of the product and manufacturer name on the department's website. A manufacturer submitting the notification to the executive director must pay a fee established by the executive director. The fee will be credited to the perfluoroalkyl and polyfluoroalkyl substances cash fund (fund).

On and after January 1, 2024, a person shall not sell or distribute in the state any products in the following product categories if the products contain intentionally added PFAS chemicals:

- Carpets or rugs;
- Cookware;
- Cosmetics;
- Fabric treatments;
- Food packaging;
- Juvenile products;
- Oil and gas products;
- Textile furnishings; and
- Upholstered furniture.

No later than January 1, 2025, the executive director will identify by rule a list of priority products and priority product categories. No later than December 31, 2027, the executive director will promulgate rules prohibiting the sale or distribution of said priority products or priority product categories that contain intentionally added PFAS chemicals and that have not been exempted by the executive director.

No later than January 1, 2028, the executive director will identify by rule another list of priority products or priority product categories. No

later than December 31, 2030, the executive director will promulgate rules prohibiting the sale or distribution of said priority products or priority product categories that contain intentionally added PFAS chemicals and that have not been exempted by the executive director.

A manufacturer or consumer that applies for an exemption for a priority product or priority product category identified by the executive director must pay a fee established by the executive director. The fee will be credited to the fund.

Section 2 includes products that do not contain intentionally added PFAS chemicals in the definition of "environmentally preferable products" for the purposes of state agency procurement.

The bill also:

- Defines certain terminology (**section 3**);
- As of January 1, 2024, repeals the exemption for gasoline distribution facilities, refineries, and chemical plants from the restriction (sales restriction) on the sale of class B firefighting foam (firefighting foam) that contains PFAS chemicals (**section 4**);
- As of January 1, 2024, allows the executive director to grant a temporary exemption from the sales restriction for the purchase of firefighting foam that is used to extinguish class B fires at a facility that engages in the wholesale distribution of crude petroleum (**section 4**);
- Requires a person that uses firefighting foam to prohibit a release of the firefighting foam into the environment, fully contain the firefighting foam during its use, safely store the firefighting foam, and report certain information to the water quality spills hotline within 24 hours if there is a release of the firefighting foam into the environment (**section 5**);
- Requires a person that uses firefighting foam to report its use to the water quality spills hotline within 24 hours after the use (**section 5**); and
- Authorizes the attorney general to enforce laws regulating firefighting foams that contain PFAS chemicals (**section 6**).

1 **25-15-601. Short title.** THE SHORT TITLE OF THIS PART 14 IS THE

3 PROTECTION ACT".

4 **25-15-602. Legislative declaration.** (1) THE GENERAL ASSEMBLY
5 HEREBY FINDS AND DECLARES THAT:

6 (a) CONTAMINATION OF THE SOIL AND WATER IN THE STATE FROM
7 PFAS CHEMICALS POSES A SIGNIFICANT THREAT TO THE ENVIRONMENT OF
8 THE STATE AND THE HEALTH OF ITS RESIDENTS;

9 (b) A GROWING BODY OF SCIENTIFIC RESEARCH HAS FOUND THAT
10 EXPOSURE TO PFAS CHEMICALS MAY LEAD TO SERIOUS AND HARMFUL
11 HEALTH EFFECTS;

12 (c) THE FULL EXTENT OF THE CONTAMINATION OF PFAS
13 CHEMICALS IN THE SOIL AND WATER OF THE STATE IS NOT CURRENTLY
14 KNOWN BUT IS ANTICIPATED TO BE WIDESPREAD AND TO REQUIRE A
15 SIGNIFICANT EXPENDITURE OF RESOURCES TO BE IDENTIFIED AND
16 REMEDIATED;

17 (d) PFAS CHEMICALS CONTINUE TO BE USED IN PRODUCTS ACROSS
18 A VARIETY OF INDUSTRIES AND FOR MANY DIFFERENT PURPOSES;

19 (e) PFAS CHEMICALS ARE NOT NECESSARY IN MANY PRODUCTS
20 AND COULD BE REPLACED WITH LESS HARMFUL CHEMICALS OR
21 TECHNOLOGIES; AND

22 (f) IF THE WIDESPREAD SALE AND DISTRIBUTION OF PRODUCTS
23 THAT CONTAIN INTENTIONALLY ADDED PFAS CHEMICALS CONTINUES IN
24 THE STATE:

25 (I) THERE IS A LARGER RISK OF PFAS CHEMICALS MIGRATING INTO
26 THE NATURAL ENVIRONMENT;

27 (II) RESIDENTS OF THE STATE WILL LIKELY SUFFER ADVERSE

1 HEALTH EFFECTS FROM EXPOSURE TO PFAS CHEMICALS; AND

2 (III) THE STATE AND LOCAL COMMUNITIES WILL BE BURDENED
3 WITH THE TESTING, MONITORING, AND CLEAN-UP COSTS NECESSARY TO
4 KEEP RESIDENTS SAFE FROM EXPOSURE TO PFAS CHEMICALS.

5 (2) THE GENERAL ASSEMBLY THEREFORE DETERMINES AND
6 DECLARES THAT IT IS IMPERATIVE FOR THE HEALTH AND SAFETY OF THE
7 STATE'S RESIDENTS TO CREATE A REGULATORY SCHEME THAT PHASES

5 CHEMICALS THAT ARE INTENTIONAL BREAKDOWN PRODUCTS OF AN ADDED
6 CHEMICAL.

7 (13) (a) "JUVENILE PRODUCT" MEANS A PRODUCT DESIGNED FOR
8 USE BY INFANTS OR CHILDREN UNDER TWELVE YEARS OF AGE.

9 (b) "JUVENILE PRODUCT" INCLUDES:



1 PRODUCT LISTING FOR ONLINE SALES PURSUANT TO SUBSECTION (2)(b) OF
2 THIS SECTION.

3 (e) ON AND AFTER JANUARY 1, 2024, A MANUFACTURER SHALL
4 NOT MAKE A CLAIM, ON THE COOKWARE PACKAGE, THAT THE COOKWARE
5 IS FREE OF ANY PFAS CHEMICALS UNLESS NO INDIVIDUAL PFAS
6 CHEMICAL IS INTENTIONALLY ADDED TO THE COOKWARE.

7 (f) COOKWARE THAT CONTAINS ONE OR MORE INTENTIONALLY
8 ADDED PFAS CHEMICALS IN THE HANDLE OF THE PRODUCT OR IN ANY
9 PRODUCT SURFACE THAT COMES INTO CONTACT WITH FOOD, FOODSTUFFS,
10 OR BEVERAGES SHALL NOT BE SOLD, OFFERED FOR SALE, OR DISTRIBUTED
11 IN THE STATE UNLESS THE COOKWARE AND THE MANUFACTURER OF THE
12 COOKWARE COMPLY WITH THIS PART 6.

13 (3) ON AND AFTER JANUARY 1, 2025, A PERSON SHALL NOT SELL,
14 OFFER FOR SALE, DISTRIBUTE FOR SALE, OR DISTRIBUTE FOR USE THE
15 FOLLOWING PRODUCTS THAT CONTAIN INTENTIONALLY ADDED PFAS
16 CHEMICALS:

- 17 (a) COSMETICS;
- 18 (b) INDOOR TEXTILE FURNISHINGS; AND
- 19 (c) INDOOR UPHOLSTERED FURNITURE.

20 (4) ON AND AFTER JANUARY 1, 2027, A PERSON SHALL NOT SELL,
21 OFFER FOR SALE, DISTRIBUTE FOR SALE, OR DISTRIBUTE FOR USE THE
22 FOLLOWING PRODUCTS THAT CONTAIN INTENTIONALLY ADDED PFAS
23 CHEMICALS:

- 24 (a) OUTDOOR TEXTILE FURNISHINGS; AND
- 25 (b) OUTDOOR UPHOLSTERED FURNITURE.

26 **SECTION 2.** In Colorado Revised Statutes, 24-103-904, **amend**
27 (1) as follows:

1 **24-103-904. Purchasing preference for environmentally**
2 **preferable products - definitions.** (1) As used in this section, unless the
3 context otherwise requires:

4 (a) "Environmentally preferable products" means products,
5 INCLUDING PRODUCTS THAT DO NOT CONTAIN INTENTIONALLY ADDED
6 PFAS CHEMICALS, that have a lesser or reduced adverse effect on human
7 health and the environment when compared with competing products that
8 serve the same purpose. The product comparison may consider such
9 factors as the availability of any raw materials used in the product being
10 purchased and the availability, use, production, safe operation,
11 maintenance, packaging, distribution, disposal, or recyclability of the
12 product being purchased.

13 (b) "INTENTIONALLY ADDED PFAS CHEMICALS" HAS THE MEANING
14 SET FORTH IN SECTION 25-15-603 (12).

15 **SECTION 3.** In Colorado Revised Statutes, 25-5-1302, **add** (1.5),
16 (3.6), (5.8), (7.5), (9), and (10) as follows:

17 **25-5-1302. Definitions.** As used in this part 13, unless the context
18 otherwise requires:

19 (1.5) "CLASS B FIRE" MEANS A FIRE INVOLVING FLAMMABLE
20 LIQUIDS OR GASES, INCLUDING PETROLEUM, PAINT, ALCOHOL, SOLVENT,
21 OIL, AND TAR.

22 (3.6) "EXECUTIVE DIRECTOR" MEANS THE EXECUTIVE DIRECTOR OF
23 THE DEPARTMENT OR THE EXECUTIVE DIRECTOR'S DESIGNEE.

24 (5.8) "INTENTIONALLY ADDED PFAS CHEMICALS" HAS THE
25 MEANING SET FORTH IN SECTION 25-15-603 (12).

26 (7.5) "RELEASE" MEANS ANY SPILLING, LEAKING, PUMPING,
27 POURING, EMPTYING, DISCHARGING, INJECTING, ESCAPING, LEACHING,

1 DUMPING, OR DISPOSING OF A CHEMICAL INTO THE ENVIRONMENT.

2 (9) "TERMINAL" MEANS A FACILITY THAT ENGAGES IN THE
3 WHOLESALE DISTRIBUTION OF CRUDE PETROLEUM AND PETROLEUM
4 PRODUCTS, INCLUDING LIQUIFIED PETROLEUM GAS FROM BULK LIQUID
5 STORAGE FACILITIES.

6 (10) "WATER QUALITY SPILLS HOTLINE" MEANS THE PHONE
7 SYSTEM CREATED AND MAINTAINED BY THE DEPARTMENT FOR THE
8 REPORTING OF SPILLS OR DISCHARGES INTO STATE WATERS TO THE
9 DEPARTMENT.

10

11 **SECTION 4.** In Colorado Revised Statutes, **add 25-5-1303.5** as
12 follows:

13 **25-5-1303.5. Restriction on use of certain firefighting foams.**

14 (1) BEGINNING JANUARY 1, 2024, A PERSON THAT USES CLASS B
15 FIREFIGHTING FOAM CONTAINING INTENTIONALLY ADDED PFAS
16 CHEMICALS SHALL:

17 (a) NOT ALLOW A RELEASE OF THE CLASS B FIREFIGHTING FOAM;

18 (b) FULLY CONTAIN THE CLASS B FIREFIGHTING FOAM BY
19 IMPLEMENTING APPROPRIATE CONTAINMENT MEASURES, WHICH MAY
20 INCLUDE BUNDS AND PONDS, THAT:

21 (I) ARE CONTROLLED;

22 (II) ARE IMPERVIOUS TO PFAS CHEMICALS; AND

23 (III) DO NOT ALLOW THE CLASS B FIREFIGHTING FOAM OR ANY
24 ASSOCIATED FIREWATER, WASTEWATER, RUNOFF, OR OTHER WASTE TO BE
25 RELEASED;

26 (c) SAFELY STORE ALL CLASS B FIREFIGHTING FOAM AND ANY
27 ASSOCIATED FIREWATER, WASTEWATER, RUNOFF, AND OTHER WASTE IN A

1 WAY THAT PREVENTS THEIR RELEASE UNTIL THE FEDERAL
2 ENVIRONMENTAL PROTECTION AGENCY HAS PUBLISHED GUIDANCE ON THE
3 PROPER DISPOSAL AND DESTRUCTION METHODS FOR PFAS CHEMICALS.
4 AFTER THE FEDERAL ENVIRONMENTAL PROTECTION AGENCY HAS
5 PUBLISHED GUIDANCE ON THE PROPER DISPOSAL AND DESTRUCTION
6 METHODS FOR PFAS CHEMICALS, THE PERSON THAT USES THE CLASS B
7 FIREFIGHTING FOAM CONTAINING INTENTIONALLY ADDED PFAS
8 CHEMICALS SHALL DISPOSE OF AND DESTROY THE CLASS B FIREFIGHTING
9 FOAM IN ACCORDANCE WITH SUCH GUIDANCE.

10 (d) IF THERE IS A RELEASE OF THE CLASS B FIREFIGHTING FOAM OR
11 ANY ASSOCIATED FIREWATER, WASTEWATER, RUNOFF, OR OTHER WASTE,
12 REPORT THE FOLLOWING INFORMATION TO THE WATER QUALITY SPILLS
13 HOTLINE WITHIN TWENTY-FOUR HOURS AFTER ITS RELEASE:

14 (I) THE TRADE NAME AND PRODUCT NAME OF THE CLASS B
15 FIREFIGHTING FOAM;

16 (II) THE QUANTITY OF CLASS B FIREFIGHTING FOAM USED THAT
17 CONTAINS INTENTIONALLY ADDED PFAS CHEMICALS;

18 (III) THE AMOUNT AND TYPE OF PFAS CHEMICALS IN THE CLASS
19 B FIREFIGHTING FOAM; AND

20 (IV) THE AMOUNT OF CLASS B FIREFIGHTING FOAM OR ANY
21 ASSOCIATED FIREWATER, WASTEWATER, RUNOFF, AND OTHER WASTE THAT
22 IS RELEASED; AND

23 (e) DOCUMENT ANY MEASURES UNDERTAKEN PURSUANT TO THE
24 REQUIREMENTS OF THIS SECTION. IN INVESTIGATING COMPLIANCE WITH
25 THE REQUIREMENTS OF THIS SECTION, THE ATTORNEY GENERAL MAY
26 REQUEST THAT THE PERSON PROVIDE THE DOCUMENTATION CREATED
27 PURSUANT TO THE REQUIREMENTS OF THIS SUBSECTION (1)(e) TO THE

1 ATTORNEY GENERAL.

2 (2) BEGINNING JANUARY 1, 2024, A PERSON THAT USES CLASS B
3 FIREFIGHTING FOAM THAT CONTAINS INTENTIONALLY ADDED PFAS
4 CHEMICALS MUST REPORT THE USE OF THE CLASS B FIREFIGHTING FOAM TO
5 THE WATER QUALITY SPILLS HOTLINE WITHIN TWENTY-FOUR HOURS AFTER
6 ITS USE.

7 (3) (a) EXCEPT AS PROVIDED IN SUBSECTION (3)(b) OF THIS
8 SECTION, THE RESTRICTIONS AND REQUIREMENTS IN SUBSECTIONS (1) AND
9 (2) OF THIS SECTION DO NOT APPLY TO THE USE OF CLASS B FIREFIGHTING
10 FOAM WHERE THE INCLUSION OF PFAS CHEMICALS IS REQUIRED OR
11 AUTHORIZED BY FEDERAL LAW, INCLUDING 14 CFR 139, OR IMPLEMENTED
12 IN ACCORDANCE WITH FEDERAL AVIATION ADMINISTRATION GUIDANCE, OR
13 OTHERWISE REQUIRED FOR A MILITARY PURPOSE.

14 (b) IF THE EXECUTIVE DIRECTOR DETERMINES BY RULE THAT THE
15 LAWS, GUIDANCE, OR REQUIREMENTS DESCRIBED IN SUBSECTION (3)(a) OF
16 THIS SECTION NO LONGER APPLY TO A PARTICULAR INDUSTRY OR SECTOR,
17 THE EXECUTIVE DIRECTOR SHALL PROVIDE NOTICE ON THE DEPARTMENT'S
18 WEBSITE OF THIS DETERMINATION AND SHALL PROMULGATE RULES
19 PROHIBITING USERS OF CLASS B FIREFIGHTING FOAM WITHIN THAT
20 INDUSTRY OR SECTOR FROM USING CLASS B FIREFIGHTING FOAM IN
21 VIOLATION OF THIS SECTION, WHICH RULES SHALL APPLY NO SOONER THAN
22 TWO YEARS AFTER THE EXECUTIVE DIRECTOR'S DETERMINATION.

23 **SECTION 5.** In Colorado Revised Statutes, **amend 25-5-1307** as
24 follows:

25 **25-5-1307. Civil penalty.** (1) A manufacturer or a person who
26 violates ~~the provisions of~~ this part 13 is subject to a civil penalty not to
27 exceed five thousand dollars for each violation in the case of a first

1 offense. A manufacturer or a person who violates this part 13 repeatedly
2 is subject to a civil penalty not to exceed ten thousand dollars for each
3 repeat offense. Penalties collected under this part 13 must be deposited
4 in the local firefighter safety and disease prevention fund created in
5 section 24-33.5-1231.

6 (2) THE ATTORNEY GENERAL HAS THE AUTHORITY TO ENFORCE
7 THIS PART 13 AND TO CONDUCT CIVIL INVESTIGATIONS AND BRING CIVIL
8 ACTIONS FOR VIOLATIONS OF THIS PART 13.

9 **SECTION 6.** In Colorado Revised Statutes, 25-5-1309, **amend**
10 (1) introductory portion as follows:

11 **25-5-1309. Restriction on the use of certain firefighting foam**
12 **at certain airports - definitions.** (1) Beginning January 1, 2023 2024,
13 the use of class B firefighting foam that contains intentionally added
14 perfluoroalkyl and polyfluoroalkyl substances shall be prohibited at
15 structures used for the storage or maintenance of aircraft where the
16 structure is located in an airport that:

17 **SECTION 7. Safety clause.** The general assembly hereby finds,
18 determines, and declares that this act is necessary for the immediate
19 preservation of the public peace, health, or safety.
