**A BILL FOR AN ACT**

101      **CONCERNING THE CREATION OF THE CONNECTING COLORADANS**  
102              **EXPERIENCING HOMELESSNESS WITH SERVICES, RECOVERY**  
103              **CARE, AND HOUSING SUPPORTS GRANT PROGRAM, AND, IN**  
104              **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

The bill creates the connecting Coloradans experiencing homelessness with services, treatment, and housing supports grant program (grant program), administered by the division of housing

(division) in the department of local affairs (department).

The grant program provides grants to local governments and nonprofit organizations to enable those entities to make investments and improvements in their communities or regions of the state to address and respond to the needs of people experiencing homelessness.

The bill requires the division to develop policies, procedures, and guidelines governing the administration of the grant program. The bill specifies how grant funding is to be awarded and the eligible uses of grant money awarded under the grant program. The bill specifies requirements for grant recipients.

The bill creates the connecting Coloradans experiencing homelessness with services, treatment, and housing supports fund (fund) in the department. The bill specifies requirements pertaining to the administration of the fund. The bill requires a transfer of \$105 million from the economic recovery and relief cash fund to the fund to administer the grant program.

The bill sets forth specified reporting requirements pertaining to the grant program.

The bill requires the department, in conjunction with the department of health care policy and financing, to report to the house of representatives public and behavioral health and human services committee and the senate health and human services committee, and to its committee of reference during its "State Measurement for Accountable, Responsive, and Transparent (SMART) Government Act" hearing, any results, recommendations, and federal implications concerning any supportive housing pilot program currently being administered by the department in conjunction with the department of health care policy and financing.

The bill requires the division to report on the activities of the grant program as part of the regular annual public report prepared by the division on affordable and emergency housing spending.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1. Legislative declaration.** (1) The general assembly  
3 finds, determines, and declares that:

4           (a) The state of Colorado is focused on supporting communities  
5 to create proven responses to homelessness that are designed to connect  
6 people without stable housing to services, care, and housing to help  
7 ensure that when homelessness occurs, it is rare and brief, and that no one

1 gets left behind;

2 (b) The COVID-19 pandemic has exacerbated Colorado's  
3 homelessness and behavioral health crisis. Many communities do not  
4 have sufficient responses to address housing and behavioral health needs  
5 for their community members.

6 (c) People experiencing homelessness with chronic behavioral  
7 health issues face many challenges in accessing long-term treatment and  
8 are far more likely to receive care in hospital emergency departments.  
9 Without trained and dedicated providers or advocates, people  
10 experiencing homelessness often end up in a cycle of expensive treatment  
11 with little or no follow-up.

12 (d) Housing and support services are crucial for the safety, health,  
13 and well-being of Coloradans. Extensive research shows that housing is  
14 an essential social determinant of health. Stable housing improves health  
15 outcomes and decreases health-care costs.

16 (2) Therefore, it is the intent of the general assembly to facilitate  
17 investments in local communities across the state of Colorado to quickly  
18 connect people experiencing homelessness with services, treatment, and  
19 temporary and permanent housing to put them on a path to economic  
20 self-sufficiency.

21 (3) The general assembly further finds and declares that the grant  
22 program described in this act is an important government service.

23 **SECTION 2.** In Colorado Revised Statutes, **add** 24-32-726 as  
24 follows:

25 **24-32-726. Connecting Coloradans experiencing homelessness**  
26 **with services, recovery care, and housing supports grant program -**  
27 **funding - report - definitions - repeal.** (1) **Definitions.** AS USED IN THIS

1 SECTION, UNLESS THE CONTEXT OTHERWISE REQUIRES:

2 (a) "COMMUNITY PARTNER" MEANS A NONPROFIT ORGANIZATION  
3 THAT UNDERTAKES ANY OF THE ACTIVITIES OR SERVICES DESCRIBED IN  
4 SUBSECTION (2)(c) OF THIS SECTION.

5 (b) "DEPARTMENT" MEANS THE DEPARTMENT OF LOCAL AFFAIRS.

6 (c) "ELIGIBLE RECIPIENT" MEANS A LOCAL GOVERNMENT OR A  
7 COMMUNITY PARTNER THAT APPLIES FOR A GRANT THROUGH THE GRANT  
8 PROGRAM.

9 (d) "FUND" MEANS THE CONNECTING COLORADANS EXPERIENCING  
10 HOMELESSNESS WITH SERVICES, RECOVERY CARE, AND HOUSING SUPPORTS  
11 FUND CREATED IN SUBSECTION (5)(a) OF THIS SECTION.

12 (e) "GRANT PROGRAM" MEANS THE CONNECTING COLORADANS  
13 EXPERIENCING HOMELESSNESS WITH SERVICES, RECOVERY CARE, AND  
14 HOUSING SUPPORTS GRANT PROGRAM CREATED IN SUBSECTION (2)(a) OF  
15 THIS SECTION.

16 (f) "LOCAL GOVERNMENT" MEANS A COUNTY, MUNICIPALITY, CITY  
17 AND COUNTY, TRIBAL GOVERNMENT, SPECIAL DISTRICT ORGANIZED  
18 PURSUANT TO TITLE 32, SCHOOL DISTRICT, DISTRICT, HOUSING AUTHORITY,  
19 COUNCIL OF GOVERNMENTS, REGIONAL PLANNING COMMISSION  
20 ORGANIZED PURSUANT TO TITLE 30, OR ANY OTHER POLITICAL  
21 SUBDIVISION OF THE STATE.

22 (g) "MATCH" MEANS MONETARY AND NONMONETARY  
23 CONTRIBUTIONS TO A PROJECT.

24 (2) **Creation of the grant program - projects or programs**  
25 **eligible for funding.** (a) THERE IS CREATED IN THE DIVISION THE  
26 CONNECTING COLORADANS EXPERIENCING HOMELESSNESS WITH  
27 SERVICES, RECOVERY CARE, AND HOUSING SUPPORTS GRANT PROGRAM TO

1 PROVIDE GRANTS TO ELIGIBLE RECIPIENTS TO ENABLE THEM TO MAKE  
2 INVESTMENTS OR IMPROVEMENTS IN THEIR COMMUNITIES OR REGIONS OF  
3 THE STATE TO:

4 (I) QUICKLY CONNECT PEOPLE EXPERIENCING HOMELESSNESS TO  
5 SERVICES, VOCATIONAL OPPORTUNITIES, RECOVERY CARE, AND  
6 TEMPORARY AND PERMANENT HOUSING IN ACCORDANCE WITH THE  
7 REQUIREMENTS OF THIS SECTION; AND

8 (II) ENSURE COLORADO HAS A COMMUNITY-BASED CONTINUUM OF  
9 RESPONSES FOR PEOPLE EXPERIENCING HOMELESSNESS, INCLUDING  
10 OUTREACH SUPPORT, EMERGENCY SHELTERS, TRANSITIONAL HOUSING,  
11 RECOVERY CARE AND RELATED RESIDENTIAL PROGRAMS, TRAINING AND  
12 EMPLOYMENT SERVICE PROGRAMS, AND PERMANENT HOUSING WITH  
13 WRAPAROUND SUPPORTIVE SERVICES.

14 (b) THE DIVISION SHALL ADMINISTER THE GRANT PROGRAM.

15 (c) THE DIVISION MAY AWARD GRANTS UNDER THE GRANT  
16 PROGRAM TO SUPPORT ELIGIBLE RECIPIENTS IN PROJECTS OR PROGRAMS  
17 THAT:

18 (I) PROVIDE GAP FINANCING FOR THE PURCHASE OR CONVERSION  
19 OF UNDERUTILIZED PROPERTIES IN COMMUNITIES WHERE EFFORTS HAVE  
20 BEEN MADE TO ENCOURAGE CONVERSION OF UNDERUTILIZED PROPERTIES  
21 INTO TRANSITIONAL OR SUPPORTIVE HOUSING THAT PROVIDES  
22 WRAPAROUND SERVICES;

23 (II) PROVIDE SUPPORTIVE SERVICES SO LONG AS THE SUPPORTIVE  
24 SERVICES MEET THE GRANT PROGRAM GOALS OUTLINED IN SUBSECTION (4)  
25 OF THIS SECTION. SUCH SUPPORTIVE SERVICES INCLUDE THOSE DESCRIBED  
26 IN 42 CFR 578.53, OR ANY SUCCESSOR REGULATION, AND THOSE  
27 DETERMINED BY THE DIVISION. FUNDS MAY BE USED TO PROVIDE

1 SUPPORTIVE SERVICES IN CONJUNCTION WITH CAPITAL IMPROVEMENTS  
2 AND HOUSING DEVELOPMENT PROJECTS OR AS STANDALONE SERVICES  
3 THAT ARE PROVIDED TO AN INDIVIDUAL THROUGH A SERVICE PROVIDER.

4 (III) INVEST IN DATA COLLECTION, MANAGEMENT, AND ANALYSIS  
5 PROCESSES TO UNDERSTAND THE SCALE OF THE NEED THROUGHOUT  
6 THE STATE AND WHETHER THE ACTIVITIES AND INVESTMENTS THROUGH  
7 THIS GRANT AND OTHER STATEWIDE PROGRAMS COULD BE EFFECTIVE AT  
8 REDUCING THE NUMBER OF PEOPLE EXPERIENCING HOMELESSNESS;

9 (IV) SUPPORT THE COORDINATION AND INTEGRATION OF SYSTEMS  
10 TO HELP CONNECT PEOPLE EXPERIENCING HOMELESSNESS WITH SERVICES  
11 AND PROGRAMS THAT BEST FIT THEIR INDIVIDUAL NEEDS; AND

12 (V) FUND HOUSING DEVELOPMENT PROJECTS AND HOMELESS  
13 RESPONSE PROGRAMS THAT INCLUDE BUT ARE NOT LIMITED TO:

- 14 (A) EMERGENCY HOMELESS SHELTERS;
- 15 (B) TRANSITIONAL AND BRIDGE HOUSING;
- 16 (C) LONG-TERM HOUSING;
- 17 (D) PERMANENT SUPPORTIVE HOUSING WITH SUPPORTIVE  
18 SERVICES;
- 19 (E) RECOVERY CARE AND RELATED RESIDENTIAL PROGRAMS;
- 20 (F) AFFORDABLE HOME OWNERSHIP ASSISTANCE;
- 21 (G) AFFORDABLE RENTAL HOUSING, INCLUDING SECURITY DEPOSIT  
22 ASSISTANCE;
- 23 (H) EDUCATIONAL AND VOCATIONAL OPPORTUNITIES; AND
- 24 (I) WORK-BASED LEARNING OPPORTUNITIES.

25 (d) IN ORDER TO RECEIVE A GRANT, AN ELIGIBLE RECIPIENT MUST  
26 PROVIDE A MATCH IN RESOURCES, AS DETERMINED BY THE DIVISION.

27 (3) **Policies, procedures, and guidelines.** (a) THE DIVISION

1 SHALL DEVELOP POLICIES, PROCEDURES, AND GUIDELINES FOR THE GRANT  
2 PROGRAM THAT, WITHOUT LIMITATION:

3 (I) DETERMINE HOW GRANTS FUNDED BY THE GRANT PROGRAM  
4 MUST BE USED;

5 (II) ESTABLISH CRITERIA THAT THE DIVISION MUST CONSIDER IN  
6 AWARDING GRANTS PURSUANT TO THIS SECTION. AT A MINIMUM, THE  
7 CRITERIA MUST INCLUDE THE CONSIDERATION OF:

8 (A) THE POTENTIAL IMPACT OF A PROJECT THAT AN ELIGIBLE  
9 RECIPIENT FUNDS WITH A GRANT AWARD AND HOW THE PROJECT MEETS  
10 THE GOALS OF THE GRANT PROGRAM; AND

11 (B) BEST PRACTICES, DATA, AND REGIONAL AND LOCAL  
12 COLLABORATION.

13 (III) ESTABLISH THE PROCEDURES AND TIMELINES BY WHICH AN  
14 ELIGIBLE RECIPIENT MAY APPLY FOR A GRANT;

15 (IV) REQUIRE GRANT RECIPIENTS TO OFFER A MATCH;

16 (V) REQUIRE ELIGIBLE RECIPIENTS TO DEMONSTRATE HOW THE  
17 GRANT FUNDS WILL BE USED TO INCREASE HOUSING AND ECONOMIC  
18 SECURITY FOR INDIVIDUALS BEING SERVED THROUGH THE GRANT  
19 PROGRAM ACTIVITIES AND EFFORTS;

20 (VI) ESTABLISH REPORTING REQUIREMENTS FOR GRANT  
21 RECIPIENTS;

22 (VII) ESTABLISH PERFORMANCE CRITERIA FOR GRANT RECIPIENTS'  
23 PROJECTS;

24 (VIII) PROVIDE ANY ADDITIONAL REQUIREMENTS THAT THE  
25 DIVISION DEEMS NECESSARY TO ADMINISTER THE GRANT PROGRAM; AND

26 (IX) DEMONSTRATE THE ABILITY TO LEVERAGE PRIVATE CAPITAL,  
27 WHEN POSSIBLE.

1 (b) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION,  
2 THE AMOUNT OF ANY GRANT AWARDED UNDER THE GRANT PROGRAM AND  
3 ANY RESTRICTIONS OR CONDITIONS PLACED UPON THE USE OF GRANT  
4 MONEY AWARDED IS WITHIN THE DISCRETION OF THE DIVISION IN  
5 ACCORDANCE WITH THE REQUIREMENTS OF THIS SECTION.

6 (4) **Grant program goals.** THE GRANT PROGRAM MUST BE  
7 ADMINISTERED WITH THE GOAL OF REDUCING THE RATE AND EXPERIENCE  
8 OF HOMELESSNESS BY SUPPORTING COMMUNITIES TO DEVELOP AND  
9 IMPLEMENT ADEQUATE SUPPORT SYSTEMS TO EFFECTIVELY RESPOND TO  
10 THE BARRIERS PEOPLE EXPERIENCING HOMELESSNESS FACE.

11 (5) **Connecting Coloradans experiencing homelessness with**  
12 **services, recovery care, and housing supports fund - transfer of**  
13 **money to the fund - appropriation.** (a) THE CONNECTING COLORADANS  
14 EXPERIENCING HOMELESSNESS WITH SERVICES, RECOVERY CARE, AND  
15 HOUSING SUPPORTS FUND IS CREATED IN THE DEPARTMENT. THE FUND  
16 CONSISTS OF MONEY TRANSFERRED TO THE FUND IN ACCORDANCE WITH  
17 SUBSECTION (5)(d) OF THIS SECTION; MONEY APPROPRIATED TO THE FUND  
18 BY THE GENERAL ASSEMBLY; AND ANY GIFTS, GRANTS, OR DONATIONS  
19 FROM ANY PUBLIC OR PRIVATE SOURCES, INCLUDING GOVERNMENTAL  
20 ENTITIES, THAT THE DIVISION IS AUTHORIZED TO SEEK AND ACCEPT.

21 (b) THE DEPARTMENT SHALL CREDIT ALL INTEREST AND INCOME  
22 DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE FUND TO  
23 THE FUND. ALL MONEY NOT EXPENDED OR ENCUMBERED, AND ALL  
24 INTEREST EARNED ON THE INVESTMENT OR DEPOSIT OF MONEY IN THE  
25 FUND, REMAINS IN THE FUND AND DOES NOT REVERT TO THE GENERAL  
26 FUND OR ANY OTHER FUND AT THE END OF ANY FISCAL YEAR. THE MONEY  
27 IN THE FUND IS CONTINUOUSLY APPROPRIATED TO THE DEPARTMENT FOR



1 THE PURPOSES SPECIFIED IN THIS SECTION.

2 (c) THE DIVISION MAY SEEK, ACCEPT, AND EXPEND GIFTS, GRANTS,  
3 OR DONATIONS FROM ANY PUBLIC OR PRIVATE RESOURCE FOR THE  
4 PURPOSES OF THIS SECTION. THE DIVISION SHALL TRANSMIT ALL MONEY  
5 RECEIVED FROM GIFTS, GRANTS, OR DONATIONS TO THE DEPARTMENT, AND  
6 THE DEPARTMENT SHALL CREDIT THE MONEY TO THE FUND.

7 (d) WITHIN THREE BUSINESS DAYS OF THE EFFECTIVE DATE OF THIS  
8 SECTION, THE STATE TREASURER SHALL TRANSFER ONE HUNDRED FIVE  
9 MILLION DOLLARS FROM THE ECONOMIC RECOVERY AND RELIEF CASH  
10 FUND CREATED IN SECTION 24-75-228 THAT ORIGINATES FROM THE MONEY  
11 THE STATE RECEIVED FROM THE FEDERAL CORONAVIRUS STATE FISCAL  
12 RECOVERY FUND TO THE FUND FOR THE PURPOSE OF IMPLEMENTING THIS  
13 SECTION. THE DEPARTMENT SHALL ONLY USE THE MONEY TRANSFERRED  
14 PURSUANT TO THIS SUBSECTION (5)(d) FOR:

15 (I) MAKING GRANTS TO ELIGIBLE RECIPIENTS PURSUANT TO THE  
16 GRANT PROGRAM; AND

17 (II) THE COSTS OF ADMINISTERING THE GRANT PROGRAM AS MAY  
18 BE INCURRED BY THE DIVISION. THE DIVISION MAY EXPEND UP TO SEVEN  
19 PERCENT OF THE MONEY APPROPRIATED OR TRANSFERRED TO THE FUND TO  
20 PAY FOR THE DIRECT AND INDIRECT COSTS IN ADMINISTERING THE GRANT  
21 PROGRAM. ALL ADMINISTRATIVE COSTS MUST BE PAID OUT OF THE MONEY  
22 TRANSFERRED TO THE FUND PURSUANT TO THIS SUBSECTION (5)(d)(II).

23 (e) THE DIVISION MAY EXPEND UP TO FIVE MILLION DOLLARS OF  
24 THE MONEY APPROPRIATED TO THE FUND FOR DATA COLLECTION AND  
25 OUTREACH EFFORTS DETAILED IN SUBSECTION (2)(c)(III) OF THIS SECTION.

26 (f) MONEY SPENT PURSUANT TO THIS SUBSECTION (5)(f) MUST  
27 CONFORM WITH THE ALLOWABLE PURPOSES SET FORTH IN THE FEDERAL

1 "AMERICAN RESCUE PLAN ACT OF 2021", PUB.L. 117-2, AS AMENDED.  
2 THE DIVISION SHALL SPEND OR OBLIGATE SUCH APPROPRIATION PRIOR TO  
3 DECEMBER 30, 2024, AND EXPEND THE APPROPRIATION ON OR BEFORE  
4 DECEMBER 31, 2026.

5 (g) THE EXPENDITURES MADE PURSUANT TO THIS SECTION  
6 CONSTITUTE GOVERNMENT SERVICES.

7 (h) THIS SUBSECTION (5) IS REPEALED, EFFECTIVE DECEMBER 31,  
8 2026.

9 (6) **Reporting.** (a) THE DIVISION SHALL INCLUDE IN THE PUBLIC  
10 REPORT THE DIVISION PREPARES IN ACCORDANCE WITH SECTION  
11 24-32-705.5 (1) INFORMATION SUMMARIZING THE USE OF ALL THE MONEY  
12 THAT WAS AWARDED AS GRANTS FROM THE GRANT PROGRAM IN THE  
13 PRECEDING STATE FISCAL YEAR. AT A MINIMUM, THE INFORMATION MUST  
14 SPECIFY:

15 (I) THE NUMBER OF LOCAL GOVERNMENTS OR COMMUNITY  
16 PARTNERS THAT APPLIED FOR A GRANT, INCLUDING THE NUMBER OF LOCAL  
17 GOVERNMENTS OR COMMUNITY PARTNERS THAT WERE NOT AWARDED A  
18 GRANT;

19 (II) THE AMOUNT OF THE GRANT MONEY DISTRIBUTED TO EACH  
20 GRANT RECIPIENT;

21 (III) A DESCRIPTION OF EACH GRANT RECIPIENT'S USE OF THE  
22 GRANT MONEY;

23 (IV) HOW THE USE OF THE GRANT AWARDED FURTHERED THE  
24 GOALS OF THE GRANT PROGRAM DESCRIBED IN SUBSECTION (4) OF THIS  
25 SECTION; AND

26 (V) RECOMMENDATIONS CONCERNING FURTHER ADMINISTRATION  
27 OF THE GRANT PROGRAM.

1 (b) THE DIVISION AND ANY ENTITY THAT RECEIVES MONEY FROM  
2 THE DIVISION SHALL COMPLY WITH THE COMPLIANCE, REPORTING,  
3 RECORD-KEEPING, AND PROGRAM EVALUATION REQUIREMENTS  
4 ESTABLISHED BY THE OFFICE OF STATE PLANNING AND BUDGETING AND  
5 THE STATE CONTROLLER IN ACCORDANCE WITH SECTION 24-75-226 (5).

6 (c) IN THE 2023 LEGISLATIVE SESSION, THE DEPARTMENT, IN  
7 CONJUNCTION WITH THE DEPARTMENT OF HEALTH CARE POLICY AND  
8 FINANCING, SHALL SHARE ANY RESULTS, RECOMMENDATIONS, AND  
9 FEDERAL IMPLICATIONS CONCERNING ANY CURRENT SUPPORTIVE HOUSING  
10 PILOT PROGRAMS BEING ADMINISTERED BY THE DEPARTMENT AND  
11 DIVISION AND THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING  
12 AS PART OF ITS "STATE MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE,  
13 AND TRANSPARENT (SMART) GOVERNMENT ACT" HEARING PURSUANT  
14 TO SECTION 2-7-203. IN THE 2023 LEGISLATIVE SESSION, THE DEPARTMENT  
15 AND THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING SHALL  
16 SUBMIT A REPORT DETAILING ANY SUCH RESULTS, RECOMMENDATIONS,  
17 AND FEDERAL IMPLICATIONS CONCERNING ANY CURRENT SUPPORTIVE  
18 HOUSING PILOT PROGRAMS BEING OPERATED BY THE DEPARTMENT AND  
19 DIVISION AND THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING  
20 TO THE HOUSE OF REPRESENTATIVES PUBLIC AND BEHAVIORAL HEALTH  
21 AND HUMAN SERVICES COMMITTEE AND THE SENATE HEALTH AND HUMAN  
22 SERVICES COMMITTEE, OR ANY SUCCESSOR COMMITTEES.

23 (7) **Repeal.** THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2027.

24 **SECTION 3.** In Colorado Revised Statutes, 24-32-705, **amend**  
25 (7) as follows:

26 **24-32-705. Functions of division.** (7) The division shall  
27 administer:

1 (a) The affordable housing guided toolkit and local officials guide
