**Bill Summary**

**Sunset Process - Senate Education Committee.** The Colorado youth advisory council (advisory committee) is set to repeal September 1, 2023. The bill implements the department of regulatory agencies' recommendation to continue the advisory committee indefinitely.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 2-2-1307 as  
3 follows:

4           **2-2-1307. Repeal of part.** This part 13 is repealed, effective  
5 September 1, 2023 SEPTEMBER 1, 2028. Prior to the repeal of this part 13,  
6 the council must be reviewed as provided for in section 2-3-1203.

7           **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
8 (14)(a)(VI); and add (19)(a)(II) as follows:

9           **2-3-1203. Sunset review of advisory committees - legislative**  
10 **declaration - definition - repeal.** (14) (a) The following statutory  
11 authorizations for the designated advisory committees are scheduled for  
12 repeal on September 1, 2023:

13           (VI) ~~The Colorado youth advisory council created in section~~  
14 ~~2-2-1302;~~

15           (19) (a) The following statutory authorizations for the designated  
16 advisory committees will repeal on September 1, 2028:

17           (II) THE COLORADO YOUTH ADVISORY COUNCIL CREATED IN  
18 SECTION 2-2-1302.

19           **SECTION 3. Appropriation.** For the 2023-24 state fiscal year,  
20 \$50,000 is appropriated to the youth advisory council cash fund created  
21 in section 2-2-1306, C.R.S. This appropriation is from the general fund.  
22 The legislative department is responsible for the accounting related to this  
23 appropriation.

24           **SECTION 4. Act subject to petition - effective date.** This act  
25 takes effect at 12:01 a.m. on the day following the expiration of the  
26 ninety-day period after final adjournment of the general assembly; except

1 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
2 of the state constitution against this act or an item, section, or part of this  
3 act within such period, then the act, item, section, or part will not take  
4 effect unless approved by the people at the general election to be held in  
5 November 2024 and, in such case, will take effect on the date of the  
6 official declaration of the vote thereon by the governor.
