A BILL FOR AN ACT

101 **CONCERNING STUDENT LEADERS INSTITUTE MODERNIZATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)

The bill continues the Colorado student leaders institute program and changes responsibility for the program from the department of higher education to the department of education. The change shifts oversight of the program from a governor-appointed executive board to the state board of education.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add with amended**
3 **and relocated provisions** article 106 to title 22 as follows:

4 **22-106-101. [Formerly 23-77-101] Legislative declaration.**

5 (1) The general assembly finds that:

6 (a) The state is committed to increasing the number of students
7 who graduate from a Colorado high school, enroll in a Colorado
8 institution of higher education, and graduate with a postsecondary
9 credential in two to four academic years;

10 (b) Several states have implemented a summer residential
11 education program for high school students who demonstrate exceptional
12 intellectual curiosity, creativity, and maturity. While participating in the
13 summer program, students attend classes, lectures, seminars, concerts, art
14 exhibits, theatrical performances, and films and have the opportunity to
15 learn independently and from distinguished faculty, staff members, and
16 guest lecturers.

17 (c) The summer residential education programs implemented in
18 other states have:

19 (I) Successfully developed a civic voice among the states' best
20 students so that they graduate from high school as civic participants;

21 (II) Prepared motivated students to participate in a competitive
22 workforce;

23 (III) Helped to create young leaders who are energized to find
24 solutions for the pressing issues facing their states; and

25 (IV) Motivated students to remain in their home states for their
26 postsecondary education and careers; and

27 (d) A high percentage of the students who have participated in the

1 summer residential education programs have subsequently enrolled in
2 postsecondary education in their home states and earned a baccalaureate
3 degree in four years.

4 (2) The general assembly finds, therefore, that it is in the best
5 interests of the state to ~~establish~~ CONTINUE the Colorado student leaders
6 institute ~~as a pilot program~~ using the model of summer residential
7 education programs implemented in other states and to appropriate state
8 money to ensure the successful operations of the institute for the benefit
9 of Colorado high school students.

10 (3) The general assembly further finds that, for purposes of
11 section 17 of article IX of the state constitution, the Colorado student
12 leaders institute is an accountable program that assists students in meeting
13 state academic standards and may therefore receive funding from the state
14 education fund created in section 17 (4) of article IX of the state
15 constitution.

16 **22-106-102. [Formerly 23-77-102] Definitions.** As used in this
17 ~~article 77~~ ARTICLE 106, unless the context otherwise requires:

18 (1) ~~"Executive board" means the executive board of the Colorado~~
19 ~~student leaders institute established pursuant to section 23-77-104.~~

20 (2) (1) "Host institution" means the institution of higher
21 education that the department of ~~higher~~ education contracts with on
22 behalf of the ~~executive~~ STATE board OF EDUCATION pursuant to ~~section~~
23 ~~23-77-104~~ SECTION 22-106-104 to operate the institute.

24 (3) (2) "Institute" means the Colorado student leaders institute
25 ~~created in section 23-77-103~~ SECTION 22-106-103.

26 **22-106-103. [Formerly 23-77-103] Colorado student leaders**
27 **institute - applications.** (1) There is ~~created~~ in the department of ~~higher~~

1 education the Colorado student leaders institute. The year-long institute
2 shall operate a competitive residential summer academic program for
3 students who are entering tenth or eleventh grade in the coming fall
4 semester. The program operated by the institute must be for four weeks
5 each summer during which time students who are accepted to the institute
6 attend college-level classes, lectures, and seminars as well as enrichment
7 activities, including concerts and theatrical productions. Each student who
8 is accepted to the institute is encouraged to donate up to four hundred
9 dollars to the institute to assist in meeting operational costs. Subject to
10 available appropriations, up to one hundred students may annually
11 participate in the institute.

12 (2) (a) The institute shall annually offer classes in at least the
13 following two areas:

14 (I) Science, technology, engineering, arts, and mathematics; and

15 (II) International social studies.

16 (b) The institute shall annually provide enrichment activities for
17 students who participate in the institute, which must include but need not
18 be limited to activities relating to visual expression and music
19 appreciation.

20 (c) In addition to participating in classes and enrichment activities,
21 students who participate in the institute must:

22 (I) Complete a history research project for a competition held
23 during the term of the institute; and

24 (II) Complete a public service practicum that includes a final
25 report of findings and recommendations to the general assembly for
26 legislative action.

27 (3) (a) (I) To apply to participate in the institute:

1 (A) A student who is enrolled in a public school that is not a
2 charter school must be nominated by the superintendent of the school
3 district in which the student is enrolled; and

4 (B) A student who is enrolled in a charter school or in a private
5 school must be nominated by the principal of the school.

6 (II) A student who is participating in a nonpublic home-based
7 educational program, as described in section 22-33-104.5, may apply
8 without having been nominated.

9 (b) To apply to participate in the institute, a student must submit
10 an application to the ~~executive board~~ HOST INSTITUTION that is in the form
11 and meets the requirements established by the host institution. If the
12 applying student is enrolled in a public school, the student must submit
13 a copy of ~~his or her~~ THE STUDENT'S individual career and academic plan,
14 as described in section 22-2-136, with the application.

15 (4) The host institution shall award three hours of postsecondary
16 academic credit to each student who successfully completes the institute.
17 The school district or high school in which each student is enrolled is
18 encouraged to apply the academic credit hours that a student receives for
19 completing the institute toward academic credit hours earned in civics, to
20 apply toward the completion of the student's high school graduation
21 requirements.

22 **22-106-104. [Formerly 23-77-104] Colorado student leaders**
23 **institute - state board of education - duties.** ~~(1) An executive board~~
24 ~~appointed pursuant to subsection (2) of this section shall oversee the~~
25 ~~operations of the institute, including contracting through the department~~
26 ~~of higher education with the host institution and annually selecting~~
27 ~~students to participate in the institute.~~

1 ~~(2) (a) The executive board consists of eleven members as~~
2 ~~follows:~~

3 ~~(f) The governor, with the consent of the senate, shall appoint~~
4 ~~eight persons to serve as members of the executive board as follows:~~

5 ~~(A) Two persons who are employed as educators in high schools~~
6 ~~in Colorado, one of whom is employed in a rural school district;~~

7 ~~(B) Two persons who are employed as teaching faculty or~~
8 ~~administrators in an institution of higher education in Colorado; and~~

9 ~~(C) Four persons from the community who have interest or~~
10 ~~experience in education; and~~

11 ~~(H) The commissioner of education or his or her designee, the~~
12 ~~executive director of the department of higher education or his or her~~
13 ~~designee, and the chief executive officer of the host institution or his or~~

15 ~~(b) The appointed members of the executive board serve two-year~~
16 ~~terms; except that the terms shall be staggered so that no more than four~~
17 ~~members' terms expire in the same year. Members may be appointed to~~
18 ~~successive two-year terms. The appointed members of the executive~~
19 ~~board serve at the pleasure of the governor. If a vacancy arises on the~~
20 ~~executive board, the governor shall appoint a person to fill the vacancy~~
21 ~~for the remainder of the term.~~

22 ~~(c) The members of the executive board serve without~~
23 ~~compensation and without reimbursement for expenses.~~

24 ~~(d) In making appointments, the governor shall attempt to appoint~~
25 ~~persons who are representative of the gender and racial diversity within~~
26 ~~the state and who represent areas throughout the state.~~

27 ~~(e) Repealed.~~

1 ~~(3)~~ (1) The ~~executive~~ STATE board OF EDUCATION WHEN
2 OPERATING THE STUDENT LEADERS INSTITUTE has the following duties and
3 powers:

4 ~~(a) The executive board shall~~ Oversee and direct the operations of
5 the institute; ~~including reviewing the student applications received,~~
6 ~~annually selecting students to participate in the institute, and annually~~
7 ~~selecting the faculty and courses for the institute, taking into account the~~
8 ~~recommendations of the host institution. In reviewing applications and~~
9 ~~selecting students to participate in the institute, the executive board shall~~
10 ensure that:

11 ~~(I) At least fifty percent of the students selected to attend the~~
12 ~~institute each year:~~

13 ~~(A) Are eligible for free or reduced-price lunch pursuant to the~~
14 ~~federal "Richard B. Russell National School Lunch Act", 42 U.S.C. sec.~~
15 ~~1751 et seq.; or~~

16 ~~(B) Would be the first generation in their immediate families to~~
17 ~~attend an institution of higher education;~~

18 ~~(H) The students who are selected reside in areas throughout the~~
19 ~~state; are representative of the gender, ethnic, racial, and socioeconomic~~
20 ~~diversity of the state; and are representative of the educational program~~
21 ~~options available throughout the state; and~~

22 ~~(HH) The students who are selected demonstrate, through their~~
23 ~~individual career and academic plans for students enrolled in public~~
24 ~~schools, a commitment to continuing in postsecondary education after~~
25 ~~high school graduation.~~

26 (b) (I) The department of ~~higher~~ education, on behalf of the
27 ~~executive~~ STATE board OF EDUCATION, shall issue a request for proposals

1 ~~for a public or private institution of higher education to host the institute.~~
2 ~~The department~~ working with the executive board, shall select and enter
3 into a contract on behalf of the executive board and the institute with the
4 public or private institution of higher education in accordance with the
5 applicable provisions of the "Procurement Code", articles 101 to 112 of
6 ~~title 24~~ FOLLOW THE APPLICABLE PROVISIONS OF THE "PROCUREMENT
7 CODE", ARTICLES 101 TO 112 OF TITLE 24, TO CHOOSE A HIGHER
8 EDUCATION INSTITUTION TO HOST THE INSTITUTE. The department may
9 enter into a multi-year contract with a public or private institution of
10 higher education, subject to annual review and renewal.

11 (II) The contract to host the institute must require the host
12 institution, at a minimum, to provide the following services in managing
13 the institute:

14 (A) Establish requirements for and create the form of the
15 applications that students submit to participate in the institute and
16 establish the timelines for submitting applications and selecting
17 participants;

18 (B) Review applications received from students and recommend
19 participants to the executive board; AND ANNUALLY SELECT STUDENTS TO
20 PARTICIPATE IN THE INSTITUTE. IN REVIEWING APPLICATIONS AND
21 SELECTING STUDENTS TO PARTICIPATE IN THE INSTITUTE, THE HOST
22 INSTITUTION MUST ENSURE THAT AT LEAST FIFTY PERCENT OF THE
23 STUDENTS SELECTED TO ATTEND THE INSTITUTE EACH YEAR ARE ELIGIBLE
24 FOR FREE OR REDUCED-PRICE LUNCH PURSUANT TO THE FEDERAL
25 "RICHARD B. RUSSELL NATIONAL SCHOOL LUNCH ACT", 42 U.S.C. SEC.
26 1751 ET SEQ., OR WOULD BE THE FIRST IN THEIR IMMEDIATE FAMILIES TO
27 ATTEND AN INSTITUTION OF HIGHER EDUCATION; THAT THE STUDENTS

1 WHO ARE SELECTED RESIDE IN AREAS THROUGHOUT THE STATE AND
2 REPRESENT GENDER, ETHNIC, RACIAL, AND SOCIOECONOMIC DIVERSITY OF
3 THE STATE; THAT THE STUDENTS REPRESENT THE EDUCATIONAL PROGRAM
4 OPTIONS AVAILABLE THROUGHOUT THE STATE; AND THAT THE STUDENTS
5 DEMONSTRATE THROUGH THEIR INDIVIDUAL CAREER AND ACADEMIC
6 PLANS A COMMITMENT TO CONTINUING POSTSECONDARY EDUCATION
7 AFTER HIGH SCHOOL GRADUATION.

8 (C) Annually solicit educators to participate as faculty for the
9 institute and annually ~~recommend to the executive board~~ SELECT faculty
10 and courses for the institute;

11 (D) Provide space for classes, lectures, and seminars; ~~and~~

12 (E) Provide living and eating facilities for students who
13 participate in the institute; AND

14 (F) COLLECT ANY NECESSARY DATA FOR THE REPORT AND
15 COMPILE IT AS REQUIRED UNDER SUBSECTION (1)(d) OF THIS SECTION.

16 (c) The ~~executive~~ STATE board OF EDUCATION may appoint an
17 advisory board consisting of persons in the community who are
18 supportive of education to assist the ~~executive~~ STATE board OF
19 EDUCATION AND HOST INSTITUTION in marketing the institute and
20 soliciting public and private gifts, grants, and donations for the institute.
21 Any persons appointed to an advisory board pursuant to this ~~subsection~~
22 ~~(3)(c)~~ SUBSECTION (1)(c) serve without compensation and without
23 reimbursement for expenses.

24 (d) Beginning in ~~the 2017 regular legislative session~~ 2024, the
25 ~~executive board~~ HOST INSTITUTION shall annually report to THE STATE
26 BOARD AND the education committees of the house of representatives and
27 the senate, or any successor committees, the ~~executive board's~~ HOST

1 INSTITUTION'S progress and success in implementing the institute. The
2 ~~executive board~~ HOST INSTITUTION must, at a minimum, report the success
3 of the institute as measured by the enrollment and progress of institute
4 alumni in postsecondary educational programs.

5 **22-106-105. [Formerly 23-77-105] Colorado student leaders**
6 **institute - funding - cash fund created.** (1) The general assembly shall
7 annually appropriate money to the department of ~~higher~~ education for the
8 institute to pay the direct and indirect costs that the ~~executive~~ STATE
9 board OF EDUCATION incurs in operating the institute, including costs
10 relating to the host institution and stipends for the institute faculty
11 members.

12 (2) (a) In addition to the amount appropriated pursuant to
13 subsection (1) of this section, the ~~executive~~ STATE board OF EDUCATION
14 ~~with the assistance of an advisory board if appointed,~~ may solicit, accept,
15 and expend public or private gifts, grants, or donations to implement the
16 institute. The ~~executive~~ STATE board OF EDUCATION shall transmit any
17 money that it receives pursuant to this subsection (2)(a) and any money
18 it receives from participating students to the state treasurer. The state
19 treasurer shall deposit the money in the Colorado student leaders institute
20 cash fund, referred to in this section as the "cash fund", which is created
21 in the state treasury. Annual operation of the institute is conditional upon
22 receiving at least forty thousand dollars in gifts, grants, or donations by
23 June 1 of each year.

24 (b) The money in the cash fund is continuously appropriated to the
25 ~~executive~~ STATE board OF EDUCATION for the direct and indirect costs
26 incurred in implementing the institute. The state treasurer may invest as
27 provided by law any money in the cash fund that is not expended for the

1 purposes of this ~~article 77~~ ARTICLE 106. The state treasurer shall credit to
2 the cash fund all interest and income derived from the investment and
3 deposit of money in the cash fund. Any unexpended and unencumbered
4 money remaining in the cash fund at the end of a fiscal year ~~must remain~~
5 REMAINS in the cash fund and ~~shall~~ IS not ~~be~~ credited to another fund.
6 ~~except that the state treasurer shall credit any unexpended and~~
7 ~~unencumbered money remaining in the fund as of June 30, 2024, to the~~
8 ~~state education fund created in section 17 (4) of article IX of the state~~
9 ~~constitution.~~

10 **SECTION 2. Repeal of relocated and nonrelocated provisions**
11 **in this act.** In Colorado Revised Statutes, **repeal** article 77 of title 23;
12 except that 23-77-106 is not relocated.

13 **SECTION 3. Safety clause.** The general assembly hereby finds,
14 determines, and declares that this act is necessary for the immediate
15 preservation of the public peace, health, or safety.
