# A BILL FOR AN ACT

#### 101 CONCERNING AN APPROPRIATION FOR SPECIES CONSERVATION TRUST

102 FUND PROJECTS.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill appropriates \$5 million from the species conservation trust fund for programs submitted by the executive director of the department of natural resources that are designed to conserve native species that state or federal law lists as threatened or endangered or that are candidate species or are likely to become candidate species for such listing as determined by the United States fish and wildlife service, allocated as





follows:

- \$750,000 for native terrestrial wildlife conservation;
- \$1,500,000 for native aquatic wildlife conservation;
- \$2,200,000 for the upper Colorado river endangered fish recovery program and the San Juan river basin recovery implementation program;
- \$50,000 for selenium management, research, monitoring, evaluation, and control; and
- \$500,000 for the federal endangered species act litigation program.

1 Be it enacted by the General Assembly of the State of Colorado:

2 SECTION 1. Legislative declaration. (1) The general assembly
3 hereby finds and declares that:

4 (a) Section 24-33-111 (2), Colorado Revised Statutes, creates the
5 species conservation trust fund in the state treasury to fund programs
6 designed to conserve native species that have been listed as threatened or
7 endangered under state or federal law or that are candidate species or are
8 likely to become candidate species as determined by the United States
9 fish and wildlife service;

(b) Pursuant to section 24-33-111 (3), Colorado Revised Statutes:

(I) The executive director of the department of natural resources, after consulting with the Colorado water conservation board and its director, the parks and wildlife commission, and the director of the division of parks and wildlife, has prepared and delivered to the general assembly a species conservation eligibility list describing programs and associated costs that are eligible to receive funding from the species conservation trust fund; and

(II) Before obligating funds from the species conservation trust
fund, the species conservation eligibility list is subject to modification
and adoption through the passage of a bill.
