A BILL FOR AN ACT

101	CONCERNING THE CREATION OF A SPECIAL LICENSE PLATE TO
102	COMMEMORATE THE STEGOSAURUS AS THE COLORADO STATE
103	FOSSIL.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill creates the stegosaurus state fossil license plate for motor vehicles. The department of revenue must designate a nonprofit organization to qualify applicants for issuance of the license plate. The organization must:

• Be headquartered in Colorado;

- Have been in existence for at least 5 years;
- Be a nonprofit organization;
- Provide educational services about the science and history of dinosaurs, dinosaur fossils, and related paleontology sites in the state;
- Support the stewardship and preservation of dinosaur fossils, tracks, and other natural resources;
- Manage land and paleontology sites that are registered as part of a national natural landmark; and
- Have been conducting preservation, stewardship, and management of dinosaur fossils, dinosaur tracks, paleontology sites, and other natural resources for at least 5 years.

An applicant qualifies for issuance of the license plate if the applicant makes a donation to the organization and pays all required taxes and fees. In addition to the standard motor vehicle fees, the applicant must pay 2 one-time fees of \$25 for issuance of the license plate. One fee is credited to the highway users tax fund and the other fee is credited to the licensing services cash fund.

14	42-3-260 to 42-3-265, AND SECTION 42-3-267 shall pay an issuance fee
15	of twenty-five dollars; except that the fee is not imposed on special
16	license plates exempted from additional fees for the issuance of a military
17	special license plate by section 42-3-213 (1)(b)(II). The department shall
18	transfer the fee to the state treasurer, who shall credit it to the Colorado
19	DRIVES vehicle services account created in section 42-1-211 (2).
20	SECTION 3. Act subject to petition - effective date. This act
21	takes effect at 12:01 a.m. on the day following the expiration of the
22	ninety-day period after final adjournment of the general assembly; except
23	that, if a referendum petition is filed pursuant to section 1 (3) of article V
24	of the state constitution against this act or an item, section, or part of this
25	act within such period, then the act, item, section, or part will not take
26	effect unless approved by the people at the general election to be held in
