# A BILL FOR AN ACT

#### 101 CONCERNING A JOINT LEGISLATIVE COMMITTEE MEETING ABOUT A

102 DISASTER EMERGENCY DECLARATION BY THE GOVERNOR.

#### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under existing law, the executive committee of the legislative council and the joint budget committee (committees) must hold a joint meeting in March, August, and December if there has been a declaration of a disaster emergency by the governor since the first day of the month for the last required meeting.

The bill eliminates the requirement that the committees meet

during those months. Instead, the committees are required to meet upon a written request of a majority of the members of the committees if there has been a disaster declaration by the governor since the last meeting.

Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1801, amend (2) 3 as follows: 4 2-3-1801. Legislative committees to receive information from 5 the executive branch during a declared disaster emergency -6 definition. (2) Each year, The committees shall hold a joint meeting 7 during the months of March, August, and December IF ANY MEMBER OF 8 THE COMMITTEES SUBMITS A WRITTEN REQUEST TO HOLD A JOINT MEETING 9 TO THE CHAIRS OF THE COMMITTEES AND THE GOVERNOR AND if there has 10 been a declaration of a disaster emergency by the governor under section 11 24-33.5-704 (4), or any successor section, since the first day of the month 12 for the last required OF THE LAST meeting. With respect to any joint 13 meeting of the committees, the requirement to meet may be waived if 14 such waiver is submitted in writing by not less than a majority of the 15 membership of the committees. <u>A REQUEST FOR A JOINT MEETING MADE</u> 16 PURSUANT TO THIS SECTION MAY BE WAIVED BY AN AFFIRMATIVE VOTE OF 17 AT LEAST TWO-THIRDS OF THE TOTAL MEMBERSHIP OF THE COMMITTEES. 18 **SECTION 2.** Safety clause. The general assembly hereby finds, 19 determines, and declares that this act is necessary for the immediate 20 preservation of the public peace, health, or safety.
