A BILL FOR AN ACT

101	CONCERNING INCREASES IN THE AMOUNT OF TRANSFERS FROM THE
102	GENERAL FUND TO THE CAPITAL CONSTRUCTION FUND TO BE
103	MADE ON JULY 1, 2023.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov/.)

Joint Budget Committee. The bill increases the amounts of transfers from the general fund to the capital construction fund and from the general fund to the information technology capital account of the capital construction fund that are scheduled to be made on July 1, 2023, as follows:

- The transfer from the general fund to the capital construction fund is increased by \$14,607,257, from \$233,361,030 to \$247,968,287; and
- The transfer from the general fund to the information technology capital account of the capital construction fund is increased by \$3,605,507, from \$60,308,481 to \$63,913,988.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 24-75-302, amend as added by Senate Bill 23-243 (2)(ss) and (2.3)(o) as follows:

24-75-302. Capital construction fund - capital assessment fees - calculation - information technology capital account. (2) The controller shall transfer a sum as specified in this subsection (2) from the general fund to the capital construction fund as money becomes available in the general fund during the fiscal year beginning on July 1 of the fiscal year in which the transfer is made or on the date otherwise specified for the transfer. Transfers between funds pursuant to this subsection (2) are not appropriations subject to the limitations of section 24-75-201.1. The amounts transferred pursuant to this subsection (2) are as follows:

- (ss) On July 1, 2023, two hundred thirty-three million three hundred sixty-one thousand thirty FORTY-SEVEN MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND TWO HUNDRED EIGHTY-SEVEN dollars;
- (2.3) In addition to the sums transferred pursuant to subsections (2) and (2.5) of this section, the state treasurer and the controller shall transfer a sum as specified in this subsection (2.3) from the general fund to the information technology capital account created in subsection (3.7) of this section as money becomes available in the general fund during the fiscal year beginning on July 1 of the fiscal year in which the transfer is made or on April 1 of the fiscal year if otherwise specified.
