Summary of Legislation

Medicaid patients are currently required to pay a copayment for pharmacy and outpatient services. The bill removes this requirement.

State Expenditures

The bill increases state expenditures in the Department of Health Care Policy and Financing by \$7,345,507 in FY 2023-24 and ongoing, paid from the General Fund, the Health Care Affordability and Sustainability Cash Fund, and federal funds. The department will remove the copayment on the affected services and increase the corresponding rates to account for the decrease in provider payments.

Effective Date

The bill was signed into law by the Governor and took effect on April 20, 2023.

State Appropriations

For FY 2023-24, the bill requires and includes an appropriation of \$7,345,507 to the Department of Health Care Policy and Financing from the following sources:

- \$1,439,499 from the General Fund;
- \$446,651 from the Health Care Affordability and Sustainability Cash Fund; and
- \$5,459,357 from federal funds.
