1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Appropriation.** For the 2023-24 state fiscal year,
3 \$87,910 is appropriated to the department of treasury for use by the
4 administration division. This appropriation is from the general fund and
5 is based on an assumption that the department will require an additional
6 1.0 FTE. To implement this act, the division may use this appropriation
7 for personal services.

8 **SECTION 2. Safety clause.** The general assembly finds,
9 determines, and declares that this act is necessary for the immediate
10 preservation of the public peace, health, or safety or for appropriations for
11 the support and maintenance of the departments of the state and state
12 institutions.
