**Bill Summary**

**Sunset Process - House Health and Human Services Committee.** The senior dental advisory committee created in the department of health care policy and financing is scheduled to repeal on September 1, 2024. Pursuant to the recommendation in the department of regulatory agencies' sunset review and report, the bill continues the senior dental advisory committee indefinitely.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
3 **(15)(a)(IV); and add (20)(a)(V)** as follows:

4           **2-3-1203. Sunset review of advisory committees - legislative**  
5 **declaration - definition - repeal.** (15) (a) The following statutory  
6 authorizations for the designated advisory committees are scheduled for  
7 repeal on September 1, 2024:

10           (20) (a) The following statutory authorizations for the designated  
11 advisory committees will repeal on September 1, 2029:

14           **SECTION 2.** In Colorado Revised Statutes, 25.5-3-406, **amend**  
15 **(3)(a)** as follows:

16           **25.5-3-406. Senior dental advisory committee - creation -**  
17 **duties - repeal.** (3) (a) This section is repealed, effective ~~September 1,~~  
18 ~~2024~~ **SEPTEMBER 1, 2029.**

19           **SECTION 3. Act subject to petition - effective date.** This act  
20 takes effect at 12:01 a.m. on the day following the expiration of the  
21 ninety-day period after final adjournment of the general assembly; except  
22 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
23 of the state constitution against this act or an item, section, or part of this  
24 act within such period, then the act, item, section, or part will not take  
25 effect unless approved by the people at the general election to be held in

- 1 November 2024 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
