Current Appropriations Clause in Bill

The bill includes an appropriation clause that appropriates \$64,738 General Fund to the Behavioral Health Administration. The clause does not correctly reference that the Behavioral Health Administration is within the Department of Human Services.

Description of Amendments in This Packet

J.002 Staff has prepared amendment **J.002** (attached) to make technical corrections to the existing appropriations clause to indicate that the appropriation is to the Behavioral Health Administration within the Department of Human Services.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

This bill requires a General Fund appropriation of \$64,738 for FY 2024-25, reducing the \$93.5 million set aside by the same amount.
