Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$59,443 to the Department of Revenue for FY 2024-25.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund appropriation of \$59,443 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.

Potential Technical Issue

Legislative Council Staff and Joint Budget Committee Staff assume that the implementation of the temporary income tax rate reductions in this bill will not impact revenue collections and diversions for the Health School Meals for All Program in the Department of Education (which is supported by limitations on income tax deductions for certain taxpayers). Staff is inquiring with the Department of Revenue to verify that the Department's implementation of the bill will not impact deposits for that program.
