A BILL FOR AN ACT

101 **CONCERNING SUSPENDING LEGISLATIVE INTERIM ACTIVITIES, AND, IN**
102 **CONNECTION THEREWITH, REDUCING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://leg.colorado.gov>.)

Executive Committee of the Legislative Council. The bill suspends legislative interim committee activities during the 2025 legislative interim (interim). Specifically, the bill:

- Prohibits the legislative council of the general assembly from prioritizing any requests for interim committees, including task forces, for the interim;

- Limits the Colorado youth advisory council review committee (committee) to meeting once in the 2025 interim, to receive the report from the youth advisory council (council), prohibits the committee and council from meeting or presenting bills in the 2026 interim, and precludes the council from contracting with a nonprofit organization to provide services for the council in the 2025-26 and 2026-27 fiscal years;
- Prohibits meetings, field trips, and legislative recommendations and reports by, and suspends for one year certain reports required to be submitted to, existing interim committees, including the legislative emergency preparedness, response, and recovery committee; legislative oversight committee for Colorado jail standards; statewide health care review committee; Colorado health insurance exchange oversight committee; opioid and other substance use disorders study committee; legislative oversight committee concerning the treatment of persons with behavioral health disorders in the criminal and juvenile justice systems; pension review commission and pension review subcommittee; legislative oversight committee concerning tax policy; and sales and use tax simplification task force.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-303.3, **add** (3)(e)
 3 and (3)(f) as follows:

4 **2-3-303.3. Interim committees - repeal.**

5 (3) (e) (I) NOTWITHSTANDING ANY PROVISION OF THIS SECTION, THE
 6 LEGISLATIVE COUNCIL SHALL NOT PRIORITIZE ANY INTERIM COMMITTEES
 7 OR APPROVE ANY TASK FORCES FOR THE 2025 INTERIM. NOTHING IN THIS
 8 SUBSECTION (3)(e) PROHIBITS THE EXECUTIVE COMMITTEE OF THE
 9 LEGISLATIVE COUNCIL, WHETHER BEFORE OR AFTER THE GENERAL
 10 ASSEMBLY HAS ADJOURNED, FROM APPROVING AN INTERIM COMMITTEE BY
 11 RESOLUTION FOR THE 2025 INTERIM IN THE MANNER SPECIFIED IN
 12 SUBSECTION (3)(c) OF THIS SECTION.

1 (II) THIS SUBSECTION (3)(e) IS REPEALED, EFFECTIVE JULY 1, 2026.

10 **2-2-1303. Membership - selection - terms.**

11 (2) (a) Nonlegislative council members shall be appointed as follows:

12 (III) (A) On or before August 31 of each year, EXCEPT FOR
13 AUGUST 31, 2025, the council members shall approve subsequent
14 appointments to the council. A youth who meets the criteria set forth in
15 subsection (1) of this section may apply to the council to be considered
16 for participation in the council.

17 **SECTION 3.** In Colorado Revised Statutes, 2-2-1304, **amend**
18 (2)(b) and (4)(a) as follows:

19 **2-2-1304. Duties - meetings - community outreach -**
20 **designation of organization to accept donations - authority to**
21 **contract - repeal.** (2) (b) (I) The council shall meet at least four times
22 each year, with two meetings occurring during the regular legislative
23 session and two meetings occurring after the regular legislative session
24 has concluded. Council members may attend and participate in council
25 meetings remotely, but at least two of the council's meetings each year
26 must be held in person, with all attending members at the same physical
27 location. Additional meetings may be held at the discretion of council

1 leadership, subject to available money.

10 conjunction with the director of the legislative council, use a request for
11 proposal process to contract with and designate one or more nonprofit
12 organizations to provide staffing and operational assistance and to serve
13 as the custodian of money donated to the council through the designated
14 organization. The contractor selected following the 2019 request for
15 proposal process shall, pursuant to one or more contracts, provide such
16 staffing, operational, and custodian services through June 30, 2023.
17 Thereafter, the council shall, in conjunction with the director of the
18 legislative council, on or before April 30, 2023, and, except as otherwise
19 provided in this subsection (4)(a), on or before every second April 15
20 thereafter, use a request for proposal process to contract with and
21 designate one or more nonprofit organizations to provide such staffing,
22 operational, and custodian services. The term of each contract entered
23 into for a term commencing on or after July 1, 2023, is two state fiscal
24 years; except that any such contract may be extended for one additional
25 two-year term. If a contract is extended, the request for proposal for the
26 next contract must be issued on or before the April 15 immediately
27 preceding the expiration of the extension term. The designated

1 organization shall not be the custodian of any money appropriated by the
2 state and credited to the fund created in section 2-2-1306. The designated
3 organization is authorized to expend any money it receives as is necessary
4 for the operation of the council and may solicit and accept monetary and
5 in-kind gifts, grants, and donations used to further the council's duties and
6 responsibilities. Any money donated or awarded to the designated
7 organization for the benefit of the council is not subject to appropriation
8 by the general assembly. Any money obtained by the council or the
9 designated organization ~~and~~ THAT IS not in the fund AND that is
10 unexpended and unencumbered at the time the council is dissolved shall
11 be distributed according to appropriate federal and state laws governing
12 nonprofit organizations. If a different nonprofit or private organization is
13 subsequently designated as the custodian of donated money in accordance
14 with this ~~paragraph (a)~~ SUBSECTION (4)(a)(I), any money that is
15 unexpended and unencumbered at the time of the change in designation
16 shall be promptly transferred by the previously designated organization
17 to the newly designated organization.

10 cooperate and coordinate with the division, the department, and the
11 GEEERC in developing the plan. The legislative committee shall develop

22 TRIPS DURING THE 2025 INTERIM.

23 **SECTION 16. Appropriation - adjustments to 2025 legislative**
24 **appropriation bill.** (1) To implement this act, the total and general fund
25 appropriations made to the legislative department in Senate Bill 25-188
26 for the 2025-26 state fiscal year are decreased by 292,488 as follows:

27 (a) The total and general fund appropriations for use by the general

1 assembly are decreased by \$71,948;

2 (b) The total and general fund appropriations for use by the
3 legislative council are decreased by 124,294 and the related FTE is
4 decreased by 1.6 FTE; and

5 (c) The general fund appropriation for use by the committee on
6 legal services is decreased by \$96,246, and the related FTE is decreased
7 by 1.3 FTE.

8 **SECTION 17. Safety clause.** The general assembly finds,
9 determines, and declares that this act is necessary for the immediate
10 preservation of the public peace, health, or safety or for appropriations for
11 the support and maintenance of the departments of the state and state
12 institutions.
