HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

HB22-1242 be amended as follows:

- 1 Amend printed bill, page 5, strike lines 17 and 18 and substitute "a  
2 factory or WORK PERFORMED OFF SITE OR WORK completed at a THE  
3 INSTALLATION site, **using**".
- 4 Page 7, line 20, strike "the first" and substitute "~~the first~~ A".
- 5 Page 9, strike line 2 and substitute "(1)(e), (1)(f), and (1)(g); and **add**  
6 (1)(h) as follows:".
- 7 Page 9, strike line 11 and substitute "**and**  
8 (g) To enforce requirements concerning the safety of hotels,  
9 motels, and multi-family structures in areas of the state where no  
10 construction standards for hotels, motels, and multi-family structures  
11 exist; AND  
12 (h) TO ENFORCE REQUIREMENTS CONCERNING THE SAFETY OF  
13 FOUNDATION SYSTEMS FOR MANUFACTURED HOMES, TINY HOMES, AND  
14 FACTORY-BUILT STRUCTURES IN AREAS OF THE STATE WHERE NO  
15 CONSTRUCTION STANDARDS FOR MANUFACTURED HOMES, TINY HOMES,  
16 AND FACTORY-BUILT STRUCTURES EXIST."
- 17 Page 9, line 23, strike "FACTORY-BUILT STRUCTURES" and substitute  
18 "MANUFACTURED HOMES, FACTORY-BUILT STRUCTURES,".
- 19 Page 21, strike lines 17 through 20 and substitute "a manufactured home  
20 ~~built in a factory and components shipped with the manufactured home~~  
21 ~~as reflected in the approved plans for the manufactured home~~ OR OF A  
22 TINY HOME. The certificate of installation must include ~~but not~~".
- 23 Page 24, line 13, strike "24-32-3329 (2)," and substitute "24-32-3329,".
- 24 Page 24, line 20, strike "HOMES OR mobile" and substitute HOMES, mobile  
25 HOMES,".
- 26 Page 33, strike lines 8 through 12 and substitute "**connection to utilities**  
27 **- rules.** (1) A STATE ELECTRICAL INSPECTOR OR A LOCAL GOVERNMENT".
- 28 Page 33, line 16, strike "(b)" and substitute "(2)".

1 Page 33, strike lines 21 and 22 and substitute:

2 "SECTION 24. In Colorado Revised Statutes, **amend**  
3 24-32-904.5 as follows:".

4 Page 34, after line 4 insert:

5 "(b) Any new recreational park trailer that is not manufactured in  
6 compliance with the American national standards institute's (ANSI's)  
7 standard A 119.5 for recreational park trailers, OR ANY SUCCESSOR  
8 STANDARD OR AMENDMENT.".

9 Page 35, line 14, strike "24-32-3329 (2)." and substitute "24-32-3329.".
