Today in Committee - HJR22-1022 Honoring Those Impacted By COVID-19 Policy

I wish I could testify to this. However, in good conscience I cannot. After consideration, what did happen to Coloradoans was so destructive and wrong, at least written testimony for comments is needed.

We were fortunate, through good business practices and life choices - we did not financially suffer; other destructive experiences - absolutely. Time and again I assured my Wife there were state and federal constitutional checks and balances to prevent more than 30 days of the tyranny we had begun to warn people was coming – before this began to happen. More than two years into the longest two weeks in history (which we predicted), I could not have been more wrong and regretful.

Instead, our legislature failed us. Our Congress failed us. Our judicial system failed us. All still do. Look at the bills killed and cases tossed out. All have zero of our trust or faith.

What did happen was to our grandchildren in school, and our daughters sent home from work - until their medical and dental bosses quickly said no more. Thankfully Weld County stood up and said NO.

What did happen to us is my dad was fired by his pulmonologist and cardiologist - and we fired his primary care physician for our own and medical freedom. All because it was political policy over patient.

What did happen to us is our Mom was first denied being seen at an urgent care, until I forced their hand. They then hospitalized her with 'COVID' and a promise she would go home with the oxygen she needed that night. Instead she was immediately given the Remdesivir poison, and denied proven alternatives. I was denied seeing her until a doctor finally said she cannot die alone - five days later (they repeatedly told us she had to make it past five days to know if she had any chance). I held her for 12 hours to her death, then escorted her to the hospital morgue. I held her for all the others in our family who could not and made sure she talked to everyone. Then I told her it was okay, and said goodbye. November 20, 2022. Just short months from seeing various truths begin to be exposed. She's scared to go, she was scared she would never leave. She was scared. She looked me, scared and for something. Then they promised us - her - it was just to get oxygen and go home. My Wife made the room she always stayed in so she could. They killed her. All of this killed her. In government programs (including 20% bill bonus for giving the poison Remdesivir) - 100% pure profit - the hospital made \$68K; in addition to their \$80K bill.

What did happen is my dad was hospitalized for 'COVID' less than three months after. At the same hospital, and they tried to deny me the authority as Medical Power of Attorney to prohibit them from giving him the poison Remdesivir. After I forced their hand, they said the protocol is no longer used. They immediately discharged him to medical rehab with oxygen and antibiotics. His age and health, much worse than Mom's. He was there 2.5 weeks and is fine. There was no profit to his hospitalization. His admitting forms did not have 'COVID' in big letters for the financial responsibility signature block - like Mom's did.

What did happen, shortly after, is my Wife became seriously ill - so much so I was scared, for the first time, and cried each trip I made to find natural solutions she had researched because of Mom's death. We would never trust the medical community again. A telemedicine MD did diagnose her as likely 'COVID'. His treatment? Bed rest, chicken soup and honey 100% truth). It took a week, and her strength and determination overcame a bad case of the same flu millions were misdiagnosed for and died. Many millions lost what can never be recovered.

None of this can be apologized for or forgiven. Ever. That, at best, would be my testimony. If it was a politician or 'official' handing out more tyranny, it was as many doing nothing. This resolution, at election time, is meaningless - in words and reality. The person occupying the governor's mansion - our house - should have been impeached long ago.

Instead, this will pass and be delivered to him to be all shits and giggles about, while he does something different and as pandering for the media at a press conference.

No thanks, and I am being very kind here.

What you can do, is arrange a personal one-on-one very public and media covered meeting with him, so we can personally tell him. Do that, and you can have my testimony.

Tyranny is terrorism. It is what happened and is still happening. It cannot be apologized for or forgiven. Not on any day, and certainly not election time.
