SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB21-085 be amended as follows:

- 1 Amend printed bill, page 2, line 5, strike "**party.**" and substitute "**party**
- 2 **- definition - rules.**".

- 3 Page 2, strike line 7 and substitute "AN ACTUARY THAT HAS EXPERIENCE
- 4 WITH HEALTH CARE POLICY, EQUITY, AND".

- 5 Page 2, line 11, strike "PLANS." and substitute "PLANS OR REDUCE OR
- 6 ELIMINATE MANDATED COVERAGE UNDER HEALTH BENEFIT PLANS."

- 7 Page 2, line 15, strike "ASSEMBLY." and substitute "ASSEMBLY WHO IS
- 8 PROPOSING THE LEGISLATION."

- 9 Page 3, after line 5 insert:
- 10 "(b) A MEMBER OF THE GENERAL ASSEMBLY WHO REQUESTS AN
- 11 ACTUARIAL REVIEW OF PROPOSED LEGISLATION SHALL SUBMIT THE
- 12 REQUEST TO THE DIVISION BEFORE SEPTEMBER 1 OF THE YEAR PRECEDING
- 13 THE REGULAR LEGISLATIVE SESSION FOR WHICH THE LEGISLATION IS
- 14 PROPOSED."

- 15 Reletter succeeding paragraphs accordingly.

- 16 Page 3, line 17, strike "LEGISLATION;" and substitute "LEGISLATION,
- 17 INCLUDING INFORMATION CONCERNING WHO WOULD BENEFIT FROM THE
- 18 CHANGES, WHICH INFORMATION, IF AVAILABLE, MUST BE DISAGGREGATED,
- 19 AT A MINIMUM, BY RACE, ETHNICITY, SEX, GENDER, AND AGE;"

- 20 Page 3, line 22, after "INCREASE" insert "OR DECREASE".

- 21 Page 4, strike lines 1 through 11.

- 22 Renumber succeeding subparagraphs accordingly.

- 23 Page 4, line 14, strike "AND".

- 24 Page 4, line 17, strike "LEGISLATION." and substitute "LEGISLATION,
- 25 INCLUDING INFORMATION CONCERNING WHO WOULD BENEFIT FROM THE
- 26 CHANGES, WHICH INFORMATION, IF AVAILABLE, MUST BE DISAGGREGATED,
- 27 AT A MINIMUM, BY RACE, ETHNICITY, SEX, GENDER, AND AGE;
- 28 (VIII) INFORMATION, IF AVAILABLE, CONCERNING ANY
- 29 DISPROPORTIONATE EFFECTS THAT THE PROPOSED LEGISLATION MAY HAVE
- 30 ON CONSUMERS AS A RESULT OF THEIR RACE, ETHNICITY, SEX, GENDER, OR

1 AGE; AND
2 (IX) AN ESTIMATE OF THE OUT-OF-POCKET HEALTH CARE SAVINGS
3 ASSOCIATED WITH ANY NEW HEALTH BENEFIT OR SERVICE DESCRIBED IN
4 THE PROPOSED LEGISLATION, INCLUDING INFORMATION CONCERNING WHO
5 WOULD BENEFIT FROM THE CHANGES, WHICH INFORMATION, IF AVAILABLE,
6 MUST BE DISAGGREGATED, AT A MINIMUM, BY RACE, ETHNICITY, SEX,
7 GENDER, AND AGE."

8 Page 4, line 21, strike "(1)(b)(IV)" and substitute "(1)(c)(IV)".

9 Page 4, strike line 24 and substitute "(1)(c)(V) AND (1)(c)(VI) OF THIS
10 SECTION IN".

11 Page 5, line 7, strike "PLANS," and substitute "PLANS OR REDUCE OR
12 ELIMINATE MANDATED COVERAGE UNDER HEALTH BENEFIT PLANS,".

13 Page 5, after line 18 insert:

14 "(4) A REQUEST FOR AN ACTUARIAL REVIEW AND ANY
15 INFORMATION SUBMITTED TO THE CONTRACTOR FOR THE PURPOSE OF
16 COMPLETING AN ACTUARIAL REVIEW PURSUANT TO SUBSECTION (1)(a) OF
17 THIS SECTION IS WORK PRODUCT, AS DEFINED IN SECTION 24-72-202 (6.5).

18 (5) AS USED IN THIS SECTION, "HEALTH BENEFIT PLAN" EXCLUDES
19 PLANS AND BENEFITS PROVIDED PURSUANT TO MEDICAID OR THE
20 "CHILDREN'S BASIC HEALTH PLAN ACT", ARTICLE 8 OF TITLE 25.5.

21 (6) THE COMMISSIONER MAY PROMULGATE RULES AS NECESSARY
22 FOR THE IMPLEMENTATION OF THIS SECTION."

23 Page 5, line 23, strike "PLANS," and substitute "PLANS OR REDUCE OR
24 ELIMINATE MANDATED COVERAGE UNDER HEALTH BENEFIT PLANS,".

25 Page 7, after line 13 insert:

26 "SECTION 4. In Colorado Revised Statutes, 10-16-102, **add**
27 (32)(d) as follows:

28 **10-16-102. Definitions.** As used in this article 16, unless the
29 context otherwise requires:

30 (32) (d) SOLELY WITH RESPECT TO SECTION 10-16-154, "HEALTH
31 BENEFIT PLAN" EXCLUDES PLANS AND BENEFITS PROVIDED PURSUANT TO
32 MEDICAID OR THE "CHILDREN'S BASIC HEALTH PLAN ACT", ARTICLE 8 OF
33 TITLE 25.5."
