HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB21-1258 be amended as follows:

- 1 Amend printed bill, page 4, strike lines 12 though 16 and substitute:
 - 2 "(c) "PROVIDER" MEANS A LICENSED PSYCHIATRIST REGULATED
 - 3 PURSUANT TO ARTICLE 240 OF TITLE 12 OR ANY OF THE FOLLOWING
 - 4 LICENSEES OR CANDIDATES REGULATED PURSUANT TO ARTICLE 245 OF
 - 5 TITLE 12: A LICENSED PSYCHOLOGIST OR PSYCHOLOGIST CANDIDATE;
 - 6 LICENSED SOCIAL WORKER, LICENSED CLINICAL SOCIAL WORKER, OR
 - 7 CLINICAL SOCIAL WORKER CANDIDATE; LICENSED MARRIAGE AND FAMILY
 - 8 THERAPIST OR MARRIAGE AND FAMILY THERAPIST CANDIDATE; LICENSED
 - 9 PROFESSIONAL COUNSELOR OR LICENSED PROFESSIONAL COUNSELOR
 - 10 CANDIDATE; OR LICENSED ADDICTION COUNSELOR OR ADDICTION
 - 11 COUNSELOR CANDIDATE."
- 12 Page 5, line 5, strike "THE FULL COST OF".
- 13 Page 5, line 7, strike "PATIENT;" and substitute "CLIENT;".
- 14 Page 5, line 12, strike "PATIENT." and substitute "CLIENT.".
- 15 Page 5, line 13, strike "PATIENT" and substitute "CLIENT".
- 16 Page 5, line 14, strike "PATIENT" and substitute "CLIENT".
- 17 Page 5, line 22, strike "PATIENT" and substitute "CLIENT".
- 18 Page 5, line 23, strike "PROGRAM;" and substitute "PROGRAM, WHICH RATE
- 19 MUST BE THE SAME REGARDLESS OF WHETHER THE APPOINTMENT IS A
- 20 TELEHEALTH OR IN-PERSON APPOINTMENT;".
- 21 Page 6, line 7, strike "MAY 31," and substitute "JULY 1,".
- 22 Page 6, line 17, strike "CONNECT" and substitute "WHEN POSSIBLE,
- 23 CONNECT".
- 24 Page 6, line 22, strike "IN-PERSON OR".
- 25 Page 6, line 23, after the period insert "AN IN-PERSON APPOINTMENT MAY
- 26 BE PROVIDED IF AND WHEN AVAILABLE.".
