HB21-1162 be amended as follows:

- 1 Amend reengrossed bill, page 2, after line 2 insert:
 - 2 "SECTION 1. In Colorado Revised Statutes, **repeal** 25-17-104
 - 3 as follows:
 - 4 **25-17-104. Local government preemption.** ~~No unit of local~~
 - 5 ~~government shall require or prohibit the use or sale of specific types of~~
 - 6 ~~plastic materials or products or restrict or mandate containers, packaging,~~
 - 7 ~~or labeling for any consumer products."~~
- 8 Renumber succeeding sections accordingly.
- 9 Page 6, strike lines 9 and 10.
- 10 Renumber succeeding subsections accordingly.
- 11 Page 7, line 2, strike "SEPTEMBER 1, 2022," and substitute "JANUARY 1,
- 12 2024,".
- 13 Page 7, line 12, strike "MARCH 31, 2023," and substitute "JUNE 1, 2024,".
- 14 Page 7, line 14, strike "SEPTEMBER 1, 2022." and substitute "JANUARY 1,
- 15 2024.".
- 16 Page 7, strike line 16 and substitute "2024.".
- 17 Page 7, strike lines 18 and 19 and substitute "(1) (a) ON AND AFTER
- 18 JANUARY 1, 2023, AND BEFORE JANUARY 1, 2024, A STORE MAY PROVIDE
- 19 A CUSTOMER WITH ONE OR MORE RECYCLED".
- 20 Page 8, strike lines 17 and 18 and substitute "2024.
- 21 (2) (a) ON AND AFTER JANUARY 1, 2024, A STORE MAY PROVIDE".
- 22 Page 9, strike lines 14 and 15 and substitute:
 - 23 "(c) (I) BEGINNING JANUARY 1, 2024, AND ENDING JUNE 1, 2024,
 - 24 A STORE MAY PROVIDE A CUSTOMER WITH A SINGLE-USE PLASTIC".
- 25 Page 9, line 22, strike "2023." and substitute "2024.".
- 26 Page 10, line 10, strike "JANUARY 1, 2022," and substitute "APRIL 1,
- 27 2024,".

- 1 Page 10, strike lines 25 through 27.
- 2 Page 11, strike lines 1 and 2.
- 3 Page 11, strike lines 4 and 5 and substitute "**containers.** (1) EXCEPT AS
4 PROVIDED IN SUBSECTION (2) OF THIS SECTION, EFFECTIVE JANUARY 1,
5 2024, A RETAIL FOOD".
- 6 Page 11, strike lines 9 through 19 and substitute:
- 7 "(2) IF A RETAIL FOOD ESTABLISHMENT PURCHASED EXPANDED
8 POLYSTYRENE PRODUCTS BEFORE JANUARY 1, 2024, THE RETAIL FOOD
9 ESTABLISHMENT MAY".
- 10 Page 11, strike lines 22 through 27 and substitute "FOOD IN THIS STATE
11 UNTIL THE INVENTORY IS DEPLETED."
- 12 Page 13, strike lines 8 through 12 and substitute:
- 13 "**SECTION 3. Effective date.** This act takes effect upon passage;
14 except that section 1 of this act takes effect July 1, 2024."
- 15 Page 1, line 101, strike "PRODUCTS, AND, IN" and substitute
16 "PRODUCTS."
- 17 Page 1, strike line 102.
