HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

SB21-087 be amended as follows:

- 1 Amend reengrossed bill, page 3, strike lines 6 through 8.
- 2 Reletter succeeding paragraphs accordingly.
- 3 Page 4, lines 4 and 5, strike "OR THE AGRICULTURAL EMPLOYEE'S
- 4 REPRESENTATIVE".
- 5 Page 4, strike lines 10 and 11 and substitute:
- 6 "(c) AN AGRICULTURAL EMPLOYEE, A PERSON WHO HAS A
- 7 FAMILIAL OR WORKPLACE RELATIONSHIP WITH THE AGRICULTURAL
- 8 EMPLOYEE, OR A PERSON WITH WHOM THE AGRICULTURAL EMPLOYEE
- 9 EXCHANGES CARE OR SUPPORT WHO HAS BEEN AGGRIEVED BY
- 10 RETALIATION BY A".
- 11 Page 4, strike lines 16 through 23 and substitute:
- 12 "(4) (a) IF A PERSON WHO HAS ENGAGED IN RETALIATION HAS
- 13 VIOLATED THIS SECTION OR HAS VIOLATED ARTICLE 3 OR 6 OF THIS TITLE
- 14 8, PART 2 OF ARTICLE 13.5 OF THIS TITLE 8, OR ARTICLE 14.4 OF THIS TITLE
- 15 8 IN A MANNER THAT HAS HARMED AN AGRICULTURAL EMPLOYEE, THE
- 16 DIRECTOR MAY COMMENCE AN ACTION IN DISTRICT COURT ON BEHALF OF
- 17 THE STATE OF COLORADO AGAINST THE PERSON WHO RETALIATED
- 18 AGAINST:
- 19 (I) AN AGRICULTURAL EMPLOYEE;
- 20 (II) A PERSON WHO HAS A FAMILIAL OR WORKPLACE RELATIONSHIP
- 21 WITH THE AGRICULTURAL EMPLOYEE; OR
- 22 (III) A PERSON WITH WHOM THE AGRICULTURAL EMPLOYEE
- 23 EXCHANGES CARE OR SUPPORT.
- 24 (b) THE DIRECTOR MAY SEEK AN ORDER".
- 25 Page 17, line 13, strike "(2)" and substitute "(2) (a)".
- 26 Page 17, line 14, strike "(a)" and substitute "(I)".
- 27 Page 17, line 16, strike "(b)" and substitute "(II)".
- 28 Page 17, line 18, strike "(c)" and substitute "(III)".
- 29 Page 17, after line 18 insert:
- 30 "(b) ANY AMOUNTS RECOVERED BY A WHISTLEBLOWER OR KEY
- 31 SERVICE PROVIDER PURSUANT TO THIS SECTION MUST BE DISTRIBUTED TO
- 32 AGRICULTURAL WORKERS AFFECTED BY THE VIOLATION WHO CAN BE
- 33 LOCATED, INSOFAR AS SUCH DISBURSEMENT IS ECONOMICALLY FEASIBLE."
