## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.HB19-1234 be amended as follows:

- 1 Amend printed bill, page 13, strikes line 9 through 13 and substitute "AND  
2 COUNTY UNLESS THE MUNICIPALITY, COUNTY, OR"
- 3 Page 13, line 22, strike "A".
- 4 Page 13, strike lines 23 through 27 and substitute :  
5 "(II) DELIVERY OF MEDICAL MARIJUANA OR MEDICAL  
6 MARIJUANA-INFUSED PRODUCTS MAY NOT CROSS THE JURISDICTIONAL  
7 BOUNDARIES OF THE MUNICIPALITY, COUNTY, CITY, OR CITY AND COUNTY  
8 WHERE THE ORIGINATING MEDICAL MARIJUANA CENTER IS LOCATED  
9 UNLESS THE MUNICIPALITY, COUNTY, CITY, OR CITY AND COUNTY ALLOWS  
10 DELIVERY FROM OUTSIDE ITS JURISDICTION."
- 11 Page 15, line 18, after the period, insert "A PERMIT APPLICANT IS  
12 PROHIBITED FROM DELIVERING RETAIL MARIJUANA AND RETAIL  
13 MARIJUANA PRODUCTS WITHOUT STATE AND LOCAL JURISDICTION  
14 APPROVAL. IF THE APPLICANT DOES NOT RECEIVE LOCAL JURISDICTION  
15 APPROVAL WITHIN ONE YEAR FROM THE DATE OF STATE LICENSING  
16 AUTHORITY APPROVAL, THE STATE PERMIT EXPIRES AND MAY NOT BE  
17 RENEWED. IF AN APPLICATION IS DENIED BY THE LOCAL LICENSING  
18 AUTHORITY, THE STATE LICENSING AUTHORITY SHALL REVOKE THE  
19 STATE-ISSUED PERMIT."
- 20 Page 19, line 23, strike "THAT".
- 21 Page 19, strike lines 24 through 27 and substitute "UNLESS THE  
22 MUNICIPALITY, COUNTY, OR".
- 23 Page 20, strike lines 10 through 14 and substitute "SECTION."  
24 "(II) DELIVERY OF RETAIL MARIJUANA OR RETAIL MARIJUANA  
25 PRODUCTS MAY NOT CROSS THE JURISDICTIONAL BOUNDARIES OF THE  
26 MUNICIPALITY, COUNTY, CITY, OR CITY AND COUNTY WHERE THE  
27 ORIGINATING MEDICAL MARIJUANA CENTER IS LOCATED UNLESS THE  
28 MUNICIPALITY, COUNTY, CITY, OR CITY AND COUNTY ALLOWS DELIVERY  
29 FROM OUTSIDE ITS JURISDICTION."
