HB19-1234 be amended as follows:

- 1 Amend printed bill, page 3, line 17, strike "VERIFICATION;" and substitute
- 2 "VERIFICATION, WHICH MUST BE SUBSTANTIALLY SIMILAR TO PROCEDURES
- 3 FOR MEDICAL MARIJUANA BUSINESSES;".

- 4 Page 3, before line 19, insert:
- 5 "(E) A REQUIREMENT THAT DELIVERY VEHICLES BE EQUIPPED WITH
- 6 SURVEILLANCE EQUIPMENT;".

- 7 Reletter succeeding sub-subparagraphs accordingly.

- 8 Page 3, line 19, strike "REQUIREMENTS;" and substitute "REQUIREMENTS,
- 9 WHICH MUST BE SUBSTANTIALLY SIMILAR TO RECORD-KEEPING
- 10 REQUIREMENTS FOR MEDICAL MARIJUANA BUSINESSES;"

- 11 Page 3, line 23, strike "REQUIREMENTS;" and substitute "REQUIREMENTS,
- 12 WHICH MUST INCLUDE REQUIREMENTS FOR INVENTORY TRACKING
- 13 SYSTEM-GENERATED TRANSPORT MANIFESTS;".

- 14 Page 5, line 20, strike "VERIFICATION;" and substitute "VERIFICATION,
- 15 WHICH MUST BE SUBSTANTIALLY SIMILAR TO PROCEDURES FOR RETAIL
- 16 MARIJUANA ESTABLISHMENTS;".

- 17 Page 5, before line 23, insert:
- 18 "(E) A REQUIREMENT THAT DELIVERY VEHICLES BE EQUIPPED WITH
- 19 SURVEILLANCE EQUIPMENT;".

- 20 Reletter succeeding sub-subparagraphs accordingly.

- 21 Page 5, line 23, strike "REQUIREMENTS;" and substitute "REQUIREMENTS,
- 22 WHICH MUST BE SUBSTANTIALLY SIMILAR TO RECORD-KEEPING
- 23 REQUIREMENTS FOR RETAIL MARIJUANA ESTABLISHMENTS;"

- 24 Page 5, line 27, strike "REQUIREMENTS;" and substitute "REQUIREMENTS,
- 25 WHICH MUST INCLUDE REQUIREMENTS FOR INVENTORY TRACKING
- 26 SYSTEM-GENERATED TRANSPORT MANIFESTS;".
