SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB19-166 be amended as follows:

- 1 Amend printed bill, page 2, line 4, strike "-revocation." and substitute
2 "-revocation - rules - definition."
- 3 Page 2, lines 15 and 16, strike "COMPARABLE ADMINISTRATIVE
4 INVESTIGATION;" and substitute "ADMINISTRATIVE INVESTIGATION AND
5 DISCIPLINARY PROCESS;"
- 6 Page 3, line 6, strike "AND".
- 7 Page 3, line 7, after "THAT" insert "ADMINISTRATIVE INVESTIGATION AND
8 DISCIPLINARY".
- 9 Page 3, line 14, strike "INVESTIGATION." and substitute:
10 "INVESTIGATION; AND
11 (C) THE CERTIFICATE HOLDER HAS ELECTED NOT TO EXERCISE, OR
12 HAS EXHAUSTED, THE INTERNAL DISCIPLINARY APPEAL RIGHTS PROVIDED
13 BY THE OFFICER'S EMPLOYER."
- 14 Page 4, lines 3 and 4, strike "COMPARABLE ADMINISTRATIVE
15 INVESTIGATION," and substitute "ADMINISTRATIVE INVESTIGATION AND
16 DISCIPLINARY PROCESS,"
- 17 Page 4, lines 23 and 24, strike "COMPARABLE ADMINISTRATIVE
18 INVESTIGATION," and substitute "ADMINISTRATIVE INVESTIGATION AND
19 DISCIPLINARY PROCESS,"
- 20 Page 5, line 7, strike "COMPARABLE ADMINISTRATIVE INVESTIGATION,"
21 and substitute "ADMINISTRATIVE INVESTIGATION AND DISCIPLINARY
22 PROCESS,"
- 23 Page 5, line 8, after "AGENCY" insert "EMPLOYING THE PEACE OFFICER, OR
24 THE LAST LAW ENFORCEMENT AGENCY TO EMPLOY THE PEACE OFFICER,"
- 25 Page 5, after line 16 insert:
26 "(i) FOR THE PURPOSES OF THIS SUBSECTION (2.5),
27 "ADMINISTRATIVE INVESTIGATION AND DISCIPLINARY PROCESS" MEANS AN
28 EMPLOYER'S FORMAL PROCESS OF INTERNAL CONTROL THAT ASSURES
29 THAT AN ALLEGATION OF VIOLATION OF EMPLOYER RULES, POLICY,
30 PROCEDURE, OR OTHER MISCONDUCT OR IMPROPER ACTIONS BY AN
31 EMPLOYEE ARE SUBJECT TO A COMPLETE AND OBJECTIVE INVESTIGATION
32 RESULTING IN FINDINGS OF FACT AND DISCIPLINARY ACTION FOR ANY
33 SUBSTANTIATED VIOLATION.
34 (j) THE P.O.S.T. BOARD MAY PROMULGATE RULES FOR THE
35 IMPLEMENTATION OF THIS SUBSECTION (2.5)."
