## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.HB18-1034 be amended as follows:

- 1 Amend printed bill, page 3, after line 2 insert:
- 2       "(5) "LOCAL DISTRICT COLLEGE" MEANS A LOCAL DISTRICT  
3 COLLEGE OPERATING PURSUANT TO ARTICLE 71 OF TITLE 23.
- 4       (6) "LOCAL EDUCATION PROVIDER" MEANS A SCHOOL DISTRICT  
5 ORGANIZED AND EXISTING AS PROVIDED IN ARTICLE 30 OF TITLE 22; A  
6 CHARTER SCHOOL AUTHORIZED BY A SCHOOL DISTRICT PURSUANT TO PART  
7 1 OF ARTICLE 30.5 OF TITLE 22; AN INSTITUTE CHARTER SCHOOL  
8 AUTHORIZED BY THE STATE CHARTER SCHOOL INSTITUTE PURSUANT TO  
9 PART 5 OF ARTICLE 30.5 OF TITLE 22; OR A BOARD OF COOPERATIVE  
10 SERVICES CREATED PURSUANT TO ARTICLE 5 OF TITLE 22 THAT OPERATES  
11 A PUBLIC SCHOOL."
- 12 Renumber succeeding subsections accordingly.
- 13 Page 3, strike lines 5 and 6.
- 14 Renumber succeeding subsection accordingly.
- 15 Page 3, line 13, strike "AND SCHOOL DISTRICTS" and substitute  
16 "COLORADO MESA UNIVERSITY, LOCAL DISTRICT COLLEGES, AND LOCAL  
17 EDUCATION PROVIDERS".
- 18 Page 3, line 19, strike "AND SCHOOL DISTRICTS," and substitute  
19 "COLORADO MESA UNIVERSITY, LOCAL DISTRICT COLLEGES, AND LOCAL  
20 EDUCATION PROVIDERS,".
- 21 Page 3, strike lines 25 through 27 and substitute "COUNCIL SHALL TAKE  
22 INTO ACCOUNT:
- 23       (a) WHETHER THE APPLICANT SERVES STUDENTS WHO RESIDE OR  
24 WHOSE PARENTS RESIDE IN RURAL AREAS OF THE STATE;
- 25       (b) WHETHER THE APPLICANT CAN DEMONSTRATE THAT IT  
26 RECEIVES FINANCIAL OR IN-KIND SUPPORT FOR ITS PROGRAMS FROM LOCAL  
27 BUSINESS AND INDUSTRY; AND
- 28       (c) THE APPLICANT'S DEMONSTRATED LEVEL OF FINANCIAL NEED  
29 AND ACCESS TO OTHER REVENUES FOR THE PURPOSES DESCRIBED IN THE  
30 APPLICATION."
- 31 Page 4, strike line 1.
