## SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.SB18-084 be amended as follows:

- 1 Amend proposed committee amendment (SB084\_L.002), page 1, line 33,  
2 strike "and".
- 3 Page 1, line 36, strike "perpetrators." and substitute "perpetrators; and  
4 (d) In an effort to be victim-centered, yet evidence-based, in  
5 prosecuting human trafficking offenses, district attorneys are encouraged  
6 to consider granting use immunity for any statements obtained from a  
7 minor victim of human trafficking during the course of investigating  
8 charges against an individual who has trafficked the minor. Granting use  
9 immunity for the statements made by the minor victim allows the victim  
10 to provide important information to law enforcement and district  
11 attorneys to assist in human trafficking investigations without fear of  
12 incriminating himself or herself. Granting use immunity would further  
13 help determine the services necessary to support the minor victim's  
14 removal from sexually exploitative activities."
- 15 Page 2, strike line 1 and substitute "(1)(a) introductory portion and  
16 (1)(a)(VIII); and add (62.5) and".
- 17 Page 2, strike lines 16 through 33.
- 18 Page 2, line 35, strike "(2)(a); and add (2.7)" and substitute "(2)(a)".
- 19 Page 3, strike lines 9 through 45.
- 20 Page 4, strike lines 1 through 19 and substitute:  
21 "SECTION 4. In Colorado Revised Statutes, add 18-3-504.5 as  
22 follows:  
23 **18-3-504.5. Granting of use immunity - affirmative defense.**  
24 DURING THE COURSE OF ANY INVESTIGATION OR HEARING OF ANY OFFENSE  
25 PURSUANT TO THIS PART 5 OR SECTION 18-7-201, 18-7-202, OR 18-7-207,  
26 A MINOR MAY BE GRANTED USE IMMUNITY BY THE DISTRICT ATTORNEY  
27 AGAINST THE USE OF ANY STATEMENTS MADE DURING SUCH  
28 INVESTIGATION OR HEARING IN A SUBSEQUENT OR PENDING CRIMINAL OR  
29 DELINQUENCY ACTION. THE GRANTING OF USE IMMUNITY PURSUANT TO  
30 THIS SECTION DOES NOT PRECLUDE A MINOR FROM RAISING AN  
31 AFFIRMATIVE DEFENSE PURSUANT TO SECTION 18-3-504 (2.5)."
- 32 Renumber succeeding sections accordingly.
- 33 Page 5, strike lines 8 through 13 and substitute "JURISDICTION."
