SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB18-026 be amended as follows:

- 1 Amend printed bill, page 6, line 21, strike "AND".
- 2 Page 6, line 22, strike "EXPIRED." and substitute "EXPIRED, AND THE  
3 PETITIONER IS NOT LIKELY TO COMMIT A SUBSEQUENT OFFENSE OF OR  
4 INVOLVING UNLAWFUL SEXUAL BEHAVIOR. IN DETERMINING WHETHER TO  
5 GRANT THE PETITION, THE COURT SHALL CONSIDER ANY TREATMENT  
6 RECORDS PROVIDED PURSUANT TO SUBSECTION (2)(b) OF THIS SECTION,  
7 ANY WRITTEN OR ORAL STATEMENT OF THE OFFENSE FOR WHICH THE  
8 PETITIONER WAS REQUIRED TO REGISTER, AND ANY OTHER RELEVANT  
9 INFORMATION PRESENTED BY THE PETITIONER OR DISTRICT ATTORNEY.".
- 10 Page 7, line 2, strike "AND".
- 11 Page 9, line 1, after the period add "IN DETERMINING WHETHER TO GRANT  
12 THE PETITION, THE COURT SHALL CONSIDER ANY TREATMENT RECORDS  
13 PROVIDED PURSUANT TO SUBSECTION (2.5)(c) OF THIS SECTION, ANY  
14 WRITTEN OR ORAL STATEMENT OF THE OFFENSE FOR WHICH THE  
15 PETITIONER WAS REQUIRED TO REGISTER, AND ANY OTHER RELEVANT  
16 INFORMATION PRESENTED BY THE PETITIONER OR DISTRICT ATTORNEY.".
- 17 Page 9, line 7, after the period add "IN DETERMINING WHETHER TO GRANT  
18 THE PETITION, THE COURT SHALL CONSIDER ANY TREATMENT RECORDS  
19 PROVIDED PURSUANT TO SUBSECTION (2.5)(c) OF THIS SECTION, ANY  
20 WRITTEN OR ORAL STATEMENT OF THE OFFENSE FOR WHICH THE  
21 PETITIONER WAS REQUIRED TO REGISTER, AND ANY OTHER RELEVANT  
22 INFORMATION PRESENTED BY THE PETITIONER OR DISTRICT ATTORNEY.".
- 23 Amend proposed committee amendment (SB26\_L.001), page 1, strike  
24 lines 26 through 29 and substitute:  
25 "Page 7, strike lines 3 through 6 and substitute "OF THIS SECTION HAS  
26 EXPIRED, AND THE PETITIONER IS NOT LIKELY TO COMMIT A SUBSEQUENT  
27 OFFENSE OF OR INVOLVING UNLAWFUL SEXUAL BEHAVIOR. IN  
28 DETERMINING WHETHER TO GRANT THE PETITION, THE COURT SHALL  
29 CONSIDER ANY TREATMENT RECORDS PROVIDED PURSUANT TO  
30 SUBSECTION (2)(b) OF THIS SECTION, ANY WRITTEN OR ORAL STATEMENT  
31 OF THE OFFENSE FOR WHICH THE PETITIONER WAS REQUIRED TO REGISTER,  
32 AND ANY OTHER RELEVANT INFORMATION PRESENTED BY THE PETITIONER  
33 OR DISTRICT ATTORNEY."."
