HB25-1295 be amended as follows:

1 Amend printed bill, page 8, before line 4 insert:

2 "SECTION 3. In Colorado Revised Statutes, 25-4-1604, **amend**
3 (2); and **add** (3) as follows:

4 **25-4-1604. Powers and duties of department - reciprocal**
5 **license - rules.** (2) (a) Subsection (1) of this section ~~shall~~ DOES not apply
6 to the city and county of Denver, which, by ordinance, may provide for
7 the licensure of retail food establishments.

8 (b) THE CITY AND COUNTY OF DENVER SHALL GRANT A DENVER
9 FOOD SAFETY LICENSE TO A LICENSEE IN ACCORDANCE WITH SECTION
10 29-11.6-103 (3).

11 (3) **Reciprocity with the city and county of Denver.** (a) THE
12 DEPARTMENT SHALL GRANT A LICENSE TO THE OWNER OR OPERATOR OF A
13 MOBILE RETAIL FOOD ESTABLISHMENT IF THE OWNER OR OPERATOR
14 SUBMITS THE FOLLOWING TO THE DEPARTMENT:

15 (I) AN ACTIVE DENVER FOOD SAFETY LICENSE ISSUED BY THE CITY
16 AND COUNTY OF DENVER; AND

17 (II) PAYMENT OF A RECIPROCAL LICENSE APPLICATION FEE AND
18 RECIPROCAL LICENSING FEE REQUIRED FOR THE LICENSE.

19 (b) (I) THE DEPARTMENT MAY CHARGE A RECIPROCAL LICENSE
20 APPLICATION FEE TO AN OWNER OR OPERATOR OF A MOBILE RETAIL FOOD
21 ESTABLISHMENT THAT APPLIES FOR A LICENSE IN ACCORDANCE WITH THIS
22 SUBSECTION (3). THE RECIPROCAL LICENSE APPLICATION FEE MUST NOT
23 EXCEED THE ADMINISTRATIVE COST INCURRED BY THE DEPARTMENT TO
24 REVIEW THE RECIPROCAL LICENSE APPLICATION.

25 (II) THE DEPARTMENT MAY CHARGE A RECIPROCAL LICENSING FEE
26 TO AN OWNER OR OPERATOR OF A MOBILE RETAIL FOOD ESTABLISHMENT
27 TO OBTAIN A LICENSE IN ACCORDANCE WITH THIS SUBSECTION (3). THE
28 RECIPROCAL LICENSING FEE MUST NOT EXCEED TWENTY-FIVE PERCENT OF
29 THE LICENSING FEE CHARGED PURSUANT TO SECTION 25-4-1607."

30 Page 8, line 4, strike "2." and substitute "4."

31 Strike "PERMITS" and substitute "PERMIT" on: **Page 4**, lines 8 and 24; and
32 **Page 6**, lines 5, 8, 13, 18, 22, and 26.

33 Strike "FOOD TRUCK" and substitute "MOBILE RETAIL FOOD
34 ESTABLISHMENT" on: **Page 3**, lines 10, 14, and 16; **Page 4**, lines 12, 19,
35 23, 25, and 27; **Page 5**, lines 14, 18, 19, and 22; **Page 6**, lines 7, 12, 17,
36 20, and 27; **Page 7**, line 1; and **Page 8**, line 3.
