HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

HB16-1078 be amended as follows:

1 Amend printed bill, page 3, line 7, strike "A" and substitute "EXCEPT AS  
2 SET FORTH IN PARAGRAPH (c) OF THIS SUBSECTION (2), A".

3 Page 4, after line 5 insert:

4 "(c) IT IS THE OBLIGATION OF AN EMPLOYEE WHO WISHES TO  
5 DISCLOSE INFORMATION UNDER THE PROTECTION OF THIS SECTION TO  
6 MAKE A GOOD FAITH EFFORT TO INFORM HIS OR HER SUPERVISOR, AN  
7 ADMINISTRATOR ABOVE THE LEVEL OF HIS OR HER SUPERVISOR, OR A  
8 BOARD MEMBER OF THE LOCAL EDUCATION PROVIDER OF THE NATURE OF  
9 THE INFORMATION TO BE DISCLOSED PRIOR TO THE TIME OF DISCLOSURE."

10 Page 5, line 22, strike "A" and substitute "EXCEPT AS SET FORTH IN  
11 PARAGRAPH (c) OF THIS SUBSECTION (2), A".

12 Page 6, after line 19 insert:

13 "(c) IT IS THE OBLIGATION OF AN EMPLOYEE WHO WISHES TO  
14 DISCLOSE INFORMATION UNDER THE PROTECTION OF THIS SECTION TO  
15 MAKE A GOOD FAITH EFFORT TO INFORM HIS OR HER SUPERVISOR, AN  
16 ADMINISTRATOR ABOVE THE LEVEL OF HIS OR HER SUPERVISOR, OR A  
17 COUNTY COMMISSIONER OF THE NATURE OF THE INFORMATION TO BE  
18 DISCLOSED PRIOR TO THE TIME OF DISCLOSURE."

19 Page 7, line 27, strike "A" and substitute "EXCEPT AS SET FORTH IN  
20 PARAGRAPH (c) OF THIS SUBSECTION (2), A".

21 Page 8, after line 24 insert:

22 "(c) IT IS THE OBLIGATION OF AN EMPLOYEE WHO WISHES TO  
23 DISCLOSE INFORMATION UNDER THE PROTECTION OF THIS SECTION TO  
24 MAKE A GOOD FAITH EFFORT TO INFORM HIS OR HER SUPERVISOR, AN  
25 ADMINISTRATOR ABOVE THE LEVEL OF HIS OR HER SUPERVISOR, OR A  
26 MEMBER OF THE MUNICIPALITY'S GOVERNING BODY TO BE DISCLOSED  
27 PRIOR TO THE TIME OF DISCLOSURE."
