HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public Health Care & Human Services.

HB18-1376 be amended as follows:

- 1 Amend printed bill, page 2, strike line 3 and substitute "(18.5), (18.6),  
2 (18.7), (22.7), and (22.8) as follows":
- 3 Page 2, after line 5 insert:  
4 "(18.5) "HOST HOME" HAS THE SAME MEANING AS SET FORTH IN  
5 SECTION 13-21-117.5 (2).  
6 (18.6) "HOST HOME PROVIDER" MEANS AN INDIVIDUAL OR  
7 INDIVIDUALS PROVIDING RESIDENTIAL SERVICES AND SUPPORTS, AS  
8 DESCRIBED IN SECTION 25.5-10-206 (1)(e), IN HIS OR HER HOME TO UP TO  
9 THREE PERSONS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES  
10 WHO ARE NOT FAMILY MEMBERS, AS DEFINED IN SUBSECTION (16) OF THIS  
11 SECTION, AND PROVIDES THOSE SERVICES AS AN INDEPENDENT  
12 CONTRACTOR OF A COMMUNITY-CENTERED BOARD OR SERVICE AGENCY."
- 13 Page 2, line 11, strike "PERSON WHO" and substitute "HOST HOME  
14 PROVIDER, FAMILY CAREGIVER, OR SERVICE AGENCY THAT".
- 15 Page 2, strike line 12 and substitute "SUPPORTS IN AN INDIVIDUAL  
16 RESIDENTIAL SERVICES AND SUPPORTS RESIDENCE TO THREE OR".
- 17 Page 2, line 18, strike "WAIVERS".
- 18 Page 2, after line 20 add:  
19 "(22.8) "INDIVIDUAL RESIDENTIAL SERVICES AND SUPPORTS  
20 RESIDENCE" MEANS A PRIVATE RESIDENCE THAT HOUSES UP TO THREE  
21 INDIVIDUALS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES  
22 AND WHOSE OWNER OR RENTER PROVIDES RESIDENTIAL SERVICES AND  
23 SUPPORTS AS DESCRIBED IN SECTION 25.5-10-206 (1)(e), AS A SERVICE  
24 AGENCY, HOST HOME PROVIDER, OR FAMILY CAREGIVER."
