HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public Health Care & Human Services.HB18-1376 be amended as follows:

- 1 Amend printed bill, page 3, line 3, strike "IN".
- 2 Page 3, strike line 4.
- 3 Page 3, line 5, strike "LOCAL AFFAIRS,".
- 4 Page 3, strike lines 11 through 19 and substitute:
 - 5 "(2) (a) PRIOR TO BEGINNING OPERATIONS, A HOST HOME
 - 6 PROVIDER SHALL NOTIFY THE STATE DEPARTMENT OF HIS OR HER INTENT
 - 7 TO PROVIDE RESIDENTIAL SERVICES AND SUPPORTS IN THE MANNER
 - 8 SPECIFIED BY THE STATE DEPARTMENT. A HOST HOME PROVIDER SHALL
 - 9 NOT BEGIN PROVIDING RESIDENTIAL SERVICES AND SUPPORTS UNTIL SUCH
 - 10 PROVIDER HAS NOTIFIED THE STATE DEPARTMENT PURSUANT TO THIS
 - 11 SUBSECTION (2).
 - 12 (b) THE HOST HOME".
- 13 Page 3, line 20, strike "RESIDENCE".
- 14 Page 3, strike lines 26 and 27 and substitute "MUST INCLUDE A
- 15 REQUIREMENT FOR COMPLIANCE WITH HOUSING QUALITY".
- 16 Page 4, line 2, strike "ALARMS;" and substitute "ALARMS.".
- 17 Page 4, strike lines 3 through 10.
- 18 Page 4, line 20, strike "WAIVER PARTICIPANTS OR".
- 19 Page 4, strike lines 21 and 22 and substitute "INDIVIDUALS WITH
- 20 INTELLECTUAL AND DEVELOPMENTAL DISABILITIES WHO RECEIVE
- 21 RESIDENTIAL SERVICES AND SUPPORTS, AS DESCRIBED IN SECTION
- 22 25.5-10-206 (1)(e), AND THEIR FAMILY MEMBERS, CASE MANAGEMENT
- 23 AGENCIES, COMMUNITY-CENTERED BOARDS, AND SERVICE AGENCIES. THE
- 24 RULES MUST INCLUDE:".
- 25 Page 4, line 23, strike "LIFE, AND FIRE" and substitute "WELFARE, AND".
- 26 Page 4, line 25 and 26, strike "RESIDENCE, INCLUDING IN THE EVENT THE
- 27 RESIDENCE CLOSES." and substitute "RESIDENCE.".
- 28 Page 4, line 27, strike "AN INDIVIDUAL RESIDENTIAL".

1 Page 5, strike lines 1 through 21 and substitute "A HOST HOME HOUSES A
2 PERSON WHO NEEDS ASSISTANCE TO SELF-EVACUATE IN THE CASE OF AN
3 EMERGENCY, AS DEFINED IN SUBSECTION (3)(c) OF THIS SECTION, THE
4 HOST HOME PROVIDER SHALL NOTIFY THE LOCAL FIRE JURISDICTION OF THE
5 ADDRESS AND LOCATION OF ANY ROOM WHERE SUCH A PERSON SLEEPS;

6 (B) A REQUIREMENT THAT THE DIVISION OF HOUSING OF THE
7 DEPARTMENT OF LOCAL AFFAIRS CONDUCT AN ON-SITE SURVEY OF HOST
8 HOMES TO ENSURE COMPLIANCE WITH THE MINIMUM HOUSING QUALITY
9 STANDARDS EVERY TWO YEARS;

10 (C) A REQUIREMENT THAT HOST HOMES THAT BEGIN OPERATIONS
11 AFTER THE EFFECTIVE DATE OF RULES PROMULGATED PURSUANT TO THIS
12 SUBSECTION (3)(b) HAVE SIXTY DAYS ~~OR LESS~~ FROM THE DATE AN
13 INDIVIDUAL WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES
14 MOVES INTO THE HOST HOME TO REQUEST AN ON-SITE SURVEY REQUIRED
15 BY THIS SUBSECTION (3)(b)(I)(C);

16 (D) A REQUIREMENT THAT HOST HOMES THAT ARE IN OPERATION
17 ON THE EFFECTIVE DATE OF RULES PROMULGATED PURSUANT TO THIS
18 SUBSECTION (3)(b) HAVE ONE YEAR ~~OR LESS~~ FROM SUCH EFFECTIVE DATE
19 TO REQUEST AN ON-SITE SURVEY REQUIRED BY SUBSECTION (3)(b)(I)(C)
20 OF THIS SECTION;

21 (E) A REQUIREMENT THAT THE DIVISION OF HOUSING OF THE
22 DEPARTMENT OF LOCAL AFFAIRS HAS SIXTY DAYS OR LESS FROM THE DATE
23 OF REQUEST TO CONDUCT AN ON-SITE SURVEY REQUIRED BY SUBSECTION
24 (3)(b)(I)(C) OF THIS SECTION;

25 (F) A REQUIREMENT THAT A HOST HOME MAY CONTINUE TO
26 OPERATE WHILE AWAITING THE COMPLETION OF THE ON-SITE SURVEY
27 REQUIRED BY SUBSECTION (3)(b)(I)(C) OF THIS SECTION;

28 (H)(G) A PROVISION THAT A HOST HOME IS NOT REQUIRED TO
29 COMPLETE AN ON-SITE SURVEY REQUIRED BY SUBSECTION (3)(b)(I)(C) OF
30 THIS SECTION MORE FREQUENTLY THAN EVERY TWO YEARS, REGARDLESS
31 OF WHO RESIDES IN THE HOST HOME.

"(G) A requirement dispute; and"

32 (II) THE STATE DEPARTMENT SHALL DETERMINE, BY RULE, OTHER
33 STANDARDS FOR INDIVIDUAL RESIDENTIAL SERVICES AND SUPPORTS
34 PROVIDERS AND RESIDENCES. INSPECTIONS MADE PURSUANT TO THIS
35 SUBSECTION (3)(b)(II) MUST INCLUDE CERTIFICATION OF COMPLIANCE
36 WITH FUNCTIONING SMOKE DETECTORS AND UNBLOCKED EGRESS FOR
37 INDIVIDUALS WITH DISABILITIES."

38 Renumber succeeding subparagraphs accordingly.

39 Page 6, line 4, strike "EVACUATE" and substitute "SELF-EVACUATE" and
40 strike "WHO" and substitute "WHO, DUE TO HIS OR HER DISABILITY AND
41 BASED ON AN INDIVIDUAL ASSESSMENT,".

42 Page 6, lines 5 and 6, strike "SELF-EVACUATE, INCLUDING AN INDIVIDUAL

- 1 WHO:" and substitute "SELF-EVACUATE THE RESIDENCE WITHOUT
- 2 ASSISTANCE FROM ANOTHER PERSON."
- 3 Page 6, strike lines 7 through 10.
