SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB19-1279 be amended as follows:

- 1 Amend reengrossed bill, page 4, line 1, strike "DISCHARGE," and  
2 substitute "DISCHARGE".
- 3 Page 4, line 2, strike "PURPOSES," and substitute "PURPOSES OR FOR  
4 TESTING FIREFIGHTING FOAM FIRE SYSTEMS".
- 5 Page 4, line 4, after the period add "AS USED IN THIS SUBSECTION (1),  
6 "FIREFIGHTING FOAM FIRE SYSTEMS" MEANS A SYSTEM DESIGNED TO  
7 PROVIDE PROTECTION FROM FIRE, OR FOR THE SUPPRESSION OF FIRE,  
8 THROUGH THE USE OF FIREFIGHTING FOAM."
- 9 Page 6, line 16, after "REQUIRED BY" insert "OR AUTHORIZED BY".
- 10 Page 6, line 17, after "LAW" insert "INCLUDING BUT NOT LIMITED TO 14  
11 C.F.R. PART 139, OR IMPLEMENTED IN ACCORDANCE WITH FEDERAL  
12 AVIATION ADMINISTRATION GUIDANCE,".
- 13 Page 6, line 18, strike "GASOLINE OR SPECIAL FUEL" and substitute  
14 "GASOLINE, SPECIAL FUEL, OR JET FUEL".
- 15 Page 6, line 20, strike "GASOLINE OR SPECIAL FUEL" and substitute  
16 "GASOLINE, SPECIAL FUEL, OR JET FUEL".
- 17 Page 6, line 21, strike "AND".
- 18 Page 6, line 22, strike "PLANT." and substitute "PLANT; AND".
- 19 Page 6, after line 22 insert:
- 20 "(d) FOR USE AT THE EISENHOWER-JOHNSON TUNNELS, IF DEEMED  
21 NECESSARY BY THE DEPARTMENT OF TRANSPORTATION. IF THE  
22 DEPARTMENT OF TRANSPORTATION DEEMS THE USE OF SUCH CLASS B  
23 FIREFIGHTING FOAM NECESSARY, THE DEPARTMENT OF TRANSPORTATION  
24 MUST ALSO MAKE A PLAN TO CONTAIN AND SAFELY DISPOSE OF SUCH  
25 CLASS B FIREFIGHTING FOAM AND ANY WATER USED IN THE CLEANUP OF  
26 SUCH CLASS B FIREFIGHTING FOAM."
