## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.HB16-1106 be amended as follows:

- 1 Amend printed bill, page 2, line 10, strike "IF ANY OF".
- 2 Page 2, strike lines 11 through 16 and substitute "THE BOARD SHALL NOT  
3 DESIGNATE A PIONEER TRAIL ACROSS PUBLIC LANDS ON A ROAD  
4 ADMINISTERED BY THE FEDERAL GOVERNMENT UNLESS THE ROAD IS  
5 DESIGNATED AS OPEN TO TRAVEL BY THE APPROPRIATE FEDERAL LAND  
6 MANAGEMENT AGENCY. EXCEPT AS SET FORTH IN SUBSECTION (2) OF THIS  
7 SECTION, THE DESIGNATION OF THE PIONEER TRAIL IS EFFECTIVE UPON THE  
8 DATE OF THE RESOLUTION.
- 9 (2) IF A COUNTY DESIGNATES ANY PORTION OF A STATE HIGHWAY  
10 AS A PIONEER TRAIL, THE DESIGNATION IS NOT EFFECTIVE UNLESS THE  
11 GENERAL ASSEMBLY, ACTING BY JOINT RESOLUTION, ALSO DESIGNATES  
12 THE PORTION OF THE STATE HIGHWAY AS PART OF THE PIONEER TRAIL.
- 13 (3) IF ANY OF THE DESIGNATED ROADS ARE PART OF THE STATE  
14 HIGHWAY SYSTEM, THE BOARD OF COUNTY COMMISSIONERS SHALL SEND  
15 A COPY OF THE RESOLUTION TO THE DEPARTMENT OF TRANSPORTATION.  
16 IF ANY OF THE DESIGNATED ROADS ARE ON PUBLIC LANDS ADMINISTERED  
17 BY THE FEDERAL GOVERNMENT, THE BOARD SHALL SEND A COPY OF THE  
18 RESOLUTION TO THE APPROPRIATE FEDERAL LAND MANAGEMENT AGENCY.
- 19 (4) A COUNTY MAY POST, OR ALLOW TO BE POSTED, IDENTIFYING  
20 AND INFORMATIVE SIGNS RELATED TO THE PIONEER TRAIL ALONG COUNTY  
21 ROADS.
- 22 (5) THE AUTHORITY TO DESIGNATE A PIONEER TRAIL IS INTENDED  
23 TO HIGHLIGHT COLORADO'S CULTURAL AND HISTORICAL HERITAGE AND TO  
24 PROMOTE HISTORICAL TOURISM AND EDUCATION. NOTHING IN THIS  
25 SECTION AFFECTS EXISTING RIGHTS-OF-WAY OR OWNERSHIP OF PUBLIC  
26 ROADS."
