SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation.HB17-1242 be amended as follows:

1 Amend reengrossed bill, page 13, after line 15 insert:

2 "SECTION 12. In Colorado Revised Statutes, 43-1-123, add
3 (2.5) as follows:

4 **43-1-123. Project closure and project reporting requirements.**
5 (2.5) NOTWITHSTANDING ANY OTHER PROVISION OF STATE LAW AND IN
6 ADDITION TO THE INFORMATION REQUIRED TO BE REPORTED PURSUANT TO
7 SUBSECTION (2) OF THIS SECTION, FOR ANY TRANSPORTATION PROJECT FOR
8 WHICH THE DEPARTMENT AWARDS A CONTRACT BASED ON BEST VALUE
9 SELECTION ON OR AFTER JULY 1, 2018, THE DEPARTMENT, IN ORDER TO
10 PROVIDE INFORMATION TO THE PUBLIC AND IMPROVE THE TRANSPARENCY
11 OF ITS PROPOSAL SOLICITATION AND CONTRACT AWARD PROCESS FOR
12 TRANSPORTATION PROJECTS, SHALL:

13 (a) REPORT ON ITS PUBLIC WEBSITE WITHIN THIRTY DAYS OF THE
14 CONTRACT AWARD AND MAINTAIN ON ITS WEBSITE FOR AT LEAST ONE
15 YEAR THEREAFTER AN EXECUTIVE SUMMARY OF ALL PROPOSALS
16 SUBMITTED IN RESPONSE TO ITS SOLICITATION OF PROPOSALS FOR THE
17 PROJECT;

18 (b) MAKE AVAILABLE FOR REVIEW AND REPRODUCTION AT THE
19 DEPARTMENT'S HEADQUARTERS FOR A PERIOD OF AT LEAST ONE YEAR
20 FOLLOWING THE DATE OF THE CONTRACT AWARD THE DEPARTMENT'S
21 SCORING OF ALL PROPOSALS SUBMITTED IN RESPONSE TO ITS SOLICITATION
22 OF PROPOSALS FOR THE PROJECT; AND

23 (c) MAKE AVAILABLE FOR REVIEW ONLY AT THE DEPARTMENT'S
24 HEADQUARTERS FOR A PERIOD OF AT LEAST ONE YEAR FOLLOWING THE
25 DATE OF THE CONTRACT AWARD THE STATEMENT OF QUALIFICATIONS AND
26 PROPOSALS FOR EACH PERSON THAT SUBMITTED A PROPOSAL IN RESPONSE
27 TO THE DEPARTMENT'S SOLICITATION OF PROPOSALS FOR THE PROJECT;
28 EXCEPT THAT THE DEPARTMENT SHALL NOT MAKE ANY SPECIFIC
29 CORPORATE FINANCIAL INFORMATION SUBMITTED AVAILABLE FOR
30 REVIEW."
