## SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on JudiciarySB16-013 be amended as follows:

- 1 Amend printed bill, page 2, strike lines 3 and 4 and substitute "(3); and  
2 **add** (1) (a.5) as follows:".
- 3 Page 3, strike lines 9 through 27.
- 4 Page 4, strike lines 1 through 19.
- 5 Page 4, line 20, strike "ADVISORY".
- 6 Page 4, line 27, strike "ADVISORY".
- 7 Page 5, line 3, strike "ADVISORY".
- 8 Page 5, after line 9 insert:  
9 "(III) EVALUATING THE OMBUDSMAN'S PERFORMANCE AS  
10 DETERMINED NECESSARY BASED ON FEEDBACK RECEIVED RELATED TO THE  
11 OMBUDSMAN; AND  
12 (IV) DEVELOPING A PUBLIC COMPLAINT PROCESS RELATED TO THE  
13 OMBUDSMAN'S PERFORMANCE;".
- 14 Page 5, line 13, strike "law;" and substitute "law TO OVERSEE AND ADVISE  
15 THE OMBUDSMAN ON THE STRATEGIC DIRECTION OF THE OFFICE AND ITS  
16 MISSION AND TO HELP PROMOTE THE USE, ENGAGEMENT, AND ACCESS TO  
17 THE OFFICE;".
- 18 Page 5, strike lines 14 through 18 and substitute:  
19 "(c) To work cooperatively with the ombudsman to provide fiscal  
20 oversight of the general operating budget of the office to ~~assist with~~  
21 ~~training, as needed, and provide any other assistance to~~ AND ensure that  
22 the office and ombudsman operate OPERATES in compliance with the  
23 provisions of this article, THE MEMORANDUM OF UNDERSTANDING, and  
24 with state and federal laws relating to the child welfare system;".
- 25 Page 6, strike lines 22 through 25.
- 26 Reletter succeeding paragraphs accordingly.
- 27 Page 7, strike lines 3 through 9.

1 Page 7, line 11, strike "(4)"; and substitute "(1)(c)";

2 Page 7, after line 20 insert:

3 "(c) To report, at least annually, pursuant to AS REQUIRED BY THE  
4 PROVISIONS OF section 19-3.3-108, concerning the actions taken by the  
5 ombudsman with respect OF THE OMBUDSMAN RELATED to the goals and  
6 duties of the office;"

7 Page 8, strike lines 5 through 10 and substitute:

8 "SECTION 3. In Colorado Revised Statutes, 19-3.3-108, amend  
9 (2); and add (4) as follows:

10 **19-3.3-108. Office of the child protection ombudsman - annual**  
11 **report.** (2) ~~The ombudsman shall transmit the annual report to the~~  
12 ~~executive director for review and comment~~ The ombudsman shall  
13 distribute the written report to the governor, the chief justice, THE BOARD,  
14 and the general assembly. The ombudsman shall present the report to the  
15 health and human services committees of the house of representatives and  
16 of the senate, or any successor committees.

17 (4) THE OMBUDSMAN SHALL PRESENT OR COMMUNICATE  
18 QUARTERLY UPDATES TO THE BOARD ON THE ACTIVITIES OF THE OFFICE."

19 Renumber succeeding sections accordingly.
