Committee on Finance.HB17-1250 be amended as follows:

- 1 Amend printed bill, page 2, line 5, strike "WILDLIFE CONSERVATION
- 2 AND" and substitute "NONGAME CONSERVATION AND
- 3 WILDLIFE".
- 4 Page 3, line 12, strike "OFTEN".
- 5 Page 5, line 17, strike "17-\_\_\_\_," and substitute "17-1250,".
- 6 Page 6, line 6, strike "WILDLIFE CONSERVATION AND" and substitute
- 7 "NONGAME CONSERVATION AND WILDLIFE".
- 8 Page 6, line 10, after "39-22-703," insert "ANY MONEYS CREDITED
- 9 PURSUANT TO SECTION 33-6-105 (1)(a),".
- 10 Page 7, lines 20 and 21, strike "WILDLIFE CONSERVATION AND" and
- 11 substitute "NONGAME CONSERVATION AND WILDLIFE".
- 12 Page 8, line 3, after "PRIVATE-SECTOR" insert "COLORADO".
- 13 Page 8, strike lines 10 through 13 and substitute:
  - 14 "(E) ONE MEMBER OF A RECOGNIZED WILDLIFE CONSERVATION
  - 15 ORGANIZATION WITH LOCAL AND NATIONAL AFFILIATES WHOSE MISSION
  - 16 FOCUSES ON CONSERVATION AND RESTORATION OF NATURAL ECOSYSTEMS
  - 17 AND ON HABITAT PROTECTION FOR BIODIVERSITY, AND WHOSE
  - 18 MEMBERSHIP ENJOYS SIGNIFICANTLY NONCONSUMPTIVE USES OF WILDLIFE;
  - 19 AND".
- 20 Page 8, line 14, after "IN" insert "NONCONSUMPTIVE USES OF".
- 21 Page 9, line 11, strike "NINE" and substitute "SIX".
- 22 Page 10, line 5, strike "BOARD" and substitute "DIVISION" and strike
- 23 "FUND" and substitute "FUND, PURSUANT TO RECOMMENDATIONS MADE BY
- 24 THE BOARD,".
- 25 Page 10, lines 6 and 7, strike "FOR THE PURPOSE OF FACILITATING" and
- 26 substitute "IN ORDER TO FACILITATE".



- 1 Page 10, line 15, after "WILDLIFE," insert "OPERATIONAL OR CAPITAL  
2 EXPENSES,".
- 3 Page 10, lines 18 and 19, strike "DIVISION OR BY THE UNITED STATES FISH  
4 AND WILDLIFE SERVICE." and substitute "DIVISION.".
- 5 Page 11, line 3, strike "FIVE" and substitute "ONE" and strike "DOLLARS  
6 AND" and substitute "DOLLARS;".
- 7 Page 11, strike line 4.
- 8 Page 11, line 5, strike "DOLLARS TO EACH GRANTEE;".
- 9 Page 11, line 6, strike "TEN" and substitute "FIVE".
- 10 Page 11, line 12, strike "TO REHABILITATE" and substitute "FOR THE  
11 REHABILITATION OF".
- 12 Page 11, line 13, strike "SPECIES." and substitute "WILDLIFE SPECIES;  
13 EXCEPT THAT GRANT MONEYS SHALL NOT BE USED TO REHABILITATE  
14 EXOTIC WILDLIFE.".
- 15 Page 11, line 15, strike "BOARD" and substitute "DIVISION".
- 16 Page 11, strike lines 18 and 19 and substitute "BE PERFORMED OR  
17 MANAGED BY THE GRANTEE.".
- 18 Page 11, line 20, strike "SEMIANNUAL" and substitute "ANNUAL".
- 19 Page 11, line 23, before "REPORTS" insert "GRANT RECIPIENTS AND  
20 AMOUNTS AND THE ANNUAL".
- 21 Page 11, after line 24 insert:
- 22 "(5) THE BOARD IS SUBJECT TO THE "COLORADO OPEN RECORDS  
23 ACT", PART 2 OF ARTICLE 72 OF TITLE 24, AND TO THE OPEN MEETINGS  
24 PROVISIONS OF THE "COLORADO SUNSHINE ACT OF 1972" CONTAINED IN  
25 PART 4 OF ARTICLE 6 OF TITLE 24. FOR PURPOSES OF THE "COLORADO  
26 OPEN RECORDS ACT", PART 2 OF ARTICLE 72 OF TITLE 24, THE RECORDS  
27 OF THE BOARD AND THE AUTHORITY ARE PUBLIC RECORDS.

1           **SECTION 3.** In Colorado Revised Statutes, 33-1-112, **amend** (6)  
2 as follows:

3           **33-1-112. Funds - cost accounting - definition - repeal.** (6) The  
4 cost of nongame programs established under articles 1 to 6 of this title  
5 TITLE 33 shall be borne by the general fund, the ~~nongame and endangered~~  
6 ~~wildlife~~ COLORADO NONGAME CONSERVATION AND WILDLIFE  
7 RESTORATION cash fund, the wildlife cash fund, and any other sources  
8 deemed appropriate by the general assembly.

9           **SECTION 4.** In Colorado Revised Statutes, 33-6-105, **amend**  
10 (1)(a) as follows:

11           **33-6-105. Disposition of fines and surcharges.** (1) (a) Except  
12 as otherwise provided in ~~paragraph (b) of this subsection (1)~~ SUBSECTION  
13 (1)(b) OF THIS SECTION, all moneys collected for fines under articles 1 to  
14 6 of this title TITLE 33, either by payment of a penalty assessment or  
15 assessed by a court upon conviction and resulting from issuance of a  
16 citation by a wildlife officer of the division of parks and wildlife, shall be  
17 transmitted to the state treasurer, who shall credit one-half to the general  
18 fund and one-half to the wildlife cash fund or, for offenses involving  
19 nongame wildlife, to the ~~nongame and endangered wildlife~~ COLORADO  
20 NONGAME CONSERVATION AND WILDLIFE RESTORATION cash fund."

21 Renumber succeeding section accordingly.

22 Strike "COLORADO wildlife CONSERVATION AND RESTORATION" and  
23 substitute "~~wildlife~~ COLORADO NONGAME CONSERVATION AND WILDLIFE  
24 RESTORATION" on: **Page 4**, lines 2 and 3, line 11, and lines 22 and 23; and  
25 **Page 5**, lines 23 and 24.

26 Strike "**wildlife conservation and**" and substitute "**nongame**  
27 **conservation and wildlife**" on: **Page 4**, lines 5 and 6; and **Page 6**, line 2.

28 Page 1, line 104, strike "**WILDLIFE CONSERVATION AND**" and substitute  
29 "**NONGAME CONSERVATION AND WILDLIFE**".
