HB16-1301 be amended as follows:

- 2 substitute "residencies, pre-apprenticeships, and".
- 3 Page 2, strike lines 19 and 20.
- 4 Reletter succeeding paragraphs accordingly.
- 5 Page 3, strike line 8.
- 6 Page 3, line 11, strike "LABOR." and substitute "LABOR; AND".
- 7 Page 3, before line 12 insert:
- 8 "(III) MEETS THE "QUALITY PRE-APPRENTICESHIP PROGRAM"
- 9 STANDARDS MAINTAINED BY THE EMPLOYMENT AND TRAINING
- 10 ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF LABOR."

- 13 Page 4, after line 6 insert:
- 14 "(g) "RESIDENCY PROGRAM" MEANS A PROGRAM DEFINED BY THE
- 15 WORK FORCE DEVELOPMENT COUNCIL OR THE DEPARTMENT OF LABOR AND
- 16 EMPLOYMENT THAT:
- 17 (I) PROVIDES INDIVIDUALS WITH A SET OF WELL-DEFINED
- 18 OCCUPATIONAL SKILLS AND ABILITIES BY TEACHING BOTH THEORETICAL
- 19 AND PRACTICAL CONCEPTS PRIMARILY THROUGH ON-THE-JOB TRAINING
- 20 AND RELATED INSTRUCTION; AND
- 21 (II) ENSURES THE INDIVIDUAL RECEIVES A FORM OF
- 22 COMPENSATION FOR SUCH ON-THE-JOB TRAINING."
- 23 Reletter succeeding paragraphs accordingly.
- 24 Page 4, line 27, strike "PRE-APPRENTICESHIP" and substitute "RESIDENCY".
- 25 Page 5, line 4, strike "PRE-APPRENTICESHIP" and substitute "RESIDENCY".
- 26 Page 5, line 6, strike "PRE-APPRENTICESHIPS" and substitute
- 27 "RESIDENCIES".

 10 INDUSTRY PRE-APPRENTICESHIP PROGRAM OR IN A CONSTRUCTION
 11 INDUSTRY APPRENTICESHIP PROGRAM, AND THE ACTUAL OR ANTICIPATED
 12 START DATE OF THE SELECTED RESIDENT, APPRENTICE, OR INDIVIDUAL IN
 13 A CONSTRUCTION INDUSTRY PRE-APPRENTICESHIP PROGRAM OR IN A
 14 CONSTRUCTION INDUSTRY APPRENTICESHIP PROGRAM."
- 15 Page 7, lines 24 and 25, strike "PRE-APPRENTICE OR APPRENTICE" and
 16 substitute "RESIDENT, APPRENTICE, OR INDIVIDUAL IN A CONSTRUCTION
 17 INDUSTRY PRE-APPRENTICESHIP PROGRAM OR IN A CONSTRUCTION
 18 INDUSTRY APPRENTICESHIP PROGRAM".
- 19 Page 7, lines 25 and 26, strike "RETAINED FOR THE CREDIT PERIOD," and
 20 substitute "RETAINED,".
- 21 Page 8, line 15, strike "PRE-APPRENTICE" and substitute "RESIDENT OR
 22 INDIVIDUAL IN A CONSTRUCTION INDUSTRY PRE-APPRENTICESHIP
 23 PROGRAM".
- 24 Page 8, line 17, strike "APPRENTICE." and substitute "APPRENTICE OR
 25 INDIVIDUAL IN A CONSTRUCTION INDUSTRY APPRENTICESHIP PROGRAM."
- 26 Page 8, strike lines 21 and 22 and substitute "THE NUMBER OF RESIDENTS,
 27 APPRENTICES, OR INDIVIDUALS IN A CONSTRUCTION INDUSTRY
 28 PRE-APPRENTICESHIP PROGRAM OR IN A CONSTRUCTION INDUSTRY
 29 APPRENTICESHIP PROGRAM THAT EACH QUALIFIED TAXPAYER RETAINS."
