Committee on Judiciary.HB17-1204 be amended as follows:

- 1 Amend printed bill, page 14, line 9, strike "OFFENSE OR" and substitute
- 2 "OFFENSE, DRUG PETTY OFFENSE,".

- 3 Page 14, line 10, strike "MISDEMEANOR OFFENSE" and substitute
- 4 "MISDEMEANOR OFFENSE, OR A LEVEL 1 OR LEVEL 2 DRUG MISDEMEANOR".

- 5 Page 14, line 12, after "(9)," insert "OR".

- 6 Page 14, line 13, strike "OR IS NOT A LEVEL 2 DRUG MISDEMEANOR,".

- 7 Page 14, line 19, after "OFFENSE;" insert "A SENTENCE FOR A DRUG PETTY
- 8 OFFENSE; A SENTENCE FOR A DRUG MISDEMEANOR OFFENSE;".

- 9 Page 14, line 22, after "(9)," insert "OR".

- 10 Page 14, line 23, strike "OR IS NOT A LEVEL 2 DRUG MISDEMEANOR,".

- 11 Page 15, line 11, strike "LEVEL 1 OR LEVEL 2 DRUG MISDEMEANOR,".

- 12 Page 15, line 19, after "OFFENSE" insert "OR FELONY DRUG OFFENSE".

- 13 Page 15, line 23, after the semicolon add "AND".

- 14 Page 15, lines 24 and 25, strike "FELONY OR A LEVEL 1 DRUG FELONY;
- 15 AND" and substitute "FELONY; AND".

- 16 Page 18, lines 5 and 6, strike "LEVEL 1 OR LEVEL 2 DRUG MISDEMEANOR,".
- 17 and substitute "ANY DRUG FELONY OFFENSE,".

- 18 Page 18, line 10, strike "FELONY OR" and substitute "FELONY.".

- 19 Page 18, line 11, strike "LEVEL 1 DRUG FELONY.".

- 20 Page 25, line 1, strike "OFFENSE" and substitute "OFFENSE,".

- 21 Page 25, line 2, strike the first "OR" and substitute "ANY DRUG PETTY
- 22 OFFENSE, ANY LEVEL 1 OR LEVEL 2 DRUG MISDEMEANOR, OR".



- 1 Page 25, line 4, strike "SECTION 18-6-800.3 OR A LEVEL 2" and substitute
- 2 "SECTION 18-6-800.3."

- 3 Page 25, strike line 5.
