1 Amend printed bill, page 33, after line 25 insert:

2 "SECTION 17. In Colorado Revised Statutes, 25-20.5-1101,
3 amend (3)(a); and add (4.5) as follows:

4 **25-20.5-1101. Harm reduction grant program - creation -**
5 **application - permissible uses - department duties - definitions.**

6 (3) On or before November 1, 2019, the department shall develop:

7 (a) Eligibility criteria for the entities described in ~~subsection (2)~~
8 SUBSECTIONS (2) AND (4.5) of this section;

9 (4.5) (a) A SUBSTANCE USE DISORDER TREATMENT PROGRAM MAY
10 APPLY FOR A GRANT TO IMPLEMENT A CONTINGENCY MANAGEMENT
11 PROGRAM FOR INDIVIDUALS WITH A STIMULANT USE DISORDER.
12 NOTWITHSTANDING SUBSECTION (4) OF THIS SECTION, GRANT MONEY
13 RECEIVED PURSUANT TO THIS SUBSECTION (4.5) MAY BE USED FOR
14 STAFFING, TRAINING, SUPPLIES, ADMINISTRATIVE COSTS, THE COSTS OF
15 VOUCHERS AND PRIZES UP TO FIVE HUNDRED NINETY-NINE DOLLARS PER
16 CLIENT DURING THE TREATMENT PERIOD, AND OTHER RELATED EXPENSES
17 AS APPROVED BY THE DEPARTMENT.

18 (b) AS USED IN THIS SUBSECTION (4.5), UNLESS THE CONTEXT
19 OTHERWISE REQUIRES:

20 (I) "CONTINGENCY MANAGEMENT PROGRAM" MEANS AN
21 EVIDENCE-BASED TREATMENT PROGRAM THAT PROVIDES MOTIVATIONAL
22 INCENTIVES TO TREAT INDIVIDUALS WITH A STIMULANT USE DISORDER.

23 (II) "STIMULANT USE DISORDER" MEANS A SUBSTANCE USE
24 DISORDER, AS DEFINED IN SECTION 27-80-203, INVOLVING A CLASS OF
25 DRUGS THAT INCLUDES COCAINE, METHAMPHETAMINE, OR PRESCRIPTION
26 STIMULANTS.

27 (III) "SUBSTANCE USE DISORDER TREATMENT PROGRAM" HAS THE
28 SAME MEANING AS SET FORTH IN SECTION 27-80-203."
